The following is how one woman in this country was murdered. She was in her Adamsville, Alabama home preparing for bed or just to relax after a day of work. Police were call to make a security check when she did not show up for work March 1, 2011. Her body was found inside her home. Her ex-husband, Willie H. Forrest Jr., 59, cut her throat. He called another ex-wife a date later and told her of the murder and said he was not sorry he killed Shellane Forrest. He was charged with capital murder. He told a cellmate he was going to get even with his wife for having him arrested for burglarizing her home and getting a protection order against him. Apparently cutting her throat was his way of getting even. The jury took less than two hours to convict Mr. Willie Forrest. Within an hour the same jury recommended that he be put to death. He told his first ex-wife how Ms. Forrest look as she clutched her throat. He wanted the joy of telling someone what he did. This is what happens to some women when they seek the protection of the law. His cellmate did not think to tell the jailers of Mr. Forrest threat against his wife.

Twenty years ago today, the Violence Against Women Act was signed into law. It remains my proudest legislative achievement -- but it didn't happen because of me.

It happened because, at a time when kicking a woman in the stomach or pushing her down the stairs was not taken seriously as a crime -- and at a time when domestic violence against women was considered a "family affair" -- something remarkable happened.

Incredibly brave and courageous women began speaking up.

Women like Marla, a model whose face was slashed by two men because she'd refused her landlord's entrees, and who was questioned for 20 minutes during the trial about why she was wearing a miniskirt. As if she had asked for or welcomed this repugnant act of violence. Marla spoke out.

Women like Christine, who was raped in a dorm room by a friend's boyfriend. Christine said she hadn't even known she'd been raped, because she'd known the man. But Christine added her voice.

There were so many more. Women who had their arms broken with hammers and heads beaten with pipes, who were among the 21,000 women who were assaulted, raped, and murdered in a single week in America at the time.

All of these women are victims. But they're also survivors.

And because they spoke up, the conversation changed and a national consensus formed to do something to protect them. Their stories -- experiences shared by millions more women -- put this issue front and center before the American people. The country was forced to see the rawest form of violence and acknowledge the culture that hid it. And they began to demand change as a result. Local coalitions of shelters and rape centers led the way. National women's groups and civil rights organizations got on board. And a bipartisan group in Congress got the bill to President Clinton's desk.

That's how we got this law enacted.

And with each reauthorization, we added more protections. In 2000, we included a definition of dating violence. In 2005, we invested in health providers to screen patients for domestic violence and associated long-term psychological and physical health. And in 2013, we made VAWA services available to LGBT Americans and restored authority for tribes to prosecute non-Indian offenders. As a result, over the years,

we've seen domestic violence rates drop significantly, fundamental reforms of state laws, and higher rates of convictions for special-victims units.

But we know our work here is never done. This past week, I announced that we'll bring together legal experts, scholars, and advocates to convene a White House Summit on Civil Rights and Equal Protection for Women because we know bias against victims of rape and sexual assault still exist in our criminal justice system -- and we must make clear every victim has a basic civil right to equal protection under the law.

And if you need information and resources about how to respond and prevent sexual assault in our schools and on our college campuses, you can visit NotAlone.gov.

And if, God forbid, you're experiencing this sort of violence or know someone who is, you can get help. You can do it right now. There is a network of passionate and dedicated folks all across the country who are ready to listen. It's anonymous, and it's safe. In fact, VAWA created the National Domestic Violence Hotline, **which you can visit here**,* or dial 1-800-799-SAFE (7233) right now for help and advice.

Twenty years after the Violence Against Women Act was enacted, I remain hopeful as ever that the decency of the American people will keep us moving forward.

They understand that the true character of our country is measured when violence against women is no longer accepted as society's secret, and where we all understand that even one case is too many.

We request that you do not read this book if you have been a victim of violence or have a male or female relative or child that has been a victim of violence. There is no way to escape the pain this book will produce. This information was difficult to research, to retrieve and extremely difficult to discuss in writing. The information is overwhelming and it is not possible to read this book without enduring excruciating pain. Pain is not our objective nor is sensationalism. Our objective is to bring about a permanent change in the status of the American woman and the women of the world. To meet this objective, we provide penetrating information. All too often, information regarding the death of an American female is taken as an isolated event, thereby making her death digestible and easy for the women of this country to accept. Although the murders are important, over time, the murders become inconsequential because many women think the murders have nothing to do with one's everyday life. Therefore, the full impact of the number of women murdered in this county is not appreciated. Collectively, the murder of over 200,000 American women is important when one can sit and read the cases of 20,000 women from this group. The information in this book is not being offered to sensationalize or exploit the death of these women. The information is being provided to bring recognition to their existence and their untimely deaths. We believe the women who paid the ultimate price for freedom should be immortalized. These women should never be forgotten.

This book was written in deference to the millions of women in the world who have lost their lives merely because they were women. Think of the girls in India who are raped so males can remain in control. If you have read the news out of Nigeria, you will understand males are fighting all over the world to remain in control. More than 300 school girls were taken from their families merely because they were females trying to learn to read. No one knows if these children will ever be returned home again. Women must wake to the fight for sovereignty.

Extreme care was taken in discussing the deaths of more than 20,000 American women. It was our wish to grant the victims as much dignity as humanly possible yet alert the women of this country of the horrors of their deaths. But how much dignity does a victim have when it is known she was stabbed more than 153 times? Again, we feel that you should not read this book if you have been a victim of violence or have a male or female relative or child who has been a victim of violence. If you chose to proceed we ask you to be brave, strength will come. There is much to learn. You will not put this book down without gaining knowledge. The Career Rapist especially will be hard reading, but as women we must stand together and face the monsters in life so we can live better lives and secure a future for our children. Although *Do This in Remembrance of Me* discusses the murder of 20,000 American women, the books are about life not death.

As you read the following information, please remain cognizant that you are reading case histories of crimes committed all over the United States. No one state has the same definition or punishment for any degree of murder, manslaughter or rape. The proof and qualification for an

insanity defense is different in most states, as are the requirements for the death penalty. The definitions of mitigating and aggravating circumstances are defined differently by state, as is the right of a judge to override the jury during sentencing in death penalty cases. Also, the requirement for probation is different per state, as is the punishment for juveniles and individuals who are mentally handicapped and commit capital offenses. When you read Volume Three: *The Career Rapist* and Volume Four: *The Recidivist*, you will then appreciate this difference.

You must also remember American law is not static. Our laws have been made to yield to technology that has allowed for the release of men from prison. With respect to all the data in the four volumes of *Do This in Remembrance of Me*, the persons listed as murderers or rapists or in the category "Murderer Status: " were individuals who at the time were apprehended, arrested, charged, tried, convicted, or suspected or alleged by the police in the murder of the women mentioned. During the course of time, some of these individuals may have been exonerated and the information was not available or recorded in the source documents used during the development of the books *Do This in Remembrance of Me*. We took extreme care to list as many convictions and as many exonerations and overturned judgments that we could find in the source documents used.

The two categories, "murdered by stranger" and "murdered by unknown," are not clearly defined as the categories when used by the United States Justice Department. Our "stranger" category is only used when the murderer is known but the relationship was not clear in the source document. The category "murderer unknown" was used when there was no information in the source document regarding the relationship of the murderer and victim, the murderer had not been apprehended, or the victim was unidentified at the time. In some situations, some of the cases listed under "unknown" may now have been solved. We did not intrude upon the lives of the survivors as mentioned in the foreword. It is not our intention to sensationalize or to make murderers celebrities. You may recognize several women who were murdered by men now made famous by the newspapers. We did not use the slogan names of these men. We saw no need to further the agenda of newspapers.

When the last name of a person is in brackets, this means that we were not certain of the spelling of the last name or that we used the last name of the parent because we only knew the first name of the victim. The word "mother" across from the victim's name means in most cases that the woman left behind young children when she died. The word "see" references similar cases or women who were murdered together or murdered by the same person. Again we caution you: please do not read this book if you have been a victim of violence or have a male or female relative or child who has been a victim of violence. There is no way to escape the pain reading the following passages will cause. This information is upsetting, but we must have courage. If you chose to proceed, we ask you to be brave; strength will come. This section will be hard reading, but as women we must stand together and face the monsters in life so that we can secure a future for our children and bring peace to our nation. There is no peace when there is violence. To the men reading our books: you must become more aware of the possibilities of danger that your daughters will experience when they date, become engaged, or marry. You cannot help the women of this nation if you do not understand their problems.

Dedication

"I have no faith in the legal system. Basically, I'm tired of Dale Abbott and everything he represents." Brenda Schworer, mother of victim

I am dedicating this book to three women to demonstrate three examples of how and why women are being murdered in this country. This information is important. This knowledge can save your life and stop you from telling your daughter or girlfriend she should stay with a husband who is beating or cheating on her especially if there is money involved. I am also dedicating this book to these women so you will never forget them and consider them every time you look in the face of your husband. All three women are dead. They were murdered in 1987, 1994, and 1997 by the person most close to them, their husband. They did not get a chance to finish their lives because a man wanted them dead. Pamela Allen Russ was 33 years old when she was murdered in California. Cynthia Mayo was 34 years old and pregnant when she was murdered in Florida and Jennifer Abbott was 26 years old when she was murdered in Massachusetts. Pamela Russ was murdered for her money because her husband wanted to continue living the good life like the husbands of Mrs. Nancy Dillard Lyons, 37, of Texas, and Mrs. Charlotte Grabbe of Illinois. When her husband was convicted Superior Court Judge Michael D. Wellington told the court, "but he used his gifts to con and betray everyone he knew." "a life of deceit and betrayal" and had killed his wife, "cashed her in for a life insurance policy." Charles Russ was charged December 6, 1989 with the murder of his wife, Pamela, nearly three years after her body was found on a road in La Jolla, California. He thought he was in the clear when he was not immediately arrested. Mrs. Cynthia Mayo was murdered because her husband had a hyper option of himself. Jennifer Abbot of Massachusetts was murdered because her husband enjoyed being cruel. Mrs. Mayo's husband committed suicide. Madames' Russ and Abbott's husband's valued their lives so they decided to take their chances with the legal system. The one element that connects their murder is society. Society has yet to resolve the situation of violence against women. It is still a subject that parents do not discuss with their children leading women to be emotionally and physically unprepared not knowing what signs to look for in order to save their lives and the lives of their children. The women are not prepared to deal with a faulty marriage. One the women need to end.

All of the women were estranged from their husbands but neither woman knew how close to death they were. They did not know their husbands were plotting their demise. If there were signs the women failed to recognize them or the women did not know the signs that lead to murder. The Institute believes neither woman thought their husband capable of such behavior. They probably believed that arguing and bickering were behaviors to be expected in a marriage. Why would or should disagreements lead to murder? Arguments in marriage are not situations of a man just behaving badly. Arguments are forms of resentment, disappointments anger, fear and bitterness of a job. These emotions can lead to murder.

A woman should always expect murder. If a woman does not expect she might be in the way of her husband's happiness, especially if she has a large insurance policy, she has signed her death warrant. Leann Fletcher of Michigan was shot to death moments after having sex with her husband. She was in the way. To the shock of Texas Wendell Lindsey of Fort Worth drowned his ten year old daughter, Jeanette, in about 18 inches of water at Lake Worth during a February 1990 fishing outing. He committed this murder after taking out a \$100,000 life insurance policy on his daughter eight days before he murdered Jeannette. A woman should always expect murder.

Everything embodied in the murder of a woman can be found in the murder of Jennifer Abbot. She had a controlling husband. Mrs. Abbott lived in Dudley, Massachusetts. She was a mother of two girls. The Worcester County District Attorney alleged Mrs. Abbott was poisoned to death in Hubbardston, February 1997. She was given a drink laced with methanol. Her husband, Dale Abbott, was the bartender at the social function they were attending. Every time he refilled his wife's drink he went out to his car and filled her glass with antifreeze. Mr. Dale R. Abbott was charged with murder March 27, 2001. He was convicted but he will be out of prison soon. Free to marry again and to begin to tell his two children how he was wrongfully convicted and how his children should see after him in his old age.

Brenda Schworer mother of Jennifer Abbott worked tirelessly to see that the man who murdered her daughter, was imprisoned.

In Volume Four Part Two, we will be discussing a particular recidivist and his victim. We will be discussing the "dissatisfied husband", who is a repeat offender, the man who says to the woman "You better or else." We will be discussing the dissatisfied husband, the man who found that the only solution to his problem was murder. The victims are all women they are dead and all of the women were murdered between 1948 and 2006. We will be speaking of the man who says to his battered wife, "I will never do it again." "Please accept these flowers as a sign of my apology." "Go out and buy yourself something nice. I want you to believe that I do care about you." "I want you to know that I just lost my temper I will never do that again."

This man is unique unto his craft. He has the advantage because he knows his prey. He understands that his victim wants the marriage to work. He understands that she wants her children to be raised with their father. He knows that his victim is willing to do almost anything to help him with his addiction, his alcoholism. She wants to be one of the winners who has a marriage that does not fail. He knows that she is willing to work day in and day out so things will be right with them. He knows all of this because she has demonstrated her desire when she allowed him to separate her from her friends and family. He knows of her loyalty because she does not receive a single phone call at home. No one calls her. No one ask her to go out on the town with the girls. No one ask her to go bowling. She is alone; the most vulnerable position a woman can be in.

Aloneness is not the same for a man as it is for a woman. Men know from childhood that a man must be fit for periods of aloneness. Successful military service requires a man to be put in position where he must be alone and fend for himself. Aloneness is part of warfare. A woman raised on a daily diet of friendship, phone calls late at night, spa days, shopping trips and gossip sessions suffers an extreme shock when all of these activities are denied her. She becomes twisted. I want my marriage to work. I believe my marriage can work. He was such a nice person when I met him. I shouldn't judge him. Like he said he was not raised with everything like I was. He is truly trying to provide for us so if I am a little patient may sooner or later we can go back to the way it once was. What woman would not chose her marriage over a friendship or a night out on the town with the girls. What woman would not consider the happiness of her children over her need for sovereignty and peace of mind while sleeping? Day in and day out women are faced with dilemmas regarding their marriage. Should I stay or should I go. If I go, will I be safe when I attempt to live alone. Sadly enough, from the lives of the women discussed within we know the answer to their dilemma is a grisly one. For each woman who faced these questions not one of these women got a chance to finish her life.

Introduction Evilness

Volume Four is about evilness, a malignancy of the heart. Evilness is a deep seeded force that propels men and women to do their very worst on the earth (murder suicide). Many argue about the existence or non-existence of good and evil and about the existence of a god and his opponent, Satan. Regardless of what side you are on one thing is certain, there is evilness in this world. Whether that evilness is driven by Satan or driven by the soul of man. Evilness does exist. Since evilness exists, it is the best evidence of a god since we live in a negative and positive world. From what we describe within there is surely evilness among us.

There is evilness in the world. It is a force that envelopes the mind until the person refuses to change and embarks on a narrow course of action that leads to destruction. Evilness is an all-consuming force. There is no day light no compromises, no second or third chances only darkness. There are no possibilities after divorce. There are no possibilities after a separation. There are no possibilities after bankruptcy. There are no possibilities after adultery. There are no possibilities except the course I have decided upon "someone must die" If you leave me I will kill the children. If you leave me I will kill you. You will not be able to escape me. I will hunt you down and make your life miserable. The only course of action you have is to capitulate and to do what you are told.

Evilness says I am angry that I have no father. I am angry because I have no money. I am angry that your country is better than my country therefore you must die. Evilness says I am angry that you are driving a new car. I am angry that your home is better than mine. I am angry because you are educated and I am not. Because of these inequalities I shall kill you. No one shall have a future. I shall rape and murder your children. I shall rape and murder your sister. I shall rape and murder until I have exhausted all modes and methods of evilness at my disposal. I shall rape and murder and while I am raping and murdering I shall laugh. I shall laugh at the inability of my victim to save herself (Raul Omar Villarreal, bragged that he stepped on Jennifer Ertman's neck when she didn't die fast enough). I shall laugh at the power I feel and I shall laugh because there is nothing you can do to undo what I have done.

In 1993 Jennifer Ertman and Elizabeth Peña were raped and murdered in Texas. Six males participated in this deed. Five were sentenced to death and one was sentenced to 40 years in prison. All of them said they did not want to die yet each of them left the scene in laughter remarking how great it was they were not discovered while they were murdering their victims. Their evil behavior ended the future of their victim's, and spawned an anger that has not been quenched even at the execution of one of the perpetrators (**Derrick Sean O'Brien**) (The execution of Messieurs Peter Anthony Cantu, and Jose Ernesto Medellin should soon follow if there is any justice in the world). Their evilness has left an indelible stain on the lives of two families.

You may not want to believe there is a dark force in the world operating in the lives of some men but the existence of this force explains envy, jealousy, rage, liturgy, rape and murder. If you believe there is a duality in life, then you believe in good and evil. If there is goodness then there is evilness and both forces are quite active and it is the activity of evilness that causes the destruction you see on earth. Evilness recently claimed the soul of Mr. Sam Quintana Jr., 25. Never was there such an example of good and evil as there was in the courtroom of District Judge Michael Villano in Colorado March 23, 1999 when he sentenced Mr. Sam Quintana Jr. Mr. Quintana's father fought to keep him out of a gang. He wanted the best for his son. But his son chose a course for his life to follow rather than to lead. He chose a course to follow men with depraved souls, rather than go to school, get a job, marry and raise children. The sentence he received was the results of this choice. March 1999 Mr. Sam Quintana, Jr. was sentenced to 96 years in prison at the age of 25. Why, because Mr. Quintana's mind had been enveloped in evilness. He associated with men who were evil and this evilness translated into the rape and murder of two young women Venus Montoya, 19, in 1996 and Brandy Duvall, 14, in 1997. The judge who sentenced Mr. Santana was a merciful person, he knew Sam Santana had changed but his hands were tied he had to follow the law Mr. Santana must be held accountable for his actions.

I do not think until he was charged with murder (in the light of day) that Mr. Quintana realized how much he was loved until he was faced with his father's tears in the courtroom. I think he finally realized that there was nothing his father would not have done for him if he had change. I think he finally realized his life was not his own. He had an obligation not only to himself but to his family to be a responsible human being. He finally realized he participated in an act so foul that it made his mother ashamed. He finally realized that his life was not his own, that part of it belong to the mother who loved him who need her son to succeed; who needed her son to live a good life. He finally realized that he would forever be the cause of his parent's suffering. He finally realized that he brought so much shame to his family that his behavior made his father feel that he had failed in his life. Imagine sitting in a courtroom recounting what you and five other men did to a 14 year old child and your father is sitting nearby listening to you. Years ago a father sat in a Warwick Rhode Island interrogation room and listened to what his 15-year old son had done to three females. The father ran to a corner in the room and threw up. He used more than one knife and the handles broke from the blades. Can you imagine how he felt when he learned his son murdered another neighborhood woman two years earlier? If this is not the father that threw up, it is the father of another 15 year old who murdered more than one woman. Imagine being told your 13-year old son murdered a woman because he was a thief. He stabbed her 58 times. Imagine being Mr. Quintana's father being told your son is a rapist and a murderer. Mr. Quintana restrained Brandy Duvall while she was being stabbed. Brandy Duvall was stabbed 28 times.

"This man could have saved my daughter's life that night, but he chose not to.
Every day, I can hear her crying for her life. Can you imagine how scared she was?
But he did nothing to help her. Instead he held her head so she could be stabbed

over and over and over again." Angela Metzger, Brandy Duvall's mother

Sam Quintana finally realized that he sacrificed his self-respect to be in a gang, to be a member of the devil's disciples that instead of being a creator of life he became a destroyer of life. There is only one force in the world that can save him now from a life time of torment and that is goodness in the form of Jesus Christ.

He finally realized what he and six other men did were an abomination, that they were consumed with evilness. He allowed evilness to reside with him. He allowed evilness to fester in his chest until it expressed itself in a bestial behavior. He could not say he was insane yet he had allowed himself to be taken over by a dark force that consumed his existence and dulled his senses. Being a member of a gang was no excuse for his lack of humanity. Mr. Quintana enjoyed being a gang member, living on the edge of society. Sneering at those of us who work and worry over our next piece of bread. The life he lived came crashing down when he realized the greater society now had charge over him. He was not as free as he thought he was. There was a greater power than he and that power could either take his life as he took the life of Brandy Duvall or it could exercise restraint and allow him to live. He had lived on the edge pretending his reality was entirely under his control now it was day light and he found he like Brandy Duvall had no control. When Mr. Quintana had to stand in court and tell what he and the other so call men did to Brandy Duvall he whispered. He did not have guts enough to stand up in court and look the judge and jury directly in the eye and tell of his participation. His male bravado had disappeared. It is one thing to laugh and joke with the boys about your sexual prowess it is another to sit in a courtroom filled with people who are listening to your every word knowing they believe you are no more than human waste. One thing for sure Sam Quintana did not want to die. He plea bargained to get the sentence of 96 years in prison. He finally realized that there was evilness in the world and it was he. He had become a tool for destruction. He finally realized that it was evilness that led to the deaths of Venus Montoya, a young mother and, Brandy Duval a young child.

Do not misunderstand my writing or my position on capital punishment. I have no sympathy for Mr. Quintana. His age and state of health assures me he shall suffer sufficiently every second of his life as he watches his hair grow grey in prison. This passage was not written for Mr. Quintana it was written for the young men to come who have to make a chose to follow evilness and be damn or to follow goodness and be saved. I am writing this section to try and save lives not to see them destroyed because of the evilness in the world. Somehow we must instill in our children they must lead rather than follow. Making the decision to join a gang is a choice. Mr. Quintana made that choice now he shall reap the whirlwind. Mr. Quintana enjoyed being buddies to these men. He enjoyed his participation in the gang. He felt important. He could be a big fish in a small pond. If he had not enjoyed his participation, he would have stopped this behavior and left the area. I am reporting what occurred in court but in my heart I believe Mr. Quintana and the six other men who brutalized Brandy Duval should be put to death. They should not be allowed to live. They are an abomination to the Lord and what this country stands for. We must all act to stamp out the evilness that is festering in our country. The only reason why these men cannot be put to death is because the Colorado statues at the time allowed for capital sentencing to be performed by a panel of judges rather than a jury and the United States Supreme Court ruled this procedure unconstitutional. A man must be put to death by a vote of 12 people not a panel of judges. A man also has the right to plead for his life.

The case of Brandy Duvall was one of the most difficult cases I have had to read. It took me several years to read what happened to her and to write about her. What happened to her could have happened to any child. She did not participate in any risk behavior. She was merely

going about her life and seven men decided she should die. Imagine the arrogance. One of her assailants when faced with death told the court room he was sorry. Imagine. If you knew what these men did to Brandy Duvall there is no way you can believe this man was sorry. He was the greatest monster of them all. Life had finally given him the opportunity to play God and he could not resist the moment. The only reason why this man was sorry is because he knew he was facing the death penalty at the time of his original sentencing.

These men were no bodies. They neither had the power of imagination to transform their existence from a desert into an oasis nor were they interested in transformation. Every day they ate from the bowl of rejection and used cruelty to justify their pain. No one knew their names. They would not be important now except their death penalty case have filled our courts for the last decades. These men were too busy paying the world back for rejecting them to recognize the evilness festering in their souls. Now it is damnation time, only they shall know how they fare.

It was evilness that caused Mr. Dustin John Higgs to order the murder of Tanji Jackson, 21, Tamika Black, 19, and Mishann Chinn, 23, January 27, 1996. It was evilness that caused the triggerman, Willis Mark Haynes, 22, to follow his orders.

It was evilness that caused Mr. Joseph Paul Franklin to shoot Toni Schewnn, 23 and Mr. Alphonse Manning to death August 7, 1977, and Nancy Hilton, 18, and William Tatum, 22 July 29, 1978 and Kathleen Mikula, 16, and Arthur Smothers, 22, June 15, 1980.

It was pure evilness when Lena Abdehauq, (infant), Mrs. Sandra Black, Mrs. Linda Marie Brown, Mrs. Carol Bruce, Marsha Levine, Officer Sharron Randolph, Mrs. Paul Sloan, Stella Sproule, Mrs. Carol DiMaiti Stuart, Zelma Swetesich, Anna Marie Turetzky, 46, Mrs. Stephanie Whitaker 20 and Mrs. Trish Willoughby; and Christine Bergeron, Mrs. Mary Brissette, Mrs. Starla Burns, Mrs. Dorothy DeTore, Mrs. Sophie Freidgood, Mrs. Patricia Ann Albanowski Giesick, Mrs. Mary Joan Lee, Mrs Maria Marshall, Mrs. Carol Thompson, Estelle Turner, Miss Turner, Mrs. Alma Ruppert, and her family and, Mrs. Marie Schuhotz, and Mrs. Xia Mee Vang, 22; Mrs. Carolyn Lawrence Amos, Mrs. Roberta Amos, 37, Mrs. Sandra Heard Amos, Mrs. Barbara Anderson, Elizabeth Cobb, 31, Telia Echols 8, Mrs. Mildred Horn, Mrs. Ricky Jeste, Bonnie Kaiser ? Mrs. Kimberly Poole, Mrs. Janice Saunder, Mrs. Betty Anne Smolka, Mrs. Sara Tokars 39, Mrs. Mary Toles, Mrs. Diane Wanstruth, Rhonda Wheeler and Mrs. Gertrude Duff-Smith Zabolio were murdered for the value of their family wealth, inheritance or insurance policies. The money was used to pay off bills, settle gambling debts, to avoid child support, start a new business and a new life because someone was in the way. The life insurance policies ranged from \$25,000 to \$1 million dollars. All tidy sums to be used to tie up all of the financial loose ends of one's life.

Mrs. Michelle Marie Fisher Young, pregnant, 29 (mother)

Michelle Young of Raleigh, North Carolina had a \$1million life insurance policy with her husband as sole beneficiary. This policy became a central element when her husband, Jason Young, 35, was charged with murder in 2009, three years after her death. Prosecutors believe Mr. Young was committing adultery with a woman in Florida and apparently Michelle Young was in the way. The life insurance policy was a bonus to start a new life. In 2006 Michelle Young was pregnant with her second child. November 3, 2006 while her husband was away on a business trip Michelle Young's sister found her body on the floor of Mrs. Young's bedroom. Mrs. Young was badly beaten and her child was found in the house with Michelle's body. For a while friends and family asked themselves who could have murdered Michelle Young in her home.

They got their answer when Mrs. Young's family filed a wrongful death civil suit against Jason Young. December 6, 2008 Wake County Superior Court Judge Donald Stephens of Raleigh, North Carolina told the court, It is, therefore, ordered, adjudged and decreed that the Defendant, Jason Lynn Young, willfully and unlawfully killed Plaintiff's decedent, Michelle Marie Fisher Young." Mr. Young lost a wrongful death civil suit when he failed to respond to the suit. Michelle's family was awarded \$15.6 million. Mr. Jason Young went on trial for murder June 8, 2011. Dr. Thomas Clark testified said he found multiple blows on Michelle Young's body that included blows to the upper arm, teeth knocked out, extensive lacerations on the left side and fractures to the skull and jaw bone. "There have to be at least 30 blows," he said. "It couldn't have been inflicted in less than 30 blows." Dr. Thomas Clark, who performed the autopsy in Chapel Hill in November 2006, said he found multiple blows that included:

- Three or four blows to the upper left arm
- Several front teeth knocked out
- An abrasion on the back of the neck and a small one on the side of the neck
- Bruises on the left side of the head
- Eight blows to her left side that resulted in cuts that were 1 to 3 inches long
- Fractures to the jaw bone
- Bruises on both hands
- Fractures to the skull
- Evidence of strangulation from finger marks on the neck

For most of the wounds, yes a weapon would have been required. Some of the injuries could have been done with a fist. The fingernail marks from strangulation were not done with a weapon. ... "The only thing I can say about the weapon is it was heavy and it was definitely a blunt object." Jurors are to believe Mrs. Young was beaten to death for her jewelry. Once you learn your husband has committed adultery you must remain forever vigilant. You do not want the headlines to read, "Woman is Suspected of Murder in the Slaying Boyfriend's Wife." The above cases should be enough to demonstrate to you as an affair progresses the mistress becomes more and more convinced that you are the problem. She will say to herself, "He may be your husband but he is my man and you need to let him go. He does not want you any more he wants me. All of this would be over if you would just get out of the way. He has told you too many times he wants a divorce. I don't see why you don't understand that he is through with you. He wants me." What you do not want to do is be unprepared when she decides to act on her thoughts. You must pay attention, you must pay attention at all times, nothing is more important than paying attention to your surroundings including your husband. He is part of the surrounding. Put the mop down. Put the broom down and forget about cleaning the house and start paying attention. A retrial was ordered in February 2012.

Is the death of Mr. Michelle Marie Fisher Young of North Carolina not an evil act?

You will not see your death coming therefore you must plan to prevent it. You can possibly prevent your death by gaining knowledge as to how other women were assaulted and murdered.

As you go about your day your mind never brings up the question, “Why would my husband want to kill me? You thoughts are normally filled with the drama at work, how are the children doing in school and will you have enough time to go shopping after work. It never occurs to women to think about murder unless they are in immediate danger or there have been physical altercations in the home. Yet here are five classic reasons for your husband to kill you when violence is absent in the relationship. The reasons are:

- You are in the way. Your husband has moved on and wants to live a different life one of leisure and fun.
- Your husband needs money to save his business. He has worked too hard to see all his labor go down the drain. He can always get another wife. The children will adjust.
- Your husband does not want to pay child support or see you live in his home with another man upon divorce.
- Your husband does not want to split the family assets down the middle. Why should he share his retirement with you, he is the one who earned it.
- Your husband has a girlfriend and he needs money to make her happy. You can't expect him to start all over again with the new love of his life.
- Your husband wants to start a business and he does not believe he can earn enough money on his current job for start up funds. You are his investment for the future.

So you see from a practical stand point murder is not an exceptional act. Murder is a solution a practicality one in which you will play an essential role. In Volume One, The Deadliest Moment, we discussed Mr. Timothy Boczkowski who killed his wives in two states. He murdered his first wife, Mrs. Mary Elaine Pegher Boczkowski, 34, in Pennsylvania. He murdered his second wife, Mrs. Mary Ann Fulton Boczkowski, 35, in North Carolina. We also discussed Mr. Gerald R. Hand. He had three wives murdered in Ohio. He had his first wife Mrs. Donna Ann Hand, 27, murdered March 24, 1976. The cause of death was strangulation. He had his second wife, Mrs. Lori Lee Hand, 21, killed September 9, 1979. She was strangled and shot. His third wife divorced him. Mr. Hand had his fourth wife, Mrs. Jill Lee Hand, 58, killed January 15, 2002. She was shot in the head. In Volume Four Part Two and Part Three we will discuss a unique recidivist, the husband who has decided to do what is best for him. We

will discuss the man who decided his wife is more valuable dead than alive. We will discuss the man who believes his family cannot live without him and we will discuss the women who are murdered who instinctively do not trust their husband yet remind married. And we will discuss the woman who leaves her husband and is still murdered. Husbands become stalker, burglars, petty thefts, destruction of property. The men are reduced to prying, snooping, lying and cheating. The women are from all walks of life.

Mrs. Veronice Bowen, 21 (mother of 3) pregnant

The man who murdered Veronice Bowen and subsequently Sheila Jackson was comfortable in his depravity and brutality. He was a methodical killer and had no problem brutalizing his victims and anyone who was around him. Yes he is a father. February 9, 1989 Mrs. Bowen was reported missing from her home in New York City. Her headless body was found 15 days later, on February 24, 1989. Veronica Bowen was found naked on the rooftop of Phillip Ward's apartment building. His alibi held for 23 years until he confessed to her murder February 2012. He said she beat her with a pipe and stabbed her to death. Veronica Bowen had separated from Mr. Ward because he was violent. During their separation she became pregnant. For this infraction Mr. Ward thought Veronice Bowen should die.

Mrs. Sheila Jackson,

Shelia Jackson was shot to death February 1994 in her New York home five years after her husband, Phillip Ward, murdered his first wife. Her husband, Phillip Ward, was convicted and sentenced to prison for her murder. He was not arrested for the death of Veronice Bowen until 2012 when he was charged with the murder. He was in prison for the murder of Sheila Jackson when he was charged with the murder of his first wife.

Mrs. Laura Lee Godfrey Holliman, 24

December 4, 2009 Brian Holliman, 28, stood in a Lowndes County Circuit Courtroom in Mississippi and told the judge he loved his wife. He said, "I did not kill my wife on purpose. This statement had to be hard to accept since Mr. Holliman had been convicted of shooting his wife to death with a 12 gauge shotgun. How do you love someone and shoot them with a shotgun. The judge knew the jury only took 90 minutes to convict Mr. Holliman of first-degree murder. The judge also knew Mr. Holliman's attorney told the court that Laura Holliman was suicidal and the 12-gauge shotgun went off accidentally as the couple argued. None of these situations were congruent. The jury did not believe the shooting was an accident nor did they believe Laura Holliman was shot out of love. She was killed because her husband was angry that she was leaving him. Laura Lee Godfrey Holliman lived in Caledonia. She was murdered October 25, 2008. Brian Holliman was sentenced to life in prison. He will be eligible for parole at age 65.

Patsy Riley Grant, 50 (mother of 3)

Patsy Grant was murdered in her home in Hardeeville, Georgia. She was trying to protect her daughter, Charlene Michelle Lovett, 30, who came to live with her. Mrs. Lovett was running from her husband, Leonard Lovett. It seems Mr. Lovett was a very violent man. Rather than leave his wife alone he sought her out at her mother's home. He entered the home with a shot gun and shot Mrs. Grant to death then he beat his wife unconscious with the butt of the shot gun. He told the arresting officers that he just snapped. Mr. Lovett had a habit of snapping. Sheriff's investigators said this wasn't the first time Leonard Lovette has "snapped". They say he had been arrested several times before for domestic violence, and the night of the shooting, deputies had been to Grant's Freedom parkway home twice before because Michelle was "scared". But when deputies left the second time, deputies say Lovette went inside the house and opened fire. Charlene Michelle Lovett spent more than a month in the hospital following the February 21, 2006, beating. After pleading guilty to murder February 13, 2007 Mr. Lovett, 38, was sentenced to life in prison. Leonard Lovett was found by deputies hiding under a mattress in an abandoned trailer.

Professor Debra Allen Vasquez, 50 (mother)

"I think all the time, if we had known, what could we have done.... People didn't know that she was involved in a relationship that had any possibility of something like that. Charles Dassance, college president

Debra Vasquez was a professor of communication at Central Florida Community College. July 2004 Ms. Vasquez was arguing with her husband at a mall. She left the mall and drove to the Ocala Police Department to get help. As she was driving her husband rammed her car. When she arrived her husband shot her to death. The police station was unstaffed at the time. The doors to the station were closed. Her husband, Jose Vazquez, later committed suicide. He died of a self-inflicted gunshot wound. After Debra Vasquez death the Ocala police department was staffed 24 hours a day. It was suggested that fire stations be used as safe havens for women. The by line in the newspapers was Man shoots wife outside empty police station. Most

women believe once they get to the police station they can get help. This is not true.

Mrs. Ramona Williams, 48 RN (mother) see Mrs. Adrienne McGee, 28 (mother of 3)

Ramona Williams was shot to death May 27, 2005 on her front lawn in front of Officer James Fuller of Brownwood, Texas. When her husband, Steve Williams, 40, attempted to shoot his daughter Officer Fuller fired at Mr. Williams making Steve Williams retreat into the house. Two officers were subsequently wounded trying to arrest Mr. Williams. Mr. Williams was shot and killed. Mrs. Williams had filed for a divorce May 17, 2005. 2005 was the first time officers were shot in the line of duty in more than 35 years in Brownwood. This may be why the officers were not as cautious as they would have been if they walked up a robbery. Domestic violence calls are deadly. Men in crisis or men who have been rejected are dangerous and volatile. A woman cannot file for a divorce and not expect violence.

Army Lt. Holley Wimunc, 24 (mother of 2)

Holley Wimunc worked as a Womack Army Medical Center in Fayetteville. She was estranged from her husband, Marine Cpl. John Wimunc of Camp Lejeune. She was in the process of a divorce after about a year of marriage. May 2008 Holley Wimunc got **a temporary restraining order** to keep her husband away from her. She said her husband put a gun to her head and threw her around their living room. She asked for the restraining order for 10 days. July 10, 2008 Lt. Wimunc was reported missing after her apartment was set on fire. Her charred body during a brush fire was in Sneads Ferry, near Camp Lejeune. Marine Cpl. John Wimunc of Camp Lejeune was arrested July 14. A second Marine, Lance Cpl. Kyle Alden, was charged with aiding John Wimunc by destroying evidence and providing a false alibi. Her estranged husband, Marine Cpl. John Wimunc, has been charged with killing her in 2008. A second Marine, Lance Cpl. Kyle Alden, of Camp Lejeune was charged with helping him by destroying evidence, burying the body and trying to establish a false alibi. Holley Wimunc was shot in the head and her body was partially dismembered and burned. Her husband reported her missing July 10, 2008. Firefighter's found her body wrapped in an air mattress three days later. At one end of the mattress, the edges were wrapped around her head, neck and upper body, and secured with clear tape. Her legs were severed mid-thigh. A metal hatchet, its handle charred, was found partially on Holley Wimunc's back and shoulder. Fragments from a projectile were recovered from Wimunc's head and left hand. Mrs. Wimunc was a mother of two.

Mrs. Amy Wingfield, 31 RN (mother)

Amy Wingfield of Celina, Texas, was estranged from her husband, Raymond Wingfield, 31. Mrs. Wingfield was at work May 16, 2002 when she was shot to death. Her husband shot her and her coworker, Lisa Stewart, 41, RN using a sniper rifle. He probably rejoiced in the thought that he killed his wife at work the one place she felt safe. He wanted her surprise when he killed her. Probably the only thing he regretted is that he could not see her face when he shot her. Raymond Wingfield pleaded guilty and was sentenced to 60 years in prison for his wife's death. He received a 20-year sentence for shooting Stewart, then got another 10-year sentence tacked on for plotting from jail to have Lisa Stewart killed months after the attack. He was a very evil man. Mrs. Stewart was left partially paralyzed. The women were returning from lunch when they were shot getting out of Mrs. Wingfield's Ford Expedition. Mrs. Stewart was shot in the back. No reason was given for the murder.

Murder occurs in every state of the union to women from all walks of life and of all ages. Who gets murdered depends on when the man decides to kill.

White, 74, and strangers, Andrea D. Myers, 31, and her 18 month old daughter, Corinne Gracy Myers, James Irvin Starling, 24, Sonja Lolley Smith, 43, and Bruce Wilson Malloy, 51. All the victims were shot to death in Kinston, Samson and Geneva, Alabama. High school baseball coach Chris Reid said, "Everybody knows everybody. "Everybody's always been willing to go out of their way to help people in need around here, no matter what the case may be. It's just a small town where you consider your friends as family."

California

Mrs. Zarghona Rahim, (mother of 2)

Zarghona Rahim, 46, was shot to death in her north Fremont California home November 11, 2006 during an argument with her husband, 62-year-old Wazir Rahim. Mrs. Rahim's mother, 82, was shot but survived. She called for help. Her grandchildren disarmed their father, tied him up beat him then called the police. Mr. Rahim was admitted to the hospital on life support.

Connecticut

Mrs. Rosa Wood(s)
George Troie

Patricia Voli
Lisa Voli (Wood)

Mrs. Rosa Wood was divorced and living in West Hartford, Connecticut with her daughter, Lisa. She had established a new life and was developing a relationship with a new boyfriend, Mr. George Troie. April 17, 1982 Mrs. Wood, her daughter, Lisa, her mother, Patricia Voli and her boyfriend, Geoge Troje, were all murdered. Murderer Status: Her ex-husband, Steven J. Wood, was accused of murder. He was convicted June 28, 1984. He got his revenge at the price of four lives. Mr. Wood was not subjected to the death penalty because of his diminished mental capacity. It is now 2000 has he regained his sanity.



With all of the murders occurring in this country you would think murder is a common topic. It is not. In fact there are five categories of murders that we avoid that we exclude from conversation. These murders are:

1. Murders committed by the clergy.
2. Murders committed by police officers
3. Murders committed against a wife and child and
4. Murders committed in suicides.

There seems to be a general consensus to avoid discussion at all cost. The failure to openly discuss these murders eliminates any knowledge we can learn from these situations. Jewel Schirmer and Betty Jean Schirmer of Pennsylvania were the wives of ministers. Veronica Bowen of New York and Sheila Jackson just happen to be married to the same man at different stages of his life. We are going to discuss the man involved in the classic accident such as the case of Pastor Schirmer. Pastor Arthur Schirmer of Pennsylvania is suspected in the death of his first wife, Jewel Schirmer, and charged with murder in the death of his second wife, Betty Jean Schirmer. Women can no longer think marrying a man of the cloth is a safe marriage To provide you with insight in these murders we introduce below:

Mrs. Sharon Guthrie, (mother of 3)

February 3, 2000 the headlines read South Dakota Pastor is Convicted of Killing His Wife. The headline reaffirmed that men are men regardless of their occupation. Sharon Guthrie was the wife that was murdered. She was poisoned. Her husband, Rev. William Guthrie, pastor of the First Presbyterian Church of Wolsy S. D. and of the Bonilla Presbyterian Church, said he returned home May 14, 1999 to find his wife unconscious in the bathtub. The police were not satisfied with his explanation especially after the autopsy. Rev. Guthrie was charged with murder. Police suspicions mounted after they found out he was committing adultery with a woman in Nebraska. A divorce would jeopardize his standing in the community. An autopsy revealed the contents of 10-20 capsules of Temazepan in her body, a sleeping pill that was prescribed for her husband. The jury did not believe Sharon Guthrie committed suicide.

Mrs. Jewel Schirmer first wife

"I knew since '99 that she was murdered. I'm happy, I'm elated, but it doesn't come as a real surprise." Jonathan Behney, brother

Jewel Schirmer lived in Lebanon County Pennsylvania. She was married to Pastor Arthur Schirmer. Her husband was serving as pastor at the Bethany United Methodist Church in Lebanon. Her husband said he returned home from jogging April 23, 1999 to find his wife's body at the bottom of the basement steps. She was bleeding from the head. He called 911 and Jewel Schirmer was taken to Hershey Medical Center where she died the next day of a traumatic brain injury. An electrical cord from a shop vac was wrapped around her leg and her shoes were off. Her death was ruled undetermined. In 2012 Dauphine County Deputy Coroner reclassified her death as a "homicide." A grand jury was convened in 2012 where Dr. Wayne Ross said he believed Jewel Schirmer's injuries were not consistent with a passive fall down a flight of stairs. Dr. Ross said that her skull fracture would have required at least 750 pounds of pressure or force to cause it, and the lacerations to her head were highly suspicious and could have been caused by an object striking her head. Dr. Ross testified that Jewel had 14 separate impact injuries to her head and face, numerous abrasions and contusions throughout her upper body and arms, as well as pervasive trauma, including dilation, abrasions and bruising to the anal area. Dr. Ross firmly believed Jewel's injuries were not from a passive fall and told the grand jury he believed the investigation should be treated as a homicide. Her husband, Arthur Schirmer was arrested September 13, 2010 for the murder of his second wife, Betty Jean Schirmer.

Mrs. Betty Jean Schirmer Second wife

Betty Jean Schirmer died July 2008. Police are saying her husband, Arthur B. Schirmer, 60, the pastor of Reeders United Methodist Church in Pennsylvania, staged an automobile accident to cover up murder. July 15, 2008 a person stopped to help a man in a PT Cruiser crashed on Route 715 in Reeders, Pennsylvania. The man inside the crashed vehicle was Pastor Schirmer. He told the passerby that his wife was injured when he struck a guardrail while trying to avoid a deer in the roadway. Betty Schirmer was taken to an area hospital where she died of head injuries, blunt force trauma to the head. Arthur Schirmer told police he was driving between 45 and 55 mph at the time of the crash. Arthur B. Schirmer was arrested September 13, 2010. He was charged with criminal homicide and evidence tampering. The damage to the car was from a vehicle traveling 20 mph. Betty' Schirmers side of the car was saturated in blood. She was bleeding from the head, unconscious, and having difficulty breathing. She also had a large laceration and bruising on the right side of her head, fractures to her face and skull,

a possible fracture to the cervical spine. Pastor Schirmer was not injured. He did not call 911 although he had a cell phone. The passerby called 911. Mrs. Schirmer was not wearing a seat belt. Investigators believed Betty was actually bleeding prior to the crash, and blood evidence on the passenger seat indicates she was bleeding prior to getting into the car. Police executed a search warrant on Pastor Schirmer's church, where he also lived, and discovered numerous dried blood drops located on the floor of the garage near the top of the stairway. There was also a large blood stain area on the concrete floor that appeared consistent with the area of the passenger front door, based on tire impressions and observations concerning where the car would be parked. DNA testing on Betty's relatives revealed that blood found in Schirmer's home was 20 trillion times more likely to be Betty's blood than an unrelated person. When police confronted Schirmer with the blood they found in the garage, Schirmer allegedly told them that within a month prior to Betty's death, he and Betty were removing firewood and a wood pile fell on both of them, causing them both to bleed. Schirmer claims he was cut on the wrist and Betty was cut on both arms causing her to bleed on the garage floor. Pastor Schirmer is awaiting trial. A grand jury was convened in 2012 into the death of his first wife Jewel Schirmer. Her brother said he always believed her death was murder.

At first glance Bety Jean Schirmer's death was deemed to be an accident but after the death of Mr. Joseph Musante police took a second look. October 29, 2008 the body of Joseph Musante was found behind the pastor's desk in the church office. He had committed suicide by shooting himself in the head. His wife, Cynthia Musante, was employed as Schirmer's personal assistant at Reeders United Methodist Church. There were complaints alleging an affair between Joseph Musante's wife and Pastor Arthur B. Schirmer, an affair necessitating the elimination of the respective spouses. The police began receiving several complaints about the deaths of both Pastor Schirmer's late wife Betty and his first wife Jewel Schirmer. Pastor Schirmer was finally indicted for murder.

You will see in the case of multiple murders the police have to go back and re-examine the first wife's death. It is not an anomaly for a man to marry and kill more than one woman. A case in point is Mr. Phillip Ward. Mr. Ward killed his first wife, his second wife and raped her daughter. The Institute wants women to realize men such as Mr. Ward are not anomalies

Mrs. Kari Baker, 31 (mother of 2)

Kari Baker lived in Texas. She was a pastor's wife. The prosecutor charged her husband with murder stating he was committing adultery and he murdered his wife because she was in the way. March 27, 2009 Matt Baker of Kerville, Texas was indicted by a grand jury in the death of his wife Kari Baker. The indictment said Kari Baker was suffocated with a pillow in April 2006. He was committing adultery. During his trial his ex-mistress testified that he drugged his wife, handcuffed her to the bed under the guise of spicing up their marriage, then smothered her with a pillow until she died. Vanessa Bulls (given immunity) said Matt Baker, then a Baptist preacher, had talked about killing his wife and making it look like a suicide.

Mrs. Sylvia Bettis

November 8, 2004 he body of Sylvia Bettis was found in the bedroom of her home in Sand Springs, Oklahoma. She had been decapitated. Her husband, Minister Robert Bettis, 70, was an immediate suspect. November 12, 2004 Minister Bettis' body was found in the Shell Creek Lake. The coroner said Robert Bettis jumped off a dam and drowned himself. The death was ruled a homicide. Minister Bettis knew how to swim but jumped in a section of the lake where there was not way to pull him out. Bettis was the pastor of Victory Assembly of God in Sand

Springs for about seven years. He retired in March. There were subtle changes in his personality.

Mrs. Cheryl Flippo,

James M. Flippo of West Virginia called police in the early morning of April 30, 1996, claiming a masked man had barged into a cabin he and his wife, Cheryl, were renting. The man cut him with a knife and knocked him unconscious, and that when he awoke he found his wife beaten to death. James Flippo was the pastor at the Church of God. The police found a photograph of a man taking his pants off. Prosecutors charged Flippo with his wife's murder, introducing the photos at his 1997 trial as evidence he was having an intimate relationship with the man and that he killed his wife in part because she was angry about it. He was sentenced to life in prison without parole. The U.S. Supreme court ruled that a warrantless search is not allowed simply because a homicide had occurred. The photograph was no longer admissible.

Mrs. Jean Gareis Hetenyi, (mother of 2)

Jean Gareis of California married Rev. George Hetenyi, an Episcopal Minister, August 1945 probably believing he would make a great husband. Her family objected to the marriage. This was her second marriage. Her first husband died in World War II. She had two children during the marriage. The couple lived in California, Texas then New York. April 23, 1949 her body was found in the Genesee River in Buffalo, New York. She was killed by two .25 caliber gunshot wounds to the chest, and was dead when she was placed in the river. The discovery of her body led to three murder trials for her husband. Neighbors told authorities of frequent violent arguments between them. There was evidence Jean Hetenyi was frequently beaten. A large amount of blood was found throughout the Hetenyi's 1947 Oldsmobile. A bullet was found in the interior of the door. The bullet was fired from the same pistol that fired the two bullets recovered from the body. Rev. Hetenyi requested a dry cleaner in Buffalo, New York to clean human blood spots from the interior of the vehicle. Jean Hetenyi's children were ages 2 and nine months at her death. Jean Hetenyi was a University of California graduate. She was successful as a concert violinist and played with the Oakland Symphony. On June 2, 1966, Hetenyi pleaded guilty to first degree manslaughter and was sentenced to time served, plus six days. He was released from prison after 17 years. He told the state that he was accepted into a monastery in the Midwest. He told the court at his sentencing he would enter the religious life and do penance. His attorney, Alexander Hercsa of Syracuse, said Hetenyi's excommunication was lifted by a decree from the Vatican, which made him eligible to become a monk upon his release. Mr. Hetenyi died in Phoenix in April 1977 at the age of 68.

Mrs. Arletha Hopkins, 36 (mother of 7)

Police believed Pastor Anthony Hopkins, 37, killed his wife, Arletha Hopkins, in 2004 after she caught him molesting his daughter in the bathroom. Her body was stored in a freezer. Anthony Hopkins, 37, of the Inspirational Tabernacle Church of God in Christ in Jackson, Alabama was arrested and charged with murder, rape, sodomy, sexual abuse and incest. One of Mrs. Hopkins daughters told police she had been sexually abused by her father since she was 11 years old. The child was 19 at the time of her statement. She told the police her mother's body was in a freezer in the home.

Mrs. Marthina Lindhardt, 25

April 13, 1997, Marthina Lindhardt died during a camping trip with her husband, Keith Linhardt,

near Harrisburg, Missouri. Her husband said he found her body in a pond. He said Marthina must have fallen into the pond and drowned after she got up in the middle of the night to go the bathroom. After Martinia Lindhardt died her husband went to live with her parents. What he did not tell them is that he had taken out a \$1.6 million life insurance out on Marthina Lindhardt shortly before she died. Keith Linhardt, 27, a lay minister of the Warrenton Christian Church pleaded guilty to the suffocation murder of his wife and received a 50-year sentence. Her parents, Clayton and Lila Shelburne, sued the insurance carrier for wrongful death. They believed that the insurance companies were responsible for "overinsuring" Marthina and giving her husband, Keith, a motive to kill her. a Missouri case, *Williams v. John Hancock Mutual Life Insurance Company*, 718 S.W.2d 611 (Mo. App. 1986), which allowed wrongful death claims against carriers that negligently insure a person and thereby create an incentive for murder. There were six insurance companies involved. Their underwriting procedures violated multiple laws and regulations. The case was based on four standards.

- issued an unreasonable amount of insurance to Marthina, since she was a hairdresser who earned no more than \$25,000 per year;
- failed to verify whether she was aware of and consented to the policies;
- did not meet with her before issuing the policies and did not deliver them to her in person; and
- should have consulted industry data-bases that would have disclosed other policies recently taken out on her life. The agent did not actually witness Marthina's signature on the application and did not know whether it was hers.

Mrs. Patty Jo Riddick Pulley, 37

"It has the whole county upset."

Ethel Mae Byrum, friend

Patty Jo Pulley graduated in music from Meredith College in Raleigh and could play every instrument in the orchestra. She taught private music lessons from home. She was the piano and youth teacher at the River of Life Church in Ringgold. Her husband was the associate pastor. She was reported missing May 14, 1999 by her husband of Pittsylvania County Virginia. Her husband, Minister Rick Pulley, said she left home to go on a shopping trip and never returned. Her red 1991 Ford pickup truck was found the next day in North Carolina. A \$50,000 reward was offered. Numerous searches were made by the police, area volunteers, tracking dogs, helicopters and the river was dragged. Patty Pulley's remains were found December 18, 2002 near a bridge in Leasburg, North Carolina. February 14, 2003 former minister Eugene Ricky Pulley, 46, was charged with murder. November 1, 2004 he was convicted and sentenced to life in prison without parole. A member of Patty Pulley's family learned Mr. Pulley was having an affair with another woman. The couple was married 13 years. Why could Minister not just divorce his wife? The answer to this question can be summed up in one word "selfishness". All his secrets would be public. He could no longer pretend to be perfect. Pretending to be something that you are not is more important to some people than being honest. My cheating on my taxes is much different than you cheating on your taxes. My behavior is excusable because I only cheated once on my taxes whereas your behavior is not.

Mrs. Adrienne Nicole Radford, (mother)
Mary Anne Turner, 47

Frederick Radford, a Methodist minister, working in Tennessee shot his wife and another parishioner in a church. Both women later died in an area hospital. Mary Anne Turner was

trying to help Adrienne Radford when she was shot. Adrienne Radford told her husband she was moving to Florida with their son. He was charged with two counts of murder, several counts of felony wanton endangerment and single counts of fleeing or evading, violation of a domestic violence order and possession of a stolen firearm. When Adrienne Radford was shot to death May 18, 2001 in The Greater Oak Missionary Baptist Church in Hopkinsville another child was left motherless. Mrs. Radford left her husband then filed for divorce. He had threatened her wife violence that she detailed in her protection order request. What she did not do is leave the state. She made the same assumption most women make when they separate from their husband. The assumption that her husband would not turn violence cost her, her life. If you have to file a domestic violence order against your husband then he is violent. If your husband threatens your life he is violent. Why not take him at his word? If your husband or boyfriend says he is going to kill you, believe him and leave the state. You are not good to your child if he kills you. Children in foster care are prisoners of the state. When they are 18 they are dumped on the street with no family affiliation to support or direct them. You have a responsibility to your children therefore when danger presents itself you should leave the state. Please note how quickly Pastor Radford, 35, turned violent and that he carried a gun with him to church. Frederick Radford felt he should be obeyed. October 28, 2002 Fredrick Radford pleaded guilty to two counts of murder and single counts of first-degree wanton endangerment, possession of a handgun by a convicted felon, violating an emergency protective order. He was sentenced to 125 years in prison with parole possible in 20 years.

Mrs. Delores Saulsberry, 48 (mother)

Delores Saulsberry lived in Lauderhill, Florida with her husband, Melvin L. Saulsberry, 50. Melvin Saulsberry started a home-based ministry called Boxing for Jesus Inc. in 1999. Mrs. Saulsberry filed four domestic violence cases starting in 2005 against her husband. Delores Saulsberry was stabbed 11 times, then her husband plunged the kitchen knife into her throat early Sunday, July 12, 2009, during an argument with her husband, Melvin L. Saulsberry, 50. She was stabbed in the neck. The couple was married 20 years. May 26, 2010 Mr. Saulsberry pleaded guilty to first-degree murder in exchange for the state's agreement not to pursue the death penalty. He thought his wife was having an affair and she disrespected him.

Mrs. Syble Stokes, 53 (mother of 2)

“It just didn’t make any sense to kill one person and leave another alive,”
Charles Cottingham, resident

Syble Stokes was found shot to death at her Centreville, Alabama home on September 20, 2005. Her husband said the couple was attacked in their home. They doused him with gasoline and knocked him out. When he woke he saw his wife shot. Earnest Stokes, a Bibb County pastor of Thomas Mill Baptist Church, was arrested seven months after the death of his wife. Everyone in town knew him. He officiated at wedding and funerals. The neighborhood was crushed. August 2008 Earnest Stokes pleaded guilty to manslaughter. Earnest Stokes pleaded guilty to manslaughter. No motive was found.

Mrs. Marla Tabb, (mother of 2)

Marla Tabb was married to a minister working in Texas for the First United Methodist Church. She was bludgeoned to death in the church parsonage August 5, 2002. Her husband, Rev. Mike Tabb, 41, was arrested August 14, 2002. Rev. Tabb told the police he found his wife’s body when he returned home from running an errand. Nothing was missing from the home.

There was no forced entry and no signs of a struggle. Mrs. Tabb sustained blunt force injuries to her head, including several wounds to her face and multiple breaks to her jaw. There was evidence of strangulation. The couple had a history of physical altercations. Marla Tabb was killed, just six weeks after she gave birth to her second child. She was beaten beyond recognition with a table leg. The trauma to Marla's face was so severe that her jaw was virtually shattered. Photos surfaced showing the minister in a topless bar, just five days after the murder of his wife. September 29, 2003 he pleaded guilty and was sentenced to 55 years in prison. Mr. Tabb will be eligible for parole in 27-1/2 years. He was a former Navy Chaplain.

Mrs. Janet Lorita Tillman, 40 (mother of 2)

Janet Lorita Tillman is another minister's wife who was murdered because she was in the way. Janet Tillman was a pastor's wife living with her husband, Pastor Timothy Dane Tillman, 45, and their two children in Birmingham, Alabama. She like many women did not know her husband was dissatisfied in their marriage. October 26, 2005 she died of a shotgun blast to the back. The prosecutor said Pastor Tillman was living a double life. He had a girlfriend then a mistress in another state. He married her right after Janet Tillman died. Defense attorney Erskine Mathis said, "They don't have any evidence at all that he murdered his wife." October 23, 2009 her husband, Timothy Dane Tillman, 45, was found guilty of her murder. He was sentenced to life in prison. He said he shot his wife by accident while carrying two shotguns into their home. The prosecutor said he was carrying on an affair and his wife was in the way. Pastor Tillman met a woman on line in 1999 and told her he was a Navy Seals officer. He visited her in the state of Washington while on church business. He introduced himself as Timothy McAnally. In 2005 he changed his name to Timothy McAnally without anyone knowing of the name change. Pastor Tillman also asked the woman to marry him while he was still married. Yes Janet Tillman had two insurance policies with her husband as beneficiary. The insurance policies were his to start a new life. District Attorney Alan Miller said, on October 20, six days before the shooting McAnally went to St. Clair County and had his name changed by to Tim Tillman, which is how he was listed as the beneficiary on two life insurance policies on his wife.

Mrs. Rosemary Todd Wynn, 53 (mother)

Rosemary Wynn lived in Raleigh, North Carolina. She was estranged from her husband, Pastor Sam Wynn, who was the pastor of the Hollands United Methodist Church. Mrs. Wynn was attacked in her home June 4, 2008. She was taken to an area hospital where she died. Her husband is a person of interest in her death.

Rev. Regina Kobak Drew, 40

Rev. Regina Drew of Westminster, Colorado was separated from her husband since December 1990. He had filed for divorce. She worked as an associate pastor of the Westminster United Methodist Church. After a Monday service her husband, who had been stalking her, shot pastor Regina Drew twice in the back and once in the chest while she was on the church lawn April 8, 1991. Murderer Status: Rev. Martin Drew, 51, committed suicide immediately after shooting his wife. Police said that Drew bought the .357 Magnum revolver used in the shootings at an Aurora shooting range March 16 and later took a class to learn how to use the weapon. "Marty and Regina would be here today if not for senseless gun laws that allow a person at a time of despair to take an action absolutely contrary to everything he believed in and dedicated himself to." Bishop Roy Sano said the deaths "should cause us to give renewed attention to the sale, possession and use of handguns."

Mrs. Rita Lynn Anderson, 31

Rita Anderson's husband, Harley Anderson, 35, used a .357-caliber Magnum pistol, to shoot her three times in the IXL Baptist Church parking lot in Oklahoma August 5, 1983. The pastor was coming down from the roof. The pastor was counseling the couple. Mr. Anderson was arrested

Mrs. Erica Bell, 24, (mother of 3)
Gloria Howard, 72,
Darlene Selvage Mills, 47,

Mr. Leonard Howard, 78;
Dolores McGrew, 68,
Pastor Claudia Brown, survived

"This man, for whatever reason, woke up this morning and decided he was going to go on a rampage." This guy does not realize what he's done - not only to a family, but to an entire community."
Police Chief Jeff LeDuff

A Louisiana prosecutor said in court that Mr. Anthony Bell, 23, walked into the 10 a.m. morning service at The Ministry of Jesus Christ Church May 21, 2006 shot five people (four died) and abducted his wife, Erica Bell, and three children all because she refused to come back to him. After leaving the church, Mr. Bell dropped off two of the children at a relative's house then drove to an apartment complex where he shot his wife to death. When apprehended he told authorities his wife shot her own family and then his wife shot herself. He told police that the reason his wife "went crazy" was because he admitted to her that he was having an affair. Anthony Bell, 23, is charged with first-degree murder of his wife, Erica, 24; his wife's second cousin, Darlene Selvage, 47; his wife's great aunt, Dolores McGrew, 68, and his wife's grandparents, Leonard Howard, 78, and Gloria Howard, 72. Mr. Bell is also charged with attempted first-degree murder in the wounding of Claudia Brown, 53, his mother-in-law and the pastor. All of the family members except Brown and Erica Bell were found dead inside The Ministry of Jesus Christ Church. He is also charged with one count of second-degree kidnapping. His children were unharmed.

Erica Bell filed for a temporary restraining order against Anthony Bell on December 16, 2005, citing family violence. On Jan. 3, 2006 the restraining order was dismissed at Erica Bell's request. Anthony Bell has been convicted twice on charges related to domestic violence. Mr. Bell put up no resistance when apprehended. He wanted to live.

Apparently, Mr. Bell's attorney realizes he cannot save his client from being convicted but he can save his client's life since the prosecutor is asking for the death penalty. His attorney asked that Mr. Bell be declared mentally retarded then Mr. Bell will be ineligible for the death penalty if a jury finds he is mentally retarded. The U.S. Supreme Court has barred the execution of people with this condition. The reasoning behind the Supreme Court's ruling is the court will allow the execution of people who don't comprehend the actions that are being taken against them. During a pretrial hearing January 19, 2007 the court was told a psychologist hired by the state found Anthony Bell's IQ is 50 - about 20 points below the recognized threshold for mental retardation in Louisiana. Under Louisiana law it is up to the jury to make the final determination. IQ is one of several factors a jury can consider when deciding a defendant's mental capacities. The benchmark IQ of 70 is generally used by courts in determining if a person is mentally retarded; however, in Louisiana, where the jury makes that determination, jurors can also consider a person's work history and ability to function in everyday life. LSU law Professor Paul Baier said, Should the jury convict Bell and recommend a death sentence "serious constitutional issues" could be raised on appeal that ultimately could halt an execution. "If you have a person with a seriously low IQ, that would create serious constitutional difficulties in light of Atkins versus Virginia." The reasoning behind the Supreme Court's ruling is the court has not allowed

the execution of people who don't comprehend the actions that are being taken against them. Jeffery Howard lost his mother, father, aunt, niece and first cousin in the shootings.

Mrs. Crystal Dawn Hamilton, 30,
Moscow Police Officer Lee Newbill

Paul Bauer, 62,

Before he killed himself in an area church Mr. Jason K. Hamilton, 36, of Moscow, Idaho told a psychiatrist February 2007 if he committed suicide, he would try to take a large number of people with him. May 2007 he tried to keep his word. After drinking in a local bar with a friend he returned home and shot his wife, Crystal Hamilton, in the head. He equipped himself with two semiautomatic rifles and walked to the courthouse where he fired 125 rounds. Crystal Hamilton was a janitor at the courthouse. He killed Officer Lee C. Newbill, a Moscow policeman, who first responded to the scene. Two other officers were shot but not fatally wounded. Mr. Hamilton entered the First Presbyterian Church, directly across the street from the courthouse and shot Sexton Paul Bauer. He shot 80 rounds in the church then killed himself Jason Hamilton had a history of violence. Authorities charged Mr. Hamilton with felony strangulation in January 2006 in a case involving a girlfriend he had while separated from his wife. Hamilton was convicted of misdemeanor domestic battery of the girlfriend, who survived, and was sentenced to 180 days in jail, with 90 days suspended. A psychiatric evaluation was ordered. A week before the shooting a judge decided against returning Mr. Hamilton to jail and gave him one more month to see a counselor.

Mrs. Reshma James, 24
Dennis John Mal-loosseril, 25

Reshma James lived in Sacramento, California with her husband, Joseph Mathai Pallipurath, 27. When they became estranged Mrs. James moved to New Jersey. She became increasingly afraid of her husband. Her husband followed her to New Jersey and began to stalk her and record her habits. Finally on Sunday December 7, 2008 he struck he entered St. Thomas Syrian Orthodox Knanaya Church his wife attended and tried to compel her to leave. When his wife refused he shot Resham James and Dennis John Mal-loosseril, 25, a church member to death. He shot a third person paralyzing the individual.

Mrs. Tanya McCall, 40

Tanya McCall lived in Oakland California. She worked for the California Automobile Association in Berkeley and she also sold real estate. She filed for a divorce in 2008. Her husband answered her request by shooting her to death. She obtained a temporary restraining order against him just three days before the shooting. Tanya McCall wrote in her application for the restraining order that she was in "abject fear for my physical safety and my life" and that the abuse began when they were teenagers. January 15, 2009 Mrs. McCall's husband, Matthew McCall, 43, pleaded guilty to first-degree murder and being a felon in possession of a gun in an Oakland California courtroom that he murdered his wife, Tanya McCall. Again we have another husband following the same old pattern, denial to family and friends until the day of trial then a guilty plea. He finally told the court that he shot his wife to death March 11, 2007 in the Acts Full Gospel Church parking lot as she walked to church. He will be sentenced to 35 years to life. He will be eligible for parole in 32 years. The original charge carried special circumstances making Mr. McCall eligible for the death penalty. The prosecutor said Mr. McCall was lying in wait for his wife. Witnesses said Matthew McCall jumped out and shot his wife twice as she fell he stood over her and shot her twice more. Tanya McCall was holding a Bible. He killed a man in 1985 in Richmond. Matthew McCall pleaded not guilty in court the day Mrs. McCall was

being buried. Mr. Matthew McCall, 43, was a stupid man. He refused to negotiate. He refused to work with his wife to divide the family assets so each could get on with their lives. Family and friends say the couple had grown apart. They owned six houses. Tanya McCall agreed to give him three of the houses. He refused. Sunday March 11, 2007 Mr. Matthew McCall drove to the Acts Full Gospel Church in California and shot his wife to death in front of 100 parishioners attending the am service. He must have felt triumphant killing his wife in front of people who respected her. Tanya McCall worked two jobs developing the family fortune. She worked as a real estate agent and an administrator of the California State Automobile Association. Her family said that for many years she supported her husband and hid the abuse she suffered at his hand. Well as of January 16, 2009 Mr. Matthew McCall will not be abusing anyone else. He was found guilty of first-degree murder and being a felon in possession of a gun. He pleaded to these charges to avoid the death penalty. He will not be eligible for parole until he is 75 years old. He murdered his wife but he also destroyed himself.

Mrs. Dorothy Gracia Nieto, 42 (mother of 3) see Mrs. Denise Balla, 46 (mother)

Dorothy Nieto of Harlingen, Texas was stabbed in her car July 20, 2002 by her husband, Manuel Ramirez Nieto, 39. She had separated from Manuel, but agreed to meet him in a church parking lot. During the conversation Manuel Nieto became violent and stabbed Dorothy Nieto 16 times in the chest and back. He then drove his wife to the emergency room, where she died. He was charged in her death. Notice he came armed with the knife. This is why we say never trust a man after you leave him. Many of the women killed in this section were murdered by men carrying concealed weapons.

Mrs. Sarah Roth, 36

The death of Sarah Roth is the best example we can give why a rejected man cannot be trusted under any circumstances. She is one of a hundred women killed in church, outside of church or in the presence of a clergyman. Sarah Roth had rejected her husband. She wanted a divorce and decided to leave her husband. Her husband, Moses Roth, 50, asked her to go with him to Rabbi Nathan Aronson's home in Brooklyn, New York to discuss their differences. He wanted reconciliation. Notice the phrase he wanted reconciliation. After Sarah Roth and her husband arrived at the Rabbi's home and had their discussion Mrs. Roth said she still wanted a divorce. Mr. Roth pulled out a gun and shot his wife in the head. He then shot himself. Mr. Roth walked into Rabbi Aronson's home concealing a weapon. He brought the gun just in case he lost the first argument. The second argument he did not plan to lose. The second argument was Mrs. Sarah Roth should die for her behavior. Once a man is rejected he is now dangerous. He becomes the most dangerous person on the planet. He will kill in front of his mother, his children, his pastor in the court house on the street in front of the police. He will not care where he kills you as long as he kills you. His only objective is to kill because he lost the argument. He did not get his way.



The second set of murders almost completely ignored is murders committed by police officers against women. Yes police officers murder their wives, their girlfriends and pedestrians. It is not unheard for a police officer to rape and murder a pedestrian, a lady of the night or to kill his wife or girlfriend when they are not obedient. For years women groups have accused police department for covering up these crimes. Below are cases for

He Who Must Be Obeyed

Nationally, about 2.5 million women are battered each year, two-thirds by their partners or other people they know. What is hidden in these figures are the professions of the batterers. Many of the batterers are police officers. Yes the man who is standing before you writing you a traffic ticket is a batterer. No profession or occupation that precludes a man from being a batterer.

In Volume Three we tried to impress upon women that any man can kill. We repeated the phrase over and over again. All men are capable of murder no one is excluded by sex, profession, size or color of skin. All men are capable of murder when driven by the desire for satisfaction, revenge or greed. Below we discuss those women murdered by men wearing the uniform of a police officer these are some of the most danger killers of all. Why! They are the most dangerous killers of all because police officers are the last to be suspected, the murder case of the woman is investigated by fellow officers and most of all these men have the skills to conceal the murder for years to avoid prosecution. The two most disturbing statistics regarding police officers are the number of complaints by the victim or family members that the police departments fail to follow up on violence complaints and the large number of suicides in this group of assailants. A recent study revealed that New York City officers kill themselves at a rate of 29 per 100,000 a year. The rate of suicide in the general population is 12 per 100,000. Most of the victims are young males with no record of misconduct who shoot themselves while off duty. Nationally, twice as many cops - about 300 annually - commit suicide as are killed in the line of duty, according to a study by the National Association of Police Chiefs. When Mrs. Crystal Brame was murdered in Washington Pastor Mark Toone, the pastor officiating at Crystal Brame's funeral, 2003, said, "I suspect there are people here who are locked in a destructive relationship.' . . . 'Let this casket be a wake-up call.'" Let the many caskets already lowered all across the country be a wake-up call to us all: officer-involved domestic violence is intolerable." Mrs. Brame was married to Tacoma Police Chief David Brame. Chief Brame killed his wife and shot himself to death. He had abused his wife for years. Chief Brame verbally abused his wife, by telling her she was "fat and . . . ugly" and "no man would ever want her." He threatened her life, "put a loaded gun to her head," and even tried to choke her several times, but each time he sent flowers afterward. When she eventually left him, he killed her. When Chief Brame's violence was reported it was dismissed by the city manager. He was even supported by the police union. Where or to whom could she go to for help, no one? Mrs. Crystal Brame was left alone to fight an abuser by herself. She died doing just that.

Mrs. Arlene Adams, 33

March 1, 1995 George Adams, 64, a retired Miami police officer shot and killed his wife and then himself. The bodies of George Adams, 64, and his wife, Arlene, 33, were found in their home in Florida. Police checked the Adamses' house after a report that one of the residents had not shown up for work. Two weeks earlier George Adams was one of several pioneer black police officers honored by Chief Donald Warshaw during the department's observance of Black History Month. He worked on the force 33 years.

Mrs. Yolanda Evetta Anderson, 31 (mother of 4)

Yolanda Anderson of Seminole County Florida was a 31-year-old mother of four, was an honor student in her final term at SCC, studying criminal justice technology. She died January 27, 2003. Anderson was found dead in January in a murder-suicide. Police said they think her ex-husband, Richard Anderson Jr., a Seminole County deputy sheriff, killed her and then himself while their children slept in another part of her home. Richard Anderson Jr. pinned Yolanda Evetta Anderson to the bed and then shot her once in the head. Police had been called to the house for domestic disturbances at least two times since the divorce was final. She filed for divorce August 12, 2002, and it was finalized a month later. She stayed in the family home.

Mrs. Laurie Barnicoat, 40 (mother of 2)

November 6, 2003 seven men and five women in Florida found former police officer Ronald Barnicoat, 43, guilty of premeditated first-degree murder in the death of his ex-wife, Laurie Barnicoat in Florida. The jury convicted him of this charge knowing he will be sentenced to life in prison without parole. He shall die in prison. Officer Barnicoat took it upon himself to determine the day his ex-wife should die. After their divorce in June 2002 Laurie Barnicoat wrote the judge and asked that her husband be ordered to stay away from her and her two daughters. Either a protection order was not granted or Officer Barnicoat decided not to honor the order because, he shot Mrs. Barnicoat to death April 7, 2008 in front of several young children as she dropped her child off at day care. There was an extensive history of abuse. The defense presented the murder as a crime of rage not premeditation therefore Mr. Barnicoat should only be sentenced to 20 years in prison for the crime of second-degree murder. This is Mr. Barnicoat explanation of the murder. As you read the explanation ask yourself why did he have a gun? Mr. Barnicoat said he drove to the daycare center to ask his ex-wife about a photo her cousin had taken of his van. He said he did not go there to kill her. He said, "I just went berserk. Something snapped. I went into some kind of rage. I don't remember a lot after that." What precipitated the rage? Was his rage due to the fact his wife no longer had to do what he told her to do? If he did not go to the daycare center to kill his wife why did he have a gun? Did he go back to his van to get the gun? The jury believed Mr. Barnicoat knew exactly what he was doing because he followed Laurie Barnicoat until he fired two shots into her body. May he rot in hell! Mrs. Laurie Barnicoat was murdered in front of her cousin, child, and several other children. There were people all around the scene going about their business. Laurie Barnicoat stayed married to her husband for 22 years. Not all of these years were abuse free. The protection order was lifted when Mr. Barnicoat said he was going to move to Oregon. Please note Mr. Barnicoat knew where to find his wife. Once your leave you must change all of your habits including the people you know. Men know the best places to catch their wives is the babysitters, and work.

Mrs. Carol Ann Carlen, 46

The body of Carol Ann Carlen, 46, was found April 14, 1992 in the trunk of her car parked in an industrial neighborhood in Oakland, California. The word "WAR" had been spray-painted along the driver's side. Her husband, Patrolman Keith Carlen, had filed a missing person report. Carol Ann Carlen was strangled to death. April 16, 1992 Keith Carlen, a 22-year police veteran, was arrested and confessed that he killed his wife. Mr. Carlen told homicide investigators he made the decision to kill his wife as he drove his truck home from work that day. Keith Carlen purchased a wig and mustache two weeks ago, and he wore them as a disguise when he ditched his wife's body. December 15, 1994 ex-officer Carlen was convicted of first-degree murder for strangling his wife two years ago and trying to make the slaying look like a gang killing. The couple was married 17 years.

Mrs. Sylvia Caballero

Sylvia Caballero lived in Houston, Texas. She was married to Jesse Sam Caballero, 45, who was a police officer with the Houston Community College system. Based on physical evidence Mr. Caballero was charged with the August 26, 2005 shooting death of his wife. Mrs. Caballero was shot three times in the head in her drive way. Her neighbor was state trooper who immediately investigated. Mr. Caballero was convicted of murder and sentenced to 45 years in prison. His appeal was denied. Prosecutors introduce during trial that Mr. Caballero was having an affair. He and his wife were married 16 years.

Mrs. Elena Cole, 46 (mother)

New York City police lieutenant Francis Cole, 48, stabbed his wife, Elena, with a kitchen knife then shot her to death in the bedroom of their home January 12, 2009 during an argument. A child at the scene tried to intervene. Officer Cole used his service revolver to commit suicide. Francis Cole joined the New York Police Department in 1990.

Mrs. Marie Teresa Davis, 33

Marie Davis lived in Houston, Texas. She was estranged from her husband, a Houston police officer. March 20, 1987 her body was found in a late model Oldsmobile in Pine Walk Trail. She was stabbed in the chest and shot in the head. Arturo Tenorio, 34, was charged with murder. He was charged with killing, Marie Davis, his ex-girlfriend during an argument. He fled to Mexico before he could be formally charged.

Mrs. Yu Dejarnette, 56

Yu Dejarnette of Kealahou, Hawaii was found November 12, 2006 on the side of an embankment near her home in the Hawaiian Ocean View Estates subdivision. She suffered severe head injuries and was pronounced dead at the Hilo Medical Center. Her husband, Daniel Dejarnette, 53, was in custody at the Kona police cellblock. He was a retired police officer. We do not see a conviction.

Mrs. Lori DeKleine (mother of 2)

Ken DeKleine, a Holland, Michigan police officer, murdered his wife January 2008 because he wanted custody of his children. Ken DeKleine allegedly hid in the attic until the kids left for school, then **strangled** their mother. The police said Mr. DeKleine confessed to the murder, saying that he'd first thought of killing Lori after she filed a personal protection order against him

in January 2007. He was finally convicted in 75 minutes and sentenced to life in prison. Ken DeKleine's fellow police officers said they never imagined he would resort to violence, even though many knew about his marital strife. Lori DeKleine had a personal protection order against her husband.

Mrs. Carli Ann Dennis, 30

Carli Ann Dennis told her supervisor August 2005 that her police officer husband, Dallas Township police officer Jeff Dennis, 35, threatened to shoot her and make it appear as a suicide. Six months later Carli Dennis was dead. Prosecutors allege Officer Jeff Dennis, 35, fatally shot his 30-year-old wife February 27, 2006 in her sleep in retaliation for an affair with Robert Bomboy, a co-worker at 911. Mr. Dennis said Carli Dennis shot herself. After two hours of deliberation he was convicted and sentenced to life in prison.

Mrs. Janet Dow, 40
Steven Dow, 17

"It is my contention that the true nature of Janet and Steven's death was covered up by the officials who were involved with this incident."
Karen Saffren, his girlfriend.

Janet Dow of Maine and her son, Steven, were killed in an auto accident in 1982. In 2000 family member said ex Trooper Richard Dow staged the accident so he could collect on her government benefits. A lawsuit was filed against Richard Dow; collecting the benefits amounts to fraud because Dow lied on federal forms about how his wife died. Janet, 40, and Steven, 17, were found in a burned-out car wreck near the family's Thornton home in December 10, 1982. No autopsies were performed and investigators accepted Dow's explanation that his wife had sped away from the home and crashed, igniting an open container of gasoline her son had placed in the car. In 1993 his girlfriend told the police Mr. Dow told her he killed his son and staged the accident. At first, state police quickly concluded that Janet Dow, 40, and her son, Steven, 18, burned to death when their car careened off the road near their home in a small northern New Hampshire town and exploded into flames on December 10, 1982. An electrical short-circuit was suspected of igniting gasoline spilling from a bucket that held the carburetor to Steven's car. But the bodies, the best evidence, were cremated three days after the deaths. No autopsies were performed. The car was destroyed shortly afterward.

Mrs. Tamera Egbert, 41 (mother of 2)

The body of Tami Egbert of Chico, California was found eight days after she was reported missing February 11, 2000. She was shot to death February 9, 2000. At the time of her death a witness said she was shot twice not once. A second review of her autopsy in 2007 determined she was shot twice. Her husband, Clinton Ray Egbert, a Butte County sheriff's deputy was arrested and charged with murder February 2007. The prosecutor alleged Egbert had a history of domestic violence against Tami Egbert and his two ex-wives. Neighbors hear gun fire the night she disappeared. Clinton Ray Egbert was convicted of the second degree murder of his wife, Tamara, and sentenced to prison for a term of 15 years to life.

Mrs. Rita Fioretti, 35 (mother)

The murder case of Rita Fioretti of New York was a long drawn out case. When the case was finished no one was ever prosecuted for her murder. A man took \$17,000 from his wife's

checking account. He needed his wife's money to start a new life with his lover. He did not legally have a right to empty his wife's bank account because he was not her beneficiary. He was committing adultery. He divorced his wife in 1974 when they were estranged but she did not know she was divorced. He was still living at home with access to her money and sex when he felt like it. His wife had been missing since August 1986 but he did not report her missing. He said she was an alcoholic and had psychiatric problems. She had a boyfriend and had left home before. The man who supposedly did all of the above was a New York police officer. He married his mistress after he emptied the bank account. Rita Fioretti's disappearance can to the DA's attention when her employer, International Paper Corp. reported her missing. Her absence was not like her. She was an exemplary employee. Bronx District Attorney Mario Merola said he began an investigation because of the extremely unusual event surround Mrs. Fioretti's disappearance. Before Mrs. Fioretti disappeared her husband, was living in Franklin Square with his pregnant patrol car partner, Maureen Brooks. A few weeks after she vanished, he moved into the City Island house that Rita Fioretti and the couple's two sons had lived in until her disappearance. Brooks and her two daughters moved in with him. Fioretti and Brooks married a month after Rita Fioretti disappeared, with Fioretti producing papers showing he secretly divorced his first wife in 1974 - although he'd lived with her until 1985. Robert Fioretti , 36, was fired from the 113th Precinct in Queens in 1987. He was convicted in January 1992 of federal bank fraud for illegally (convicted of forging his missing wife's signature) withdrawing \$17,000 from Rita Fioretti's Elmont bank account two months after she vanished. He was sentenced to 10 years in prison. In March 1992 Mr. Fioretti admitted in Bronx criminal court that he had raped his then 12-year-old stepdaughter in 1989 and sexually assaulted his then 13-year-old stepdaughter in 1988 and 1989. September 16, 1992 Robert Fioretti, 42, was sentenced to 5 to 15 years for first-degree rape and 2 to 6 years for first-degree sexual abuse. The children abused belong to the woman he married after Rita Fioretti disappeared.

Rita and Robert Fioretti married. In 1974 the couple was estranged. They filed for a divorce. While waiting for the divorce the couple reconciles. They purchase a house because they have two children. Unknown to Rita Fioretti her divorce was granted and her husband picked up the papers without telling her. They had their second child in 1983. So for 12 years she lived with Robert Fioretti thinking she was married. In 1985 he gets his partner, patrolwoman Maureen Brooks pregnant. She already has two children. He moves in with her. His wife consulted a divorce attorney May 1985 telling him she wants to file for a divorce. The attorney does his research and tells her she is already divorced. It is now August 1986. Police speculate Rita Fioretti confronts Robert Fioretti regarding his deceit. He kills her and disposes of the body. Remember Mrs. Rita Fioretti worked at the paper company for years. She amassed a small fortune. Why leave this money in the bank? He withdraws Rita Fioretti's \$17,000.00 from the bank and moves in with mistress. They marry. Now his mistress has authority over Rita Fioretti's children. Mr. Fioretti is fired then charged with bank fraud. He is convicted and sentenced to 10 year. He is then charged with rape. He is convicted and receives a second sentence. He is never charged with the murder of Rita Fioretti. What happened to Rita Fioretti is the reason why the Institute advocates all women should snoop listen and pry and be forever vigilant.

Mrs. Susan Fitch, 32

Susan Fitch of Kentucky died after being thrown from the hood of her husband's moving car in 1986. Mrs. Fitch died of massive head injuries. Police detective Joe Fitch, 36, pleaded guilty to manslaughter. He was sentenced to 5 years probation. Fayette Circuit Judge George Barke saw nothing wrong with the sentence.

Mrs. Janice Foote, 33

Janice Foote lived in Miamisburg, Ohio. She was shot to death in her home May 1, 1990. Her husband, Nicky R. Fooote, 39, turned the gun on himself. He had held the police at bay for about 12 hours before killing himself. Neighbors told police that there had been a loud argument and two shots had been fired. Nicky R. Foote was a Miami Township police officer.

Mrs. Elizabeth Harton, 27 (mother of 4)

August 1, 2002 Elizabeth Harton was found dead in her Columbus, Ohio home. Her husband, Hermando Harton, called his ex-wife in California and told her he shot his wife to death. She in turn called the Ohio police. Mr. Harton took the police on a mad chase where he was shot and paralyzed. February 2003 Hermando Harton pleaded guilty in a plea agreement with Franklin County Prosecutor Ron O'Brien. He killed his wife two weeks after being fired from the Columbus police department.

Mrs. Evelyn Henriquez, 30 (mother)

Mrs. Henriquez disappeared on August 13, 1993. She was last seen at her apartment. She was married to New York police Detective Victor Henriquez. So far we have reported on three missing wives of New York police officers.

Mrs. Rosa Maria Hernandez

San Juan Officer Jose Hernandez of Texas was not married a year before he shot his wife, Rosa Maria to death October 6, 2009. There was a history of abuse before the couple married. Officer Jose Hernandez committed suicide at the scene. The shooting occurred around 11:30am.

Mrs. Sharon N. Hogan, 47

Sharon N. Hogan of Utah was shot September 2, 2002 during a domestic dispute at the house she shared with husband, ex-Utah Highway Patrol trooper Larry Dale Hogan, 55. Police believe Larry Hogan then turned the gun on himself. Police cited Larry Hogan for domestic violence just hours before the shootings. Sharon N. Hogan was shot just before 6 a.m. **Sharon Hogan** was found on the front lawn, bleeding profusely from multiple gunshot wounds. Larry Dale Hogan, 55, and his wife, Sharon, 47, had a neighborhood barbecue. At 2 a.m., about 45 minutes after the barbecue ended, Sharon called police, saying her husband was "trying to beat her up" and that she needed help. The police arrived and took him to a restaurant. He stayed for a while then asked to go home. Shortly after arriving at home Larry Hogan shot his wife. The shooting happened just hours after South Jordan police cited Larry Hogan for domestic violence. Officers removed him from the home about 2 a.m., but he was allowed to return. They did not think the violence would continue.

Mrs. Bonnie Horinek, 35

Bonnie Horinek was an attorney practicing in Fort Worth, Texas. She was shot to death in her bed March 14, 1995. Her husband, a police officer, called 911 stating his wife had committed suicide. He was not believed. He was tried and convicted and sentenced to 30 years in prison. He had threatened his wife on several occasions. Mr. Horinek was an alcoholic. Information regarding Texas domestic violence. * In Texas, an estimated 824,790 women - or 11.4 percent

of female adults in the state - were physically abused in 1998, according to Texas Department of Human Services estimates. In Nueces County, 13,114 women were physically abused that year, according to the DPS. * From 1995 to 1998, 458 Texas women were killed by intimate male partners, according to the Texas Department of Public Safety. * Eight of those women - wives, ex-wives or girlfriends - were killed in Corpus Christi, according to the DPS and the Corpus Christi Police Department. The CCPD began tracking domestic violence-related homicides with the formation of a special domestic violence unit last September. There were several red flags, alcoholism, sporadic employment, threats, and angry outbursts. Rather than just leaving Mrs. Horinek told friends she was going to leave her husband and she packed her bags. She should have just left.

Mrs. Lillian Mae Johnson, 53 (mother)

Mrs. Lillian Mae Johnson was shot to death October 2002 in her home in South Carolina. An autopsy showed Ms. Johnson had been shot four times: once in the head, twice in the upper chest and once in the back. Her husband, Walter Lewis Johnson, was a former Westminster police lieutenant. Walter Lewis Johnson, 58, committed suicide at the scene. In 2000 he was arrested for domestic violence. He put his wife out of the house in the cold and pointed a gun at her. He received a 1 year suspended sentence and 100 hours of community service for resisting arrest. Look at the sentence the charge was not taken seriously. No counseling was ordered. Just go home and don't do it again. 30 percent of the 881 homicides in South Carolina between 1998 and 2000 were domestic violence cases.

Officer Selena Johnson, 35 (mother of 2)

Officer Selena Johnson worked as a Grand Crossing District officer in Chicago, Illinois. Officer Johnson was shot to death in her home September 1988 around 3 o'clock in the morning. Her husband broke into the house. She filed for a divorce June 1988. She received two protection orders. She made several complaints to her husband's commanders. Her husband, Patrolman Edward Johnson, committed suicide while talking to his commanding officer. The couple was married 15 years. Allegedly, he abused alcohol. He was openly abusive. He belittled her in public and often threatened to kill her. Officer Johnson asked for a protection order June 29, 1988 based on an argument the couple had May 30, 1988 where he threatened to shoot her. Fellow officers said after the couple separated Officer Selena Johnson was dating a sergeant in her precinct. Edward Johnson shot his wife after she went on a three day week end trip with a sergeant in her precinct.

Mrs. Leta Kay Kiesz, 44 (mother of 2) second wife

December 1, 2003 the body of Leta Kiesz was found in her Jeep Cherokee in the parking lot of the Lake Meridian Marketplace in Kent, Washington. She was shot to death. Her divorce was almost final when she agreed to meet her estranged husband at a restaurant to discuss events. Friends had heard him make threats to kill his wife. By the time her body was found her husband, Douglas Kiesz, had presented himself to the police and given himself a psych defense. He was said to be terminally ill. July 2, 2004 Mr. Kiesz, 60, a former Seattle police officer, pleaded guilty to murder. He was sentenced to 18 years.

Mrs. Sandra Kipp, 35 (mother) second wife
Sgt. Jeffrey Alan Klein, 35

Roy Kipp, 43, a retired Collier County sheriff's lieutenant, was arrested May 20, 2000 in less than two hours on charges that he shot his estranged wife, Sandra Kipp, 35, and the sergeant,

Jeffrey Klein, 35. The Kipps were separated. Sgt. Jeffrey Klein was a member of the Collier County Sheriff's office in Naples, Florida. In 2002 the jury took 2.5 hours to find Royle J. Kipp guilty of two counts of first-degree murder. The prosecutor asked for the death penalty.

Mrs. Janet Kovacich, 27 (mother of 2)

Janet Kovacich lived in Placer County. Janet Kovacich disappeared September 8, 1982 from her home in Auburn, California just a week before her 28th birthday. Family said she would never leave her children ages 5, and 7. A judge ruled that Janet Kovacich died the day of her disappearance. A partial skull with a possible bullet hole in was found October 2, 1995 along the shoreline of Rollins Lake. The skull was nearly buried in dry silt near a boat ramp that is normally under water. In 2006 DNA testing was performed on the skull indicating the skull belonged to Mrs. Kovacich. DNA taken from the skull was compared to that of Janet Kovacich's late mother and of her two children. DNA technology determined there was "a near statistical certainty" that the skull found in 1995 belonged to Janet Kovacich. Friday Her husband, Paul R. Kovacich Jr., 58, a former Placer County sheriff's sergeant, was charged with murder September 7, 2006, after evidence was heard before a grand jury. Friday, April 24, 2009 her husband, Paul Kovacich Jr., 59, a former Placer County California sheriff's sergeant, was arrested for her 27 year old murder. Janet Kovacich was reported missing September 8, 1982 just before her 28th birthday. The defense is disputed the bullet hole. Special circumstances allegations, kidnapping and use of a firearm, could subject the defendant to the death penalty. The prosecutor said, Janet Kovacich was preparing to end the couple's rocky marriage and confronted her husband about divorce on the morning she vanished. Prosecutor Daniel Gong suggests Paul Kovacich offered to drive his wife to an appointment at a school where she wanted her children enrolled. "She got into the Ford Bronco with the defendant, believing he would drive her to her appointment. "The defendant drove Janet to Rollins Lake against her will and killed her there." Former police Sgt. Kovacich was found guilty of murder January 2009 and sentenced to 27 years to life in prison. Janet Kovacich wrote in her dairy about how her husband controlled her and her unhappiness and their counseling sessions. Weeks before Janet's Kovacich's disappearance, she had been inquiring about **divorce attorneys** and taking steps to gain independence. She had enrolled in classes at Sierra College. A week before she disappeared, she underwent breast augmentation surgery to improve her looks.

Mrs. Kristin Palumbo-Longo, 29 (mother of 4)

Palumbo Longo was stabbed to death in her Deerfield, New York home September 28, 2009. Her husband, Joseph Longo, a Utica, New York police officer, committed suicide on the scene. She was estranged from her husband and had asked for a divorce. He and his wife just attended a divorce hearing. Officer Longo was angry. Her husband learned he would have to pay \$1,800.00 in child support. Police Investigator Joseph Longo Jr. was committing adultery. He was dating one of his coworker's. He needed his salary to start a new life with his mistress. This is why we say once a man begins to commit adultery your life and the lives of your children are in danger. Mr. Longo Jr. kept his promise he murdered his wife and himself. He had threatened murder suicide twice before. Mrs. Longo's family filed suit against the department stating the department should have known about his state of mind. He had pointed his service revolver in his mouth in front of his wife and child and showed signs that he was inclined to hurt himself and demonstrated signs of a mental breakdown.

Mrs. Virginia Lozano, 36 (mother)

She was in the way

Mrs. Lozano of Texas married when she was 20 years old. She died when she was 36. The prosecutor said the day Mrs. Lozano died her husband shot her to death with his service revolver. Texas prosecutor said he believed detective Robert Lozano, 44, murdered his wife, Viki, with his service pistol on July 6, 2002 and later married another woman. The defense said the death of Viki Lozano was a suicide. The prosecution felt so strongly that Virginia Lozano did not commit suicide July 6, 2002 that they brought charges against Detective Robert Lozano, 37. When Robert Lozano was tried in July 2009 the prosecution called him a liar over and over again. Prosecutor Susan Piel said Mr. Lozano lied about crying out to his dead wife not to leave him. That was not heard on the 911 tape. Piel also said he lied about Viki Lozano being ill after the baby was born and him having to care for the baby for months, and he lied about performing CPR. Bobby Lozano's explanation that he had started cleaning his gun and then decided to wait to finish until he returned from a tanning salon was a cover-up to hide the time of his wife's death. "I need to stop and leave all this stuff on the bed because I had an emergency tanning session, because I have not tanned since yesterday. "He had just shot his wife, and he needed an alibi." The jury did not believe the defense attorney and brought back a verdict of guilty. The jury found him guilty in five hours.

Mrs. Karen Ludwig, 38

Karen Ludwig was shot to death in her home in Ashburn, Virginia during an argument July 4, 2005 with her husband, John W. Ludwig, 51, a U.S. Marshals Service detective. He was charged with first degree murder but convicted of voluntary manslaughter. He said he killed his wife in self-defense. July 2006 he was sentenced to six and a half years in prison. That is what Karen Ludwig's life was worth.

Mrs. Jennifer Barrett McCrady, 30 (mother of 2)

Jennifer McCrady lived in Belpre, Ohio. She was married to Jack McCrady, an Ohio State Police officer. She was reported September 19, 1996 missing by her husband. Actually, she was buried on a hillside several miles from her home. When her body was found, she was dressed in her pajamas. He said he last saw her that morning when he left for work he noticed nothing unusual about her behavior. But she never showed up to work that day. Jack believed she was having an affair. It appears that she left him with the children. She left her wedding band on the kitchen counter, luggage missing, and photos were missing. A few days later someone reported a car abandon in a parking lot. The car turned out to belong to Jennifer McCrady. Friends were concerned that something bad had happened she as dedicated to her children they were her life, no one would believe she would walk out on her children and no one believed she was having an affair. She was talking about divorcing her possessive and jealous husband. A witness said she saw a police vehicle driving in a remote area outside of town detective drove there. They found a dirt mound and the body of Jennifer McCrady wrapped inside sleeping bag. She was wearing pajamas. Officer McCrady was fired after his arrested. He was convicted and sentenced to 15 years to life. He is eligible for parole in 2014,

Mrs. Yvonne Mattheson, 43

Mrs. Mathison lived in Hawaii. She was married to Hilo patrol Sgt. Kenneth Mathison. Mrs. Mathison was murdered in 1992. Her husband said he accidently ran over her with the family van. Her husband was not convicted until 1995. He was sentenced to life in prison. Like Wisconsin Hawaii does not have the sentence life in prison without parole. The police department was accused of a cover up.

Mrs. Martha Jeanette Page Miller, 33 (mother)

Byron Keith Miller, 40, a Hattiesburg, Mississippi police officer shot his wife, Martha Miller, to death in their home October 30, 1999 then committed suicide. There was no indication that the couple had been having domestic problems. The couple's son was not at home at the time of the shooting. Later a court ruled against Martha Miller's mother stating her estate could not inherit from Byron Miller. Slayer statute silent on whether or not a victim can inherit from the assailant.

Mrs. Kimberly Mount, 35 (mother of 2)
Officer Jose Gomez, 34

Mrs. Selena Gomez

Officer Michael Mount of Eustis, Florida received a divorce request from his wife, Kimberly. The couple had only been married for six months. Mrs. Mount said her husband was extremely jealous and she was afraid of him. She sought refuge at the home of Officer Gomez and his wife, Selena, were friends. February 5, 2006: Officer Jose Gomez, 34, of Eustis, Florida, was shot to death by a fellow officer looking for his wife. Officer Mount broke into the home. Officer Gomez was trying to protect the estranged wife. Also murdered was Officer Gomez' wife, Selena Gomez, 29, and the fellow officer's wife, Kimberly Mount, 35. Officer Mount had accused Officer Gomez of dating his wife. Cpl. Michael Mount committed suicide.

Mrs. Deborah Nieves, 39 (mother of 4)

November 13, 2007 New York Hudson Valley police found a man and woman lying on the kitchen floor. Town of Highlands police say the woman, 39-year-old Deborah Nieves, had multiple gunshot wounds and the man, 37-year-old Wilfredo Nieves Jr., had a single fatal bullet wound to the head. Deborah Nieves called 911 before being shot by her husband, who was a police officer with the Port Authority of New York and New Jersey. The couple did not have a serious history of domestic disputes with the town police. A police officer shot his wife to death during an argument and then turned the gun on himself.

Mrs. Cathalene Pacheco, 43 (mother of 4)

"Domestic abuse is "the most under-reported crime in America."

The last words spoken by Mrs. Pacheco were "Albert think of the kids." The reason why we know these were her last words is because Mrs. Pacheco was on the phone with one of her children when she was attacked. Cathalene Pacheco had left her husband and moved in with a friend down the street but she did not stop being a mother. She would see after her children each day. January 4, 2002 her husband, Kona police detective Albert Pacheco, asked her to babysit the children so he could go out for the night. As Mrs. Pacheco drove to his home he rammed her van then shot her multiple times. Remember we said men are trained in warfare. Mr. Pacheco set up the ambush so it worked perfectly. Mrs. Pacheco was not expecting an attack. She was going to fulfill her responsibility as a parent. August 17, 2004 Kona police detective Albert Pacheco has been sentenced to life in prison plus 20 years for "ambushing" his wife. Big Island Circuit Court Judge Greg Nakamura imposed a consecutive sentence of up to 20 years on Albert Pacheco, 48, for the separate offense of using a firearm in the commission of a felony. Mr. Pacheco must serve that 20-year term after he serves his murder sentence.

Mrs. Theresa Parker (mother)

Theresa Parker worked as a police dispatcher for the Walke County police department. She and her husband, Sam were in the process of separating when she was reported missing March 21, 2007. On September 22, 2010, the Georgia Bureau of Investigation announced that they identified remains found in a creek bed on a Chattooga, Georgia farm as those of Theresa Parker. Sam Parker was a Lafayette police officer. He remained a person of interest until his wife's body was found. Evidence was collected and he was fired then charged with murder. He was convicted September 9, 2009 and sentenced to life in prison.

Mrs. Kathleen Savio Peterson, 40 third wife
Mrs. Stacy Ann Peterson, 23 fourth wife (mother of 2)

March 1, 2004 Kathleen Savio of Chicago, Illinois was found dead in a bathtub. The coroner ruled the death as an accident. Kathleen Savio was in the process of divorce. When her husband's new wife, Stacy Peterson, went missing October 29, 2007 the death of Kathleen Savio Peterson got a second look. Some believed the accidental drowning homicide was staged to look like an accident. Mrs. Savio filed for an emergency order of protection from her husband, writing in the file that "he wants me dead and if he has to he will burn the house down just to shut me up." Mrs. Stacy Peterson was reported missing October 29, 2007. Drew Peterson said his wife left him for another man. Her husband, Bolingbrook police Sgt. Drew Peterson, 53, became a suspect after months of investigation. His second wife, Vicki Connolly said that during their marriage that Peterson was controlling and hit her and told her he could kill her and make it look like an accident. Remember he was a police officer. Drew Peterson was arrested May 7, 2009 for the murder of Kathleen Peterson, his third wife. Her death was reclassified a homicide after her body was exhumed February 2008. The judge set bond at \$20M. Dr. Larry Blum testified Thursday that a laceration to Savio's head and the bruises and scrapes on her body could not have been caused by an accidental fall in her bathtub, as state police concluded after investigating her March 2004 death. Drew Peterson, 53, was convicted September 6, 2012.

Dr. Margo S. Prade, 41, (mother of 2) third wife

"I don't know what this is going to do to the children, finding out their father killed their mother." Lillie M. Hendricks, 74, mother

"It's unfortunate but things like this happen in all walks of life. It shows we're all human and we're subjected to the same emotions as everyone else, like passion and anger and destruction," Akron Police Chief Ed Irvine

"It's tough. Our job was to maintain the ethics of the Akron Police Department. He was a dedicated, hard-working investigator. We never had a disagreement over how an investigation should be handled or the outcome. We arrested and convicted other officers. I'm devastated. I had to arrest him. My own partner," Affairs Division, Lt. Ed Duvall

Dr. Prade lived and worked in Akron, Ohio. She was a divorced from Akron Police Captain Doug Prade She was shot to death November 26, 1997 in the parking lot of her office as she was arriving for work. Four years earlier Captain Prade's 21 year old son Prescott E. Prade, University of Akron biology student, was shot to death February 17, 1993. People were extremely sensitive knowing two murders had occurred in a 5 year period. February 23, 1998 Akron Police Captain Doug Prade, 51, was arrested and charged with murder. No bond was allowed. The couple divorced in April 1997, after nearly 18 years of marriage. It was his third marriage. Dr. Prade was shot five times at close range. Captain Prade, 52, was convicted

September 24, 1998. He was sentenced to 26 years to life. Doug Prade's lower teeth matched a bite mark on Margo Prade's left upper arm. In 2011 the Ohio Innocence Project helped to secure a new DNA test on the bite marks on Dr. Margo Prade's lab coat. The bite marks did not conclusively belong to her ex-husband, former Akron, Ohio police Capt. Douglas Prade. Mr. Doug Prade was released from custody in 2013. He spent 15 years in prison.

Mrs. Ann Racz, 43 (mother of 3)

"Several times I left my keys in the door and he'd knock to let me know they were there. If he's the one (who killed her), you'd never think that of him. He's such a nice man." neighbor

Ann Racz lived in Valencia, California. She was reported missing April 1991 after she filed for a divorce. Her husband, former sheriff's Deputy John Racz, 61, was tried for her murder June 2007. Mrs. Racz moved out of the family's home on Fortuna Drive on April 18, 1991, taking the children to a nearby condominium she had secretly rented. April 22, 1991 she spoke to her husband while sitting in her van. Her van was later found at the airport, suggesting she boarded a plane. Ann Racz has had no contact with her family or children since 1991. She was devoted to her children. The question for the California jury in 2007 was did Ann Racz run away from her family never considering the fate of her children. If Ann Racz filed for a divorce from her husband, sheriff's Deputy John Racz, why would she leave her home? All she had to do was wait for the divorce to become final. What devoted mother leaves her children, 14, 7, 11 and never looks back. Ann Racz was last seen April 22, 1991 after leaving her home to move to apartment to start life anew with her three children. Deputy Racz was tried for the 1991 murder of his wife June 21, 2007. The couple was **married 18 years**. Mrs. Ann Racz' body has not been found.

Mrs. Amanda Blaies-Rinaldi, 28 (mother of 2)

"She was scared of him, but she wanted it to work, like any mother would, for her family..."

*She said 'If anything happens to me, I want you to know who did it'".best friend
"My mom has told her so many times to get away... She kept on saying 'I love him'...
He kept on yelling at her, cussing at her". sister*

Anthony Rinaldi, a state corrections officer in Arizona, is accused of shooting his wife, Amanda Rinaldi, December 13, 2011 in the garage of their home while arguing over financial matters. He said his military training kick in garage "due to the fact that he 'snapped' and his 'military training' kicked in." You can assume his attorney will be mounting a psychiatric defense excusing Mrs. Rinaldi's death. There were children in the home at the time of the murder. He pleaded not guilty Thursday to first-degree murder. This man has ruined the lives of two children.

Mrs. Jennifer Serge,

Jennifer Serge was shot to death January 15, 2001 in her Pennsylvania home. Her husband, Scranton police officer Michael Serge, 55, told investigators that he shot his wife in self-defense after she attacked him with a knife. How did this happen? Was he wearing his gun at the time of the knife attack? He was convicted February 2002 and sentenced to life in prison. His appeal was denied in 2008.

Mrs. Diane Stahl

Diane Stahl was married to a New York police officer, Mark Stahl. She was reported missing from her home in Toms River, New Jersey since June 1985. Authorities believe she is dead. Mark Stahl later moved to Florida. Diane Stahl and Rita Fioretti disappeared around the same time. They were both married to New York police officers who worked together in the 1960's.

Mrs. Elva Corona Stratton, 35
Officer Detective Montion
Sergio Munoz

The death of Elva Stratton demonstrates violence against women has nothing to do with race, religion or one's position in the community. Her husband, Police Officer Stratton, died October 16, 1989 after being shot by a fellow officer who was protecting himself. Officer Stratton was angry over business dealings with his business partner and fellow officer. He entered a fundraiser office and shot Detective Montion and employee, Sergio Munoz. After the shooting was over police officer went to Mr. Stratton's home to tell his wife about the death of her husband. What investigating officer did not know is that Elva Stratton had been killed hours earlier. Her body was found in their home when officers went to the home to tell her Detective Montion had been shot. Officer Stratton had been drinking heavily.

Mrs. Darla Trice, 26 (mother) second

Charles Trice, 40, a Florida Highway Patrol trooper, told Hillsborough County Sheriff's deputies April 25, 1994 he shot his wife to death after she stabbed him with a knife during an argument. Darla Trice had filed for a divorce and a protection order against her husband after he threatened her. Trice was charged with simple battery following a December 9, 1993 dispute in which he threatened to kill his wife if she took their child. Darla Trice wrote in the court petition for protection, "We argued. He grabbed me by my hair and wrist, and pulled my arm behind my back and pushed me into the laundry room. He told me to leave the house and not to take the child or else I would leave the house in a body bag." He was put on administrative leave in January. He underwent counseling then was reinstated April 1994. The charges were dropped in April 1994. His wife was dead at the end of 1994. A neighbor said, "We all knew she was afraid of him. She stressed that fact to everybody." The neighbor who visited with Darla every day questions whether the incident happened exactly as Officer Charles Trice said. "I know she wouldn't have argued with Charlie because she was afraid of him. She would have never, ever pulled a knife on him. If she had been that scared, she would have run over here." Darla Trice's neighbors were watching out for her. They knew the terms of Charles Trice protection order. Mr. Trice was charged May 26 with first-degree murder in the April 24 shooting death of his 27-year-old wife, Darla. He was freed from jail Tuesday after posting a \$50,000 bail. He was also fired. He went to live with his parents making certain they would have custody of his child if he is convicted. Therefore his ultimate goal was realized his wife did not get custody of his child. June 28, 1995 the jury told the court they did not believe Charles Trice acted in self-defense when he shot his wife with his .357 caliber revolver.

Mrs. Simona Tucker, 21 (mother)

Simona Tucker was shot to death at home in Moreno Valley California on Mother's Day May 8, 1994. She was shot in the head. Her husband, Garden Grove police officer Derrick Tucker, 32, was charged with murder. He said the shooting was an accident. He said he and his wife was playing with his gun. Family members said Mrs., Tucker was afraid of her husband and left him

in 1993 for more than eight months. She was killed a few days after the couple reconciled. A custody battle between grandparents ensued over Mrs. Tucker's child. Mr. Tucker took the child to his parents before he was arrested. He is not in prison.

Mrs. Lorna Waleskowski, 40
Hayden Waleskowski, 9

The authorities concluded that Waterford Michigan Police Officer Michael Waleskowski killed his wife, Lorna and son, Hayden, torched this house then turned a gun on himself in 2004. Officer Waleskowski was caught on a surveillance camera allegedly taking about \$500 from an arrested suspect's wallet. He was dismissed from duty at 3:30 a.m. August 2004. The murders may have been committed to avoid his family being humiliated. The suicide rate for police officers is two to three times higher than the national average.

Officer Patricia Williams, 33 (mother)

Officers Ed Williams, 36, and Officer Patricia Williams worked for the Detroit Police Department living in Canton, Michigan. The couple was arguing in the parking lot of the library in Canton, Michigan in 2009 when Ed Williams shot his wife to death. He then attempted suicide. He was placed on life support pending organ donations. The previous week end the Canton police answered a domestic violence call at their home. Officer Ed Williams called his wife on the phone and asked her to meet him at the library.

Mrs. Lisa Wofford, 34
Kimberly Wofford, 17

Lisa Wofford and her daughter, Kimberly, were shot to death in a shopping center parking lot in Glynn County Georgia. Mrs. Wofford's divorce was scheduled to be final the week of January 18, 1998. Former police officer Jesse Wofford, 53, committed suicide.

Mrs. Kimberly Wright, 34 (mother)

It took authorities ten years to convict Michigan State Trooper Douglas J. Wright, 52, for the murder of his wife. He was convicted of second-degree murder May 2003 and sentenced to 25 to 50 years in prison Kimberly Wright, 34, was found dead May 1, 1993, in the basement of her home on Grove Park Road, across from Lake Fenton. She had been shot once in the chest with a handgun her husband brought to the house. Trooper Wright said his wife committed suicide. The couple was in the process of a divorce. He said he argued with his wife left the home when he returned his wife had shot herself. When the death occurred investigators questioned whether Kimberly Wright was capable of shooting herself because she had a high blood-alcohol level when she died. He cleaned the murder scene. The couple was married nine years.

Mrs. Linda Yancey, 44
Marcial Cax Puluc, 20

Linda Yancey was shot to death June 2008 in DeKalb County Stone Mountain, Georgia. Cax Puluc, a Guatemalan immigrant was shot to death by her husband, Derrick Yancey. Her husband told police Mr. Puluc shot his wife and he shot Cax Puluc. When his story did not hold up was he fled to Punta Gorda Belize. Federal Marshal brought him back to the country September 2009. Derrick Yancey was a DeKalb County Deputy. DeKalb County sheriff's

deputy Derrick Yancey, 49, of Georgia was charged in August 2009 with the June 2009 murder of his wife, Linda Yancey, and a laborer who worked in their home. November 3, 2010 a jury of seven men and five women found Mr. Yancey, 51, was convicted on two counts of malice murder and two counts of possession of a firearm during the commission of a crime.

Mrs. Judith Black Ziobron, 32 (mother of 2)

Judith Ziobron of Maine died after a fall from a horse Thanksgiving November 27, 1993. Shortly before her death she told her husband she wanted a divorce. She was going to sell the farm and move out of state with her two children. She and her husband, Edward, owned a farm in Hayford Hill. At the time of Judith Ziobron's death, she had a \$120,000 life insurance policy with double indemnity in the case of unexpected death. She also was insured as a co-mortgage holder on the farm. He was unemployed detective. January 24, 1996 a wrongful-death suit was brought against her husband, Edward Ziobron, contending that Mrs. Ziobron was beaten to death. Her injuries were more consistent with a person being beaten than falling off a horse. Mrs. Ziobron's face was crushed, she sustained numerous deep gashes to the head, several ribs were fractured, and the heart muscle was ruptured. Dr. Michael Baden said her injuries were not cause by a horse. Mr. Ziobron did not contest the suit. The court placed a \$500,000 attachment on the Ziobron farm. Mr. Ziobron once worked as a Waldo County sheriff. Three weeks after his wife's death he moved to California.



Another set of murders we do not discuss are male victims of domestic violence. These are the men who are killed because they have associated with women who are experiencing violence in their lives; Women who are trying to get away from their tormentor; Women who are trying to get away from their stalker, their coworker, their first husband etc.

June 13, 2007 Michael James Young Jr., 21, was free on a \$75,000 bond when he shot and killed Robert Bell, 49, of Gaston, South Carolina. Mr. Young was arrested June 5, 2007 and charged with stalking his wife, Shaunna Lynn Bell, 21. He was later released on bond. A condition of his bail, he was prohibited from making contact with Bell or her family. Still intent on harassing Ms. Bell he followed the father and daughter to a shopping mall where he confronted and shot Mrs. Bell and her father. Mr. Robert Lynn Bell, 49, died at the scene. Shaunna Bell survived. Brian Christian Leagones, 21, was charged with obstruction of justice and accessory

to murder. He gave Mr. Young a ride to and from the mall where the shooting took place. Witnesses said, "got into a waiting car." Mr. Leagones was later charged with misprision of a felony. Michael Young was charged with murder, assault and battery with intent to kill and possession of a firearm during commission of a violent crime. It was his habit to carry a gun. Mr. Young was men who like to make threats which he often did at his wife's job. He called her at work incessantly. The couple was not married a year. Ask yourself what it took for Mr. Young to pull the trigger and shoot his wife and her father. How will he defend his action? Did he say he was insane? Why did he have the gun on him? Why did the judge not exhibit more caution before allowing this man out of jail on such a low bond. What are the judge's views on stalking? What are the stalking laws in this state? What is the harshest sentence for stalking in this state? Why did Mr. Leagones help Mr. Young by giving him a ride? Why didn't Michael Young have a car? Did he have a job?

Khamchan Chomsavanh,29

Khamchan Chomsavanh of Missouri was shot to death April 7, 2000 in his girlfriend's apartment by Seun Inta, his girlfriend's estranged husband. Mr. Seun Inta, 39, of Texas stole a set of keys from his wife's apartment on a visit to see his children. He decided his wife was seeing another man and decided to kill him thus the April 7th attack. Seun Inta pleaded guilty to first-degree murder, first-degree assault, burglary and armed criminal action. The prosecutor recommended 50 years. Mr. Seun Inta and his wife were separated about a year.

Mr. Fernando Barraza, 20

Fernando Barraza of Utah was stabbed to death February 10, 2005 trying to help his friend who was being stabbed by her estranged husband, Jamie Valasco.

Mr. Scott Broadman,

Scott Broadman of Wisconsin was shot to death April 24, 2003 in his girlfriend's home by his girlfriend's ex-husband, Frank Lunkley. Mr. Frank Lunkley then took his own life. He had moved to Iowa. His ex-wife thought their divorce went fairly well. They had joint custody of the children but the children were living with their mother. There is no such thing as an amicable divorce. It is possible that from Mr. Luckley's point of view Mr. Broadman had his wife, his children and was now living in his home.

Jim Brown, 44

Jim Brown of the finance director of Pine Spruce, North Carolina was shot to death in the town hall June 2003 because he was dating the ex-wife of Bob Brandl. Bob Brandl had threatened his ex-wife by saying, "If you see someone else, I will take care of it, and you won't like it." Mr. Brandl committed suicide.

Mr. Arturo Deleon

Arturo Deleon of Dallas, Texas was shot to death May 10, 2004 in his apartment by the estranged husband of his girlfriend. The estranged husband had been lurking outside and entered the apartment through the patio doors.

Mr. William Donahue, 55

"A beautiful person. He's the only person I know who was 99 percent perfect."
Edith Kinney, secretary

William Donahue of New Jersey was stabbed in the back in his home. John Peplinsky Jr. 24, was charged with first degree murder. He was the ex-boyfriend of Mr. Donahue's daughter. Mr. Peplinsky was stalking Mr. Donahue's daughter. He forced his way into the Donahue's home through the back door when the daughter returned home from a date and an argument ensued. William Donahue was a principal of a high school. Mr. Peplinsky was lawn gardener.

Robert Harris, 27

Robert Harris of Ohio was shot to death February 23, 1996 while at work by his co-worker's estranged husband, Terry Bryant. The Bryant's had been married 23 years. Mr. Harris was not having an affair with Terry Bryant's wife. He was merely her coworker. Mr. Bryant said when he drove to his wife's place of employment he was drunk and blind with jealousy. He went there to kill a dog. He ended up killing Robert Harris. He was convicted and sentenced to 15 years to life.

Vernon Howe, 28

Vernon Howe of Florida was shot to death February 5, 1990 by Richard Mosley, 28. Mr. Mosley was looking for his estranged wife. Mr. Mosley was charged with first-degree murder.

Joseph Hatley, 18

Joseph Hatley of Oregon married Michelle Cotton, 32, Friday, July 11, 2003. Saturday, July 12, 2003 Joseph Hatley was shot to death inside his home by his wife's ex-husband, Robert Cotton, 39. Robert Cotton committed suicide as the police were approaching.

Gary W. Hardison

Gary W. Hardison of Virginia was shot to death June 2, 2002 by David Lee Farrow, 34. Mr. Hardison was dating Mr. Farrow's ex-girlfriend whom he shared a child. Mr. Farrow was convicted and sentenced to life in prison without parole.

Ike T. Johnson, 45

Ike Johnson was shot to death by Kent D. Kettle, 36, July 30, in a parking lot as he left his girlfriend's apartment. Kent D. Kettle, 36, was the ex-husband of the woman Mr. Johnson was dating. He hid in the parking lot waiting for Mr. Johnson to leave the apartment. Kent Kettle committed suicide after a four hour standoff with police.

Mr. Frederick Keough, 43

Dec. 5: Frederick Keough, 43, of Salem, was allegedly shot to death by his girlfriend's estranged husband, Armando Pereira, who then fatally shot himself in the head. Keough was the father of two sons. According to the district attorney, Pereira and his wife had separated a year earlier and she had begun divorce proceedings.

Richard Loiacono, 42

February 7, 2000 Richard Loiacono of Colorado was shot to death by Arnold Pardun. Mr. Pardun was going to a bitter divorce with his wife. Arnold Pardun's wife was staying with Mr. Loiacono and his wife. As police arrived Mr. Pardun killed himself.

Gabriel Miguel Meza, 33

Gabriel Meza of Washington was shot to death October 14, 2004 in his apartment by his girlfriend's ex-husband, Martin M. Lopez. Clearly Mr. Lopez was full of hate.

Emanuel Murray Jr. 3months

May 3, 2009 Emanuel Murray Jr. was thrown from a car onto highway I-275. He died as a result of that fall. His cause of death was blunt impact with skull fractures and brain lacerations. The man who threw him onto the highway was Richard McTear Jr. Mr. McTear had terrorized Emanuel Murray's mother in her apartment. Mr. McTear hid in the apartment until she returned home then he attacked her. He beat her and bit her twice. Then he threatened to kill her and Emanuel Murray. Baby Murray was beaten in the apartment. He was twice thrown against the wall as he was sitting in his car seat. When Emanuel Murray's mother broke away from Mr. McTear, Mr. McTear grabbed Emanuel and ran off with him in his car. Richard McTear is now charged with first-degree murder, felony battery, burglary with battery, aggravated child abuse and kidnapping. Mr. McTear is being held in protective custody. This murder took place in Florida.

Mr. Cedric Paulk, 26

Cedric Paulk of Louisiana was shot to death March 9, in a Walgreen's by his girlfriend's former boyfriend, Larry Williams, 54. He was charged with first-degree murder. It was obvious Mr. Williams was stalking Mr. Paulk.

Julian Robinson

Julian Robinson of Nevada was dating Kelly Watts. Ms. Watts was Mr. Evan Moore's ex-girlfriend. Rather than going on with his life Mr. Moore decided Mr. Julian Moore had to die. He shot Mr. Robinson to death in a public display of violence at the Ponderosa Hotel -Casino. When Mr. Moore was convicted in 2008 Judge Deborah Agosti sentenced Mr. Moore to life in prison with parole possible after 40 years. Chief Deputy District Attorney Daniel Greco said he was pleased with the sentence. He said, "Mr. Moore will either die in prison, or be released from prison in his late 80s when he will no longer be a threat to harm anyone."

Mr. Edward Schiller, 39

Edward Schiller of Massachusetts was shot to death January 13, 2006 inside a parking garage. The ex-husband of the woman he was dating paid a man \$10,000 to kill him. Scott Foxworth and James Brescia were charged with murder.

Mr. Scott A. Smith, 34

Scott Smith of Kansas was shot to death April 2, 2003 as he was returning his children home to his ex-wife. His ex-wife's boyfriend, Eric Leckenby, 29, was angry that Mr. Smith and his ex-wife were arguing over the custody of their three children so he decided to kill Mr. Smith then himself.

David Allen Steven, 38

There is no rational reason why David Steven was shot to death December 23, 1998 except that he got caught up in the lives of Ronald Barker, 34 and Ny Nourn, 18. Mr. Barker was cheating on his wife with Ny Mourn, who he met over the Internet. Ms. Nourn was an employee of Mr. Stevens. She decided to cheat on Mr. Barker with Mr. Steven. Mr. Steven knew nothing of her involvement with Mr. Barker. Nevertheless he was shot to death because Mr. Barker was angry he had sex with Ms. Nourn. Ny Nourn and Ronald Barker were convicted of his murder. Superior Court Judge Frederick Link sentenced Mr. Barker to life in prison without parole. He told Mr. Baker "This community is better off with you gone." Ny Nourn was granted a new trial. At one point in her relationship with Mr. Barker she lived with him and his wife.

Martin C. Stevens, 39

Martin Stevens of Springfield, Illinois was shot to death May 6, 2001 by Mark A. Burmeister, 38, because a woman preferred Mr. Stevens over Mr. Burmeister.

Brian W. Washington, 20

Brian Washington of Utah was shot to death April 27, 2003 by Steven Leroy Richardson, 32. Mr. Washington was dating Mr. Richardson's wife. The Richardson's were going through a divorce. Steven Richardson killed himself.

Mr. Raymond Wilkinson,

Raymond Wilkinson of Key West, Florida was shot to death in 2005 by Douglass Fontaine, 50, who was his ex-wife's husband. Douglass Fontaine drove from Vernon, Connecticut. Mr. Fontaine committed suicide while being pursued by police.

Michael Zammitti Jr. 39
Chester Roberts, 51

March 13, 2006 Michael Zammitti and Chester Roberts were shot to death by Sean Fitzpatrick inside a concrete company. Mr. Roberts was shot because he was a witness. Mr. Zammitti was shot because his wife's alleged boyfriend, Sean Fitzpatrick, was angry that she would not leave Mr. Zammitti.

Chapter One The Assault

The Institute offers this section to women in support of our statement that women must always be alert.

You must always snoop, listen, and pry. The following women did not do this and the women were assaulted, luckily they survived the assault with their lives.

Mrs. Angela Litvac

Mr. Yachiel Abramov was arrested May 25, 1995 and charged with solicitation of murder for hire. He was accused of offering up to \$4,500 in money and \$2,500 in car repairs to Lamar Jones and Leroy Solti, both 18. Mrs. Litvac was shot once and stabbed four times. Jones and Solti were charged with attempted murder, home invasion, aggravated batter with a fire arm. Mr. Abramov was convicted and sentenced to 35 years. His wife said "Little did I know that I was in for a very rude awakening and that my life would blow up in my face." I do not know who this man is, and for five years my life was a set of cheap magician's tricks and illusions. "He walked into my life through the front door and tried to force me through the exit."

Mrs. Myra Furbush

Harrold Furbush, 56, was arrested January 1, 2002 for hitting his wife in the head, neck and face with a hammer as she slept and setting their apartment on fire. Myra Furbush survived because a neighbor immediately called the police, the fire department responded quickly and the firemen were able to find her body through the smoke. Mr. Furbush was charged with criminal attempt at murder, first-degree assault and first-degree arson. Mr. Furbush ran into a police car as the police were responding to the 911 call.

Mrs. Carolyn Cox, 65

Carolyn Cox was beaten in her home in 2004 with a blunt object and dragged through her home to the garage where two cars were left idling. The garage door was locked. Her husband Bill J. Cox, 66, was convicted April 2007 of attempted murder and aggravated domestic abuse. McHenry County Circuit Judge Joseph Condon sentenced him to 20 years in prison. Nichole Owens, chief of criminal prosecutions for the state's attorney's office said "This was an unspeakable, brutal, senseless crime done by her husband of 43 years and the father of their two children. "She was ambushed in her sleep." When her husband was sentenced Mrs. Cox said, "I was a young bride of 19, a simple farm girl with hopes and dreams. On Sept. 13, 2004, my dreams were shattered. It's over. It's done, I just wish I could stop hurting." Mrs. Cox life was saved because a family member called the police when they could not reach Mrs. Cox.

Mrs. Chao Lee, 40

Chueng Lee, 45, of Weston, Wisconsin, a Wausau police officer, was charged with attempted first-degree intentional homicide, false imprisonment and aggravated battery after he crashed his pickup into a Shawano County bridge September 18, 2007. He said he had swerved to avoid a deer. Authorities said he was trying to kill his wife. He kept a photograph of another woman that he described as "his soon-to-be 20-year-old wife." Chueng Lee threatened to kill his wife, who had filed for divorce in March 2007. A criminal complaint said 46-year-old Chueng Lee forced his wife, Chao Lee, into his pickup and crashed it into a Shawano County bridge. Mr. Lee pleaded no contest in May 2008 to felony charges of recklessly causing great bodily

harm. He was sentenced in August to three years in prison. Chueng Lee also will spend two years on extended supervision. Chueng Lee was a fifteen year veteran of the police force. He accepted a pleas deal during his trial. He was charged with attempted murder conviction would have landed him in prison for 15 years. According to court records Chueng Lee threatened to kill his wife at her home before she got into his pickup for what he said was a drive to a casino. She said her husband told her, "You want to die in the house so all the kids will be scared or you rather die someplace else?" Chao Lee told investigators that she got into his truck because of those threats and when she tried to fasten her seat belt several times, he repeatedly removed it before the crash into the concrete bridge. This is how Mrs. Lee's marriage ended.

Mrs. Donna Boley

Donna Boley was hospitalized for nausea, seizures, unable to speak and was paralyzed from the neck down from an unknown malady. Finally doctors told the police they thought Mrs. Boley was being poisoned with arsenic. Why didn't he just get a divorce rather than try and kill his wife. October 10, 1993 James Boley, 43, a high school guidance counselor was arrested and charged with poisoning his wife's food and drink. Mrs. Boley had a \$600,000 life insurance policy. He was charged with assault and attempted murder. Mr. Boley was maintaining a separate life from his family. He was using a dating service and meeting women. Mr. Boley was finally convicted and sentenced to two life terms. Mrs. Boley said she was unaware that there were any problems in their lives. James Boley started poisoning his wife in 1991.

Mrs. Jody Niceley, 48

When Marc Niceley went on trial in Covington, Kentucky February 2007 and his attorney told the jury that Marc Niceley was not a killer that his wife, Jody Niceley, attempted suicide the jury did not believe him. The jury did not believe Mr. Niceley found his wife wounded on the floor of their home. They believed the prosecutor and the medical and ballistics experts that said that the trajectory of the bullet, as well as CAT scans, show Jody Niceley could not have shot herself in the head. The jury took one hour and found Marc Niceley guilty of criminal intent to commit murder. Jody Niceley married February 2005. She was shot in the head June 16, 2005. Her husband was convicted and sentenced to 14 years in prison. Assistant Commonwealth's Attorney Christy Muncy said, "She survived the most unthinkable act anybody could ever do to her. It doesn't get worse than this."

Mrs. Aspasia Kousounadis

December 1, 2006 Mr. Arthur Kousounadis, 56, did something really stupid, and threw his life away. He purchased a gun and when to his ex-wife's job and fired the gun at her. The prosecutors in New Hampshire said that action was attempted murder and he was guilty of violating a Massachusetts protection order. Mr. Kousounadis was angry and frustrated that his attempts at reconciling with his wife didn't work. He wanted her attention and he was not getting it. The couple was married for 24 years. Mr. Kousounadis was convicted of felony criminal threatening and violating a protection order. In 2009 he appealed his conviction.

Attempted Assault husband acting alone

March 5, 1993 Mrs. Annette O'Flaherty's husband, Harold O'Flaherty, 52, of Gaithersburg, Maryland was sentenced to 30 years in prison with all but five years suspended for criminal solicitation. Mr. O'Flaherty was arrested February 12, 1992 for agreeing to pay a hit man \$2,000 to kill his wife. Harold O'Flaherty wanted his wife dead and gave the hit man \$500.00 as

a down payment. Mr. O'Flaherty was blind. He was a Reagan administration appointee to the National Commission on the Handicapped. When Harold O'Flaherty handed the hit man the money he said, "It's never been a real close marriage." The couple was married 29 years. Mr. O'Flaherty was a public servant.

Mrs. Jacqueline Harper, 21

Ohio prosecutors told the court Mr. Christopher Harper, 25, plotted to kill his 21 year old pregnant wife because he did not want to pay child support in the event he left his wife. Mr. Harper made a long list on a note pad of ways his wife could be killed. Christopher Harper offered his friend, Patrick Allen O'Toole, \$2,000.00 or \$3,000.00 to kill his wife. Jacqueline Harper was attacked February 4, 1991 with a tire iron while she was sleeping. She survived. The murder plot was discovered. Mr. O'Toole pleaded guilty in October to attempted first-degree murder and conspiracy, and agreed to testify against Mr. Harper. Mr. Harper pleaded guilty to attempted murder April 1992. His wife divorced in May 1991.

Mrs. Kelly Jo Pollock

Imagine the emotional trauma Mrs. Pollock experienced when she learned her husband, Jesse Earl Pollock Sr., 26, was arrested for hiring a hit man to kill her in a fake car accident. She could not deny the situation did not exist because she heard the prosecutor read the charge' the use of interstate commerce facilities with intent of committing murder for hire. She heard the prosecutor tell the court her husband agreed to plead guilty to wire fraud arising from his attempt to defraud his insurance company. Jesse Earl Pollock Sr., 26, of Tallmansville, Virginia was arrested by federal agents March 5, 1993 at Stonewall Jackson Hospital and charged with offering to pay an FBI informant \$5,000 to kill his wife. There was a \$50,000-plus insurance policy. February 12, 1993 Mr. Pollock offered \$5,000 to the unidentified man to kill his wife. The man reported the offer to the Upshur County Sheriff's Department and began working with the FBI. Mr. Pollock was sentenced to 60 months in prison. Mr. Pollock entered the hospital thinking he was there to see his wife's body.

Mrs. Sherrie Hruzek,

Sherrie Hruzek of New Berlin, Wisconsin was another woman shocked to learn her husband wanted her dead. Her husband, Michael Bauer, 31, purchased a \$500,000 life insurance policy and a 200,000-volt stun gun and rigged her bed so she could be electrocuted. The plan was to electrocute Sherrie Hruzek April 1997 then tell the police his wife accidentally killed herself in the bathtub with the hair dryer. Mrs. Hruzek was three months pregnant. Her husband called her from jail stating her he thought about killing her, he just couldn't do it. During Mr. Bauer's trial the jury learned he forged his wife's signature on the insurance policy. His wife found a website where Mr. Bauer looked up ways and means of committing murder. They learned that the night of April 23, 1997 Mrs. Hruzek woke up three times to find Mr. Bauer standing over her fully dressed. Three days later she found handcuffs behind her bed. What the jury did not learn was that Mr. Bauer tried to hire a man to kill his wife while he was in jail awaiting trial for attempted murder. Mr. Michael Bauer was convicted of attempted murder in 1998.

Attempted Assault – Ex Wife

Mrs. Shona Davis

Assistant District Attorney Rich Tuttle told a Colorado jury that Mr. Stuart Shader, 32 tried to get his girlfriend, Shawna Nelson to kill his ex-wife, Shona Davis. The attorney continued telling the

jury that when Ms. Nelson betrayed Mr. Shader by going to the police Stuart Shader tried to hire a hit man to kill both women. The first trial ended in a mistrial. The second Mr. was convicted in 2006 of three counts of soliciting to commit first-degree murder and two counts of attempting to commit first-degree murder. He was sentenced to ten years in prison. The couple was married and divorced in 2004. Mrs. Shona Davis said she still loved Stuart Shader but he had a drinking problem. Mr. Shader had a history of domestic violence. He was arrested on a felony criminal trespass charge in an incident that involved Davis just before his arrest for soliciting Shona Davis' murder. There are two elements that the eleven women above have in common they believed that there was no reason for their husbands to want them dead. They might have been strife in the relationship or some arguments or disagreement but none of these women thought the state of affairs in their marriage warranted murder. These were not just assaults at home following an argument these were assaults that resulted after the husband gave his wife a long hard look and decided the best thing for him was the death of his wife. These assaults were based on selfishness. What is good for me! Imagine the shock when some of the women learned their husband's wanted to cash their lives in so the husband could start a new and rich filled life. In one second of time Mrs. Angela Litvac learned her husband wanted her dead. Mrs. Myra Furbush was attacked in her sleep. Mrs. Carolyn Cox, 65 was assaulted in her sleep. These women were not given any opportunity to defend themselves. Imagine going to sleep and your husband has decided to electrocute you, to zap you with 200,000 volt stun gun. Mrs. Chao Lee, 40 was assaulted after she filed for a divorce. Mrs. Donna Boley learned her husband wanted to cash her in to start life anew. Mrs. Jody Niceley learned her husband wanted her dead. Mrs. Aspasia Kousounadis learned her husband wanted her dead. Mrs. Annette O'Flaherty learned her husband wanted her dead. Can you imagine the chagrin of these women when their relatives learned the state of their marriage? People derive importance from the condition of their marriage. Mrs. Jacqueline Harper and Mrs. Sherrie Hruzek both learned their husbands wanted to cash her in to start a new life. Mrs. Shona Davis life was threatened by her ex-husband. When is enough, enough? Their marriage ended in divorce why didn't her ex-husband not just leave the situation alone and try to rebuild his life. Not one of these husbands thought divorce was a satisfactory solution.
