The information is overwhelming and it is not possible to read this book without enduring excruciating pain. Pain is not our objective nor is sensationalism. Our objective is to bring about a permanent change in the status of the American woman and the women of the world. To meet this objective, we provide penetrating information. All too often, information regarding the death of an American female is taken as an isolated event, thereby making her death digestible and easy for the women of this country to accept. Although the murders are important, over time, the murders become inconsequential because many women think the murders have nothing to do with one's everyday life. Therefore, the full impact of the number of women murdered in this county is not appreciated. Collectively, the murder of over 200,000 American women is important when one can sit and read the cases of 20,000 women from this group. The information in this book is not being offered to sensationalize or exploit the death of these women. The information is being provided to bring recognition to their existence and their untimely deaths. We believe the women who paid the ultimate price for freedom should be immortalized. These women should never be forgotten.

This book was written in deference to the millions of women in the world who have lost their lives merely because they were women. Think of the girls in India who are raped so males can remain in control. If you have read the news out of Nigeria, you will understand males are fighting all over the world to remain in control. More than 300 school girls were taken from their families merely because they were females trying to learn to read. No one knows if these children will ever be returned home again. Women must wake to the fight for sovereignty.

Extreme care was taken in discussing the deaths of more than 20,000 American women. It was our wish to grant the victims as much dignity as humanly possible yet alert the women of this country of the horrors of their deaths. But how much dignity does a victim have when it is known she was stabbed more than 153 times? Again, we feel that you should not read this book if you have been a victim of violence or have a male or female relative or child who has been a victim of violence. If you choose to proceed we ask you to be brave, strength will come. There is much to learn. You will not put this book down without gaining knowledge. The Career Rapist especially will be hard reading, but as women we must stand together and face the monsters in life so we can live better lives and secure a future for our children. Although *Do This in Remembrance of Me* discusses the murder of 20,000 American women, the books are about life not death. As you read the following information, please remain cognizant that you are reading case histories of crimes committed all over the United States. No one state has the same definition or punishment for any degree of murder, manslaughter or rape. The proof and qualification for an insanity defense is different in most states, as are the requirements for the death penalty. The definitions of mitigating and aggravating circumstances are defined differently

by state, as is the right of a judge to override the jury during sentencing in death penalty cases. Also, the requirement for probation is different per state, as is the punishment for juveniles and individuals who are mentally handicapped and commit capital offenses. When you read Volume Three: *The Career Rapist* and Volume Four: *The Recidivist*, you will then appreciate this difference.

You must also remember American law is not static. Our laws have been made to yield to technology that has allowed for the release of men from prison. With respect to all the data in the four volumes of *Do This in Remembrance of Me*, the persons listed as murderers or rapists or in the category "Murderer Status: " were individuals who at the time were apprehended, arrested, charged, tried, convicted, or suspected or alleged by the police in the murder of the women mentioned. During the course of time, some of these individuals may have been exonerated and the information was not available or recorded in the source documents used during the development of the books *Do This in Remembrance of Me*. We took extreme care to list as many convictions and as many exonerations and overturned judgments that we could find in the source documents used. The two categories, "murdered by stranger" and "murdered by unknown," are not clearly defined as the categories when used by the United States Justice Department. Our "stranger" category is only used when the murderer is known but the relationship was not clear in the source document. The category "murderer unknown" was used when there was no information in the source document regarding the relationship of the murderer and victim, the murderer had not been apprehended, or the victim was unidentified at the time. In some situations, some of the cases listed under "unknown" may now have been solved. We did not intrude upon the lives of the survivors as mentioned in the foreword. It is not our intention to sensationalize or to make murderers celebrities. You may recognize several women who were murdered by men now made famous by the newspapers. We did not use the slogan names of these men. We saw no need to further the agenda of newspapers.

When the last name of a person is in brackets, this means that we were not certain of the spelling of the last name or that we used the last name of the parent because we only knew the first name of the victim. The word "mother" across from the victim's name means in most cases that the woman left behind young children when she died. The word "see" references similar cases or women who were murdered together or murdered by the same person. Again we caution you: please do not read this book if you have been a victim of violence or have a male or female relative or child who has been a victim of violence. There is no way to escape the pain reading the following passages will cause. This information is upsetting, but we must have courage. If you choose to proceed, we ask you to be brave; strength will come. This section will be hard reading, but as women we must stand together and face the monsters in life so that we can secure a future for our children and bring peace to our nation. There is no peace when there is violence. To the men reading our books: you must become more aware of the possibilities of danger that your daughters will experience when they date, become engaged, or marry. You cannot help the women of this nation if you do not understand their problems.

## Author's Statement

My name is Gloria G. Lee. I am the author of *Do this In Remembrance of Me*. I have been asked over and over again, why I wrote 10,000 pages discussing the murders of 20,000 women. How could I stand to read about these murders day in and day out, and then write about the murders, especially given the fact that some of the murders involved children? The answer is simple: I want to change America. I have been angry for 15 years over the condition of the American woman and I decided to do something with my anger. You will probably say that 15 years is a long time to be angry, but that is the truth. I have been seething at the status of women in this country. I have had enough of men making money off the bodies of women. I endured the trauma of investigating these murders because I wanted to change the minds of women and men to allow every woman who wants to live her life under her own steam to be able to do so without reprisal, without ostracism and without betrayal. I wanted to be the catalyst to the final liberation of women. I am a member of the generation that burned their bras, yet I did not get the chance to do all that I wanted to do with my life. There were both economical and gender road blocks in my way during my life time that I want removed for future generations of women. I do not believe a single woman uneducated with children should have to do sexual favors for a male supervisor just to get a job or maintain a job, especially in a minimum wage restaurant. Is that not humiliation? How many times must a woman pay for being poor?

I endured reading and writing about women being murdered because prostration and prostitution does more than just anger me; it leaves me simmering with rage. I endured reading and writing about women being murdered because I refused to go to my grave being a mean and hateful old woman, enraged because I did not get a chance to do what I wanted to do in my life. Anger solves nothing; it merely wrinkles the face. I stayed at my computer because I remembered my mother's words when she took me to the library. She told me over and over again "Knowledge is power; He who reads, sees." I tried to put as much knowledge in *Do This In Remembrance of Me* as I could. I want the women of this nation to see.

My mother was among the poorest of the poor, but she was a proud woman. She was also a defiant woman. It was her defiance that fueled my spirit everyday as I wrote. My mother did not want to be what others wanted her to be. She was always trying to make the house look better, make us look better, with our hair combed and tied in ribbons and shoes shined. If there was one moment in time that I would use to describe my mother, I would say it was the moment when she would receive books in the mail through the Reader's Digest program. I read them all. I read every free book that came with each subscription my mother made in each of our names. The books she gave me to read were the greatest moments that defined my mother. She believed in books. There was nothing greater than a book. She believed through books one could escape poverty and ignorance. My mother believed she was doing the best thing for me by giving me a book to read. Later my mother would die in a hospital having no bed sores after being nursed day in and day out for 17 years by one of her daughters who she poured her dreams into. We remembered her words, "Look people in the eye, have a firm hand shake, sit up straight, work for what you want, don't back down when you are right and never get on your knees except for the Lord." My mother's wish for my life kept me writing. My past successes or failures were of no consequence to me. I was going to leave my words behind for others to read. My mother did not die an angry old woman and neither shall I.

Not every woman reading *Do This In Remembrance of Me* will experience the same emotions. Many will stand up, holler, scream, and spew vile words against my views. I am especially afraid of Black women, but I shall stand my ground even if they attack my body. I am demanding that they stand up even unto death. Black women in this country endured more than 400 years of being raped and sexually abused. No black woman has a right to go to sleep at night without landing a blow for the liberation of women. Some women will say, let the dead remain dead. Why dredge up the past? Murder has a specific protocol. It is not decent to talk about murder. These attitudes have remained unchanged for centuries. You don't speak of rape or murder in public. Secretly these people think murder is an evaluation of a person's self worth. Illogically, people feel "If the person was murdered they weren't worth much because only bad people are murdered. They must have done something wrong to be murdered. Good people by

virtue of their goodness live decent lives so they are no supposed to be murdered.” Erroneously, women keep thinking if a woman is murdered she could not have been worth much because women who are valued do not get murdered. What kind of logic is that?

Women changed their outward manifestations, but many still refuse to take control of their minds and lives. Black women stick their heads in the sand when it comes to violence against women (“Oh please, don’t talk about the number of Black prostitutes being murdered!”) and White women find fault with the murdered woman. “She did not have to stay with him. The women should not have been so demanding. Everyone knows men work hard and must be given great understanding when they come home. The women should have gone to church more. Church attendance is very important to a marriage. You can’t be much if you are not a Christian. I am better than you are because I am a Christian. I give to my church every Sunday. And because I say I am a Christian everyone is to believe that I do what the Lord tells me to do.” Hypocrisy of the greatest order. **Some women will do anything for money.**

It is much better to find fault in others, than face what one has become after high school. It is much better to find fault in others, than face the fact that one’s daughter may not want to live the life of her mother. It is much better to find fault in others, than face the fact that some women prefer to fly a plane than bake cookies. Why should either activity exclude one from being a woman? Some women will say, “It was the murdered woman’s fault.” Her husband would not have been killed her if she had behaved better. The women were murdered because they were not good wives. The women should have paid more attention to their husbands. The female college students were murdered because they did not stay home and get married and raise children like women are supposed to do. Women have no business flying airplanes or being an army general. Education is not necessary for women. Their roles are set in society: get married and be a good wife and mother. The reason why we have problems with juveniles today is because the mother is not in the home. She is off somewhere having a career. Read these objections out loud to yourself. Do they make sense at all?

I pose one question to the fought finders and the women who stick their heads in the sand, what do you say about the death of a child at the hands of his or her father or his or her mother’s boyfriend.

As long as women remain divided, through fear, ignorance, superstition and social superiority men will continue to demand that women do as they are told to do at home and at work. This means your daughter, your niece, your aunt your grandmother and your mother must do as they are told because women remain divided in this country. Your daughter, your niece, your aunt your grandmother and your mother may have to get on their knees and open their mouth to get a job or to keep their job. I demonstrate in my books just because you have money now, does not mean this money will protect your child from economic or sexual abuse in the future. Are you really sending your daughter off to college so she can make her way in the world, or are you hoping she will meet a male student and get married and have children? If you are actually sending your daughter to college so she can fulfill herself, then you need to teach her more than what she has been taught. Every day she must be told about being abducted from her job at the pizzeria, being raped in the bathroom of Burger King, being raped in her dorm room, date rape, all the evil things men do so she will be prepared to protect herself. She should trust no one. Sending your daughter off to college as if there are no bad people in the world make you a bad parent. This is the ultimate form of neglect. You must tell her every trick in the book that males use to have sex with women voluntarily and non-voluntarily. (See The Career Rapist). You must also tell her how men turn women into prostitutes. If you do not know this information, it is high time you found out.

Out of all of the sentences I have written, the greatest sentence of all is this: Women talk too much. Shut Up! Arguments quickly escalate into **mortal combat** with the casualty being the woman. Your fury does not translate into muscle strength against a 200 pound man. For your safety, and the survival of your children, stop talking so much. I write this sentence especially for Black women. You fought these men when they were boys on the school grounds but men are a different animal when they become adults. By th time they are adults they have learned combat tactics from playing with other juvenile males. It is possible to think if you stop talking. If you want to live to raise your children stop talking so much. You talk too much at work. You talk too much on a date. You talk too much at home. You talk too much at church

and you definitely talk too much to your best girlfriend. Retrain yourself to think, not talk. If you feel the need to run your mouth, go into a bar, purchase a Coke, pour your troubles out to the bartender then tip the bartender and go home. It is stupid to threaten a man; "If you do not leave your wife, I will tell your wife what we have been doing." Less than five minutes after a woman in Texas got these words out of her mouth she was dead. "If you don't stop coming home drunk I am going to take the children and move to my mother's home." The woman who uttered these words was killed along with her children as she was walking out the door. Their bodies were found on the front lawn. Weak people threaten. Strong people act. Strong people do not ask for permission, they just do. Remember, if you have been in a relationship more than three months, the man knows your weaknesses. Why? Because you talk too much. Men are hunters. They constantly look for weaknesses in everyone around them.

Lastly, it is my sincere wish that the series, *Do This In Remembrance of Me*, help you make it safely through life. Do not be afraid, just be willing to fight for your life. My mother preached to me for years: Let no man take your life without a fight.

## **Oklahoma police officer charged with raping women while on duty**

Heide Brandes reported that Oklahoma police officer Daniel Holtzclaw was charged with multiple sex offences. He is accused of sexually assaulting 13 women while on duty. He was arrested in August. He will be tried for 35 felony counts including 6 counts of first degree rape and sexual assault.

Apparently, Officer Daniel Holtzclaw appeared in court Wednesday to answer to the charges of numerous sex offenses. He denied all charges and was placed under house arrest. He is staying at his parent's home in Enid on paid leave.

13 women testified during a preliminary hearing about being forced to have sex. Some of the women said the Officer Holtzclaw threatened them with jail. A 17 year old said Officer Daniel Holtzclaw raped her on the front porch of her mother's home. She testified Officer Holtzclaw picked her up while she walking home and threatened to arrest her on outstanding warrants.

## **Former federal jail guard who raped female inmate at Metropolitan Correctional center sentenced to seven years behind bars**

Mr. Rudell Mullings age 54 of New York was a federal jail guard working for the U.S. Bureau of Prisons. In 2015 he was charged with raping a female prisoner in his custody.

His DNA was found on her clothing. Mr. Mullings said they had consensual sex. No one in authority over a prisoner can have consensual sex. During his trial the woman testified that Rudell Mullings had harassed her over the course of several weeks before finally accosting her February 14, 2015 in a hallway of the Manhattan lockup (Metropolitan Correctional center ) where she was waxing the floor.

She described how he approached her from behind and restrained her. She said he pulled down her pants and panties and raped her from behind. He told her there were no security cameras in the hallway that could corroborate her story and

no one would believe her. Mr. Mullings weighs 350 pounds. The female inmate told the court Rudell Mullings had been stalking her for some time and said he wanted to hook up with her on the outside someday. "He told me he would like to be the first to put his little penis in me."

Clearly Mr. Mullings was letting his fantasies get the best of him. Mr. Mullings was only sentenced to 7 years in prison after finally admitting that he raped the female inmate. How is this justice? The women he raped had already been traumatized from being molested by relatives as a child.

This is what the woman told Mr. Mullings, "You raped me. "It wasn't consensual sex. It was rape." She told U.S. District Judge Edward Korman, "Now, to compound my childhood trauma, Mr. Mullings has created new challenges for me to confront," she said. "I want Mr. Mullings to know that his actions have caused me tremendous grief, pain, and humiliation." "Even in my dreams, I am suffering flashbacks where I'm repeatedly raped." There is no way Mr. Mullings should have been sentenced to a mere seven years.

Question, did anyone in authority have video surveillance placed in the corridor so this crime cannot be repeated.

## Remember Arthur Bomar and Others Like Him

Please remember this book was written to help women identify rapists living among us and to remind all females, women must always be alert. The most common characteristic of all rapists is that all rapists are men. You have read 500 pages in Volume Three Part One and each page told you that all rapists are men. This means your father, brother, uncle, stepfather, cousin, stepbrother, step son, grandfather, boyfriends, ex-boyfriends and suitor have a 100% chance of being a rapist. I want you to repeat this phrase, all rapists are men. Let this phrase sink into your spirit. All rapists are men, this means your husband, and ex-husband, your uncle, father, brother, and stepfather, cousin, stepbrother, step son, boyfriends, ex-boyfriends, suitor and your grandfather have a 100% chance of being a rapist. The likelihood that he practices this profession is fifty-fifty. Yes being a rapist is a profession a profession that some men practice with zeal? They take pride in their work and they are constantly perfecting their craft. Some rapists do have dormant periods. Please remember any male that you approach has a 100% chance of being a rapist. A rapist does not wear his profession on his face like Dracula or the Werewolf. His identity is determined by his actions not by his clothing, facial expression or race. He does not have to be a practicing rapist but a rapist none the less. Some men rape intermittently once every one or two years (Patrick Baxter Volume Two) or they rape and murder once a trigger is introduced into their life. There can be a stressor that sets him off or he may live a fantasy where he imagines himself a threat where women are living in terror of him. He maybe in the preparation stage of his development or he may have taken his first step to realizing his ambition (Christopher Righetti, age 14). Patrick Baxter raped an 8 year old when he was 13 years old. He was just getting started. He went on to murder 14-year-old Michelle Walker in 1987, 19 year old Patricia England in 1988 and 25 year old Lisa Gibbens in 1990. He was not convicted until 2002. Raymond Williams of Philadelphia, Pennsylvania raped and murdered Carmen Berrocal, 18, June 25, 1989 when he was 26 years old. He happened upon her on the street early in the morning. She was walking home from a graduation party. He was not associated with this murder for 15 years. His DNA had not shown up for any other rapes. He was a murderer just not an active rapist. You will read about several men who raped once or twice because they just happen on a victim. These are the lazy rapists the passive hunter or scavenger if you will. These rapists do not have the imagination for the hunt. Rape is like any other profession some men are excellent at it whereas others are poor craftsmen. They are just like plumbers. Some men are excellent plumbers whereas other men are poor plumbers. They all have the desire to be a plumber and they all passed the course to be a plumber but their individuality differentiates their talent. There are other rapists who rape for the thrill of it. These are the men who rape and tell their victim that they will return the next year to do it all over again (Florida – Georgia). They like to climb through the windows or swing from the balcony to prove to the victim and to law enforcement that they cannot be stopped.

Other thrill rapists like to rape and murder their victim in their bed while there are other people in the home proving their prowess. Remember any male that you approach has a 100% chance of being a rapist. A rapist does not wear his profession on his face just like a plumber. You cannot tell a plumber just by looking at him and you cannot tell a rapist by looking at him. Mr. Jerry Wayne Nobles, 53, a grandfather, was sentenced March 13, 2000 to two consecutive life sentences plus 10 years. He will not be eligible for parole until he's 118. He was convicted of assaulting his 4 year old grandchild. He was a grandfather that was a rapist. July 13, 1997 a woman of the night entered a Louisiana Orleans Parish police station and told authority that she had been raped twice that night by two different people on two occasions and both assailants were police officer (bullies in uniforms) who told her they would arrest her if she resisted. Ms. Yosheka Butler gave the police two condoms filled with DNA as proof of the attacks. She said she wanted her story publicized to prevent similar attacks by police officers. Police officers should pay just like everyone else. She said the attacks she endured are common among prostitutes. Ms. Butler said, "They've been doing that sort of thing for the longest time. Everybody's scared to come forward, but not me. Something's got to be done." She left the state after making the charges. She was frightened. So you see police officers can also be rapists. Rape is the largest single most crime reported in the United States and it is predominantly committed against one gender, women. Remember in Chapter Three we estimated that the number of rapists at large in this country was approximately 1,539,614 men. From 1958 to 2006 2,859,434 women were reported raped in this country. During this same period of time 1,918,574 men were arrested for the offense of rape leaving 1,539,614 rapists at large. Please do not think a rapist stops being a rapist because he gets old. He is still a rapist. The figure does not include the number of rapists immigrating to this country or crossing our borders as tourists each year. Yes there are men entering this country requesting immigration status and they are rapist. And yes there are men entering this country as tourists that are rapist. I know you did not think all of the western rapists went to the Far East. There are men looking for blonde haired and blue eyed women to terrorize. If we add in the number of women who were assaulted by men attempting to rape them (598,574), we have between 1,539,614 to 2,138,368 rapists at large in this country. Yes, there are more than a million rapists in this country. Take the female population and divide that population by 1,539,614 to 2,138,368 and that will give you the number of rapists per woman in this country. This figure represents the number of fathers, brothers, uncles, stepfathers, cousins, stepbrothers, stepsons, grandfathers and boyfriend and ex-boyfriends and suitors that are rapists. That is correct the man you are sleeping with can be a practicing rapist. Nothing precludes a man from being a rapist especially not age. We have rapists at both ends of the age spectrum (10 to 70). Do not sit there and tell yourself that what was just said is not true. It is true. The man you just finished having sex with can be a rapist. Did you notice the number of men in Chapter Six that had girlfriends? When Michael Ross was capture at his home, his girlfriend was visiting him. When William Taylor was arrested in 1981 for killing Donna Williams, Sharon Peterson, and an unnamed woman, he was living with his girlfriend. The couple had just moved into the area. Police believe Mr. Mr. James Randall, 41, of Florida murdered approximately six women in the home he shared with his girlfriend. The police know he murdered in his home they just do not know the exact number of women murdered in his home. Maury Travis murdered in his home. There were pictures of some of the murders. He had a girlfriend who visited him often in his home. She just did not visit the basement where he did his killing. Remember a girlfriend makes a man appear normal. People believe that a rapist does not want to have normal sex with a woman or that a rapist cannot have normal sex with a woman. This level of deception from both sides is the reason why most women cannot accept that their boyfriend is a rapist when he is caught and tried. The women want to say their boyfriend is the gentlest creature in the world; when all the time he has been hunting women with astounding success. There is not one woman in the world who wants to believe she had normal sex with a man that is a rapist. If I am making you vomit so be it. It is better to have an upset stomach than find out that you are married to a man like Mr. Thomas J. McCarthy, or John Eric Armstrong. Yes rapists are hiding as married men. Yes the man you just served chicken to is a rapist (Altemio C. Sanchez, 48). Rapists do not live in some far off land lurking in the darkness they are sitting on your porch talking to your children (Robert Lee Yates). There are cousins who rape together. Cousins, Aaron Mitchell, 23, and Warren Mitchell, 24 convicted of murdering Mrs. Doris Baker, 78. Cousins, Jamie Rodriguez Jr., 21, and Agustin Pena, 15, convicted of murdering Stephanie Dubay, 14. Cousins, Victor Lamar Waterford, 16; Alec Vernal Waterford, 19; and Willie Labron Hill, 19, convicted in the murder of Cynthia Mills, 23. Imagine having that much evilness in a family. Two cousins murdered Karen King, a college student in Michigan. Angelo Buono and Kenneth Bianchi are not the only cousins who raped and murdered together

There are brothers (Brothers, Andrew and Tommy Kokoraleis, of Illinois; Andrew Kokoraleis was executed on March 17, 1999.) who rape together and there are childhood friends (Charles MacKay and Robert Cooper) that rape together. Demario Atwater, 23, and Laurence Lovette, were friends who murdered together. They shot student Eva Carson to death for a few dollars. They were caught within days of the shooting. Kayson Pearson and Troy Hendrix were two friends convicted in the rape and murder of college student, Romona Moore, 21. Two friends, Todd Hoke and Nicolas Castillo, both 16 are now in prison after being convicted of the viscous murder of Amber Leann Hess, 17, of Arizona. She was pregnant when she was beaten strangled then stabbed to death. Todd Hoke and Nicolas Castillo killed Amber Hess because they did not like her.

Two of the most notorious brothers that hunted together were the Cook brothers of Ohio. Mr. Nathaniel Cook, 42, and Anthony Cook, 49, of Ohio together murdered nine people. By the way these men are eligible for parole. There are also business partners who are charged with sexual offenses. August 5, 1999 Lorenzo Feal, 39, of Yorba Linda, and his friend, Amir Kahajavirad, 34, of Long Beach, were charged with poisoning by using the drug gamma-hydroxybutyrate, or GHB -- and kidnapping for the purpose of sexual assault and four various sexual assault charges, all involving a drugged and unconscious victim. GHB is a powerful synthetic central nervous system depressant. February 7, 2000 Lorenzo Feal was convicted of sexually assaulting a drugged and unconscious person. He was sentenced March 27, 2000 to 11 years in prison. Did he just happen to have GHB available? This was a stupid crime. Mr. Feal was earning \$20,000 per month. He threw this all away because of his impish attitude. He had to see what it felt like to have sex with an unconscious woman besides no one would know. He could beat the system. All he had to do is use his magic potion on any woman he met. GHB was a gold mine. What a stroke of luck. There would not be a woman on the planet that he could not have. What a rush. Why not purchase a woman? It would have been cheaper he could have saved the last 11 years of his life. This was the first case in California in which prosecutors were able to provide scientific evidence involving the use of gamma-hydroxybutyrate, or GHB. We do not know disposition of Mr. Amir Kahajavirad's case because his role was reduced. We do not know if he was convicted along with Mr. Feal. The law does not think it is so funny to drug and rape a woman. The victim was sodomized. Some rapists think if the woman is not awake how can she tell authorities what happen to her? You can find rape among any human condition in the world. There are dishwashers who are rapists. There are gardeners who are rapists and there are cable installers (Luis Jeovanny Saravia, 31, California) (Luis Saravia, 32, in our country illegally) who are rapists and there are immigrants who are rapists. Just remember every rapist is a man. Therefore every man can be a rapist. Nothing precludes this behavior. Nothing! No occupation precludes a man from being a rapist. A rapist can be a doctor, lawyer or Indian chief. No hair color precludes a man from being a rapist this means the blonde haired blue eyed man at the office you have been watching can be a rapist. No pants size, no shoe size or age precludes a man from being a rapist. Larry Donnel Green was convicted in 1997 of murdering three women in Newport News, Virginia. The first woman he murdered he had known as a teenager. He was her sister's ex-boyfriend. He was related to the second woman he murdered and he was an acquaintance of the third woman he murdered

And most of all marriage does not preclude a man from being a rapist in fact many rapist use marriage as a camouflage. Lee Roy Martin, 31, was married when he murdered four women in South Carolina. Robert Hansen was married when he killed a number of women in Alaska. Robert Lee Yates was married when he killed countless women in Washington. Jeffery Gordon was married when he killed two women in Michigan. He raped in Florida. John Eric Armstrong was married when he murdered five women in Michigan. Derrick Todd Lee, 34, was married when he murdered six women in Louisiana. Paul Durousseau, 32, was married when he murdered five women in Florida and one woman in Georgia. Donald Wilcox was a father of three when he murdered a number of women. Mr. Goodreau was married and a social security worker when he murdered two women in Michigan. William Floyd Zamastil, 51, was married when he killed in Wisconsin and California. Victor Malone was married and a social worker when he murdered four women in Michigan. Many of these men were also fathers. Any male that you approach has a 100% chance of being a rapist. A rapist does not wear his profession on his face. Who would suspect a father of six of being a rapist and a murderer? No one! As you read you will learn there have been lots of men who have raped and murdered women who are fathers and some were fathers of six children. The fact that the murderer(s) of Diane Carter, 30, Cecilia Jacobs, Lois Johnson, 31, Arlette McQueen, 21, Patricia Real, 26, Delores Willis, 23, and Paulette Woodward, 19 of Detroit, Michigan in the 1980's have not been apprehended lends credence to the possibility that the man you are sitting next to is a rapist and a murderer. The fact that the murderer of Tanya L. Miller, 19, Deborah L. Harris, 31, Sheila Farrow, 37, Jessica Payne, Florence McCormick, Joyce Ann Mims and Quithreaun Stokes of Milwaukee, Wisconsin has been genetically identified is proof that a rapist is quietly living among us.

When Karl Lee Myers was arrested in Oklahoma August 1996 for the deaths of Mrs. Michelle Marzano, 29, and Shawn Marie Williams, 22, two women spoke out against his guilt. Jennifer Simmons said the man who was dating her mother adored her four year old daughter and was a nice man. "He loves my daughter to death. He brings her things and is very affectionate to her." Her daughter called him "her buddy" he is kind and generous to me and my mother. His sister, Hazel Robitaille, said it, was hard believing her

brother was the serial killer he was being made out to be. "He's lost his job. He's going to lose what he's worked hard for." She said personally I don't think so when asked did she believe her brother killed Shawn Williams and Mrs. Marzano. She said her brother liked being around people and was affectionate. Karl Myers sister said, "They're going to have to go a long way to prove it to me. And this DNA -- I'm not impressed with it." During Mr. Myer's trial the DNA expert testified that the likelihood that the semen sample found in Cindy Michelle Marzano came from any other than Karl Lee Myers was 1 in 14 million. Karl Lee Myers married May 2, 1986 his wife died October 1995 approximately 10 years later of cancer. This was his second marriage he married December 1964 at the age of 16. Karl Lee Myers socialized well with women and married two of them but after his conviction there was no doubt he was a rapist and a murderer of women. When Mr. Robert Lee Drown, 27, was arrested for the murders of Jennifer Ison, 31, RN and her daughters, Shannah Ison, 10, and Marissa Ison, 3, Jackie Bare said, she knew Mr. Drown's wife, "I never saw (Ison) with him. If he had a relationship with this woman, I didn't know anything about it, but after the fact -- the fire -- I heard some people at the Bull say he had gone out with her." Ms. Bare said she was surprised when she heard Drown was a sex offender and charged with murder. "I can't find it in my heart to think he'd do something like that. "He doesn't seem to be that type of guy." Mr. Drown volunteered to be a stripper at her daughter's bachelorette party. "It really bothers me now," she said. "I was with him for 2 1/2 hours, all my friends and all my family were around him -- and he was as good as gold to them." One characteristic of sexual offenders is they befriend a woman to gain access to their children. Women often see murder "As something you read about happening somewhere else." When Sean Patrick Goble was arrested in 1995 Lisa Hill said, "Whenever he was off the road, he would come to my house. Park that truck right up in front. He was gentle. He was like a big bear. If I was crying, he was right there holding me. He didn't mistreat anybody." Ms. Hill's sister, Wanda Moore, said, "He's called me many times out on the road and stuff crying. "Sometimes he'd say it was his grandma that was sick. Other times he wouldn't say why he was upset. Other times he'd say something wasn't right and he just wanted to talk." This is the same man who put a woman's head between his legs and squeezed her to death. Mr. Goble gave both sisters rings and clothing. These items were seized by the police believing Mr. Goble took these items as souvenirs. It is common knowledge that a career rapist will give their friends or girlfriend the victim's clothing or jewelry so he can remember the killing experience whenever the jewelry or clothing is worn. The two women had known Sean Patrick Goble for ten months. He was convicted of several murders.

There was a young girl walking down the street in Detroit, Michigan about 15 years ago and a young man was standing on the street watching her walk. He thought it would be funny to drag her into a vacant house and rape her. As she approached him this is just what he did. According to his police record he had never been charged with rape but when the young woman left the abandoned house crying he was then labeled rapist. In his mind he was not a rapist he was just forcing a woman to have sex with him and why not. He reasoned she probably had sex before so why not with him. He knew the young woman and he wanted sex so why not drag her into an abandoned house and force her to have sex. It was not like she could do anything about it. He had been brutalizing young girls for a long time concealing his behavior from his mother. He finally got up enough nerve to go further and attack a woman on the street. He was convicted and now he is labeled a rapist. I do not know how much time he was sentenced to in prison. The two main points is he is now labeled a rapist and he thought raping his victim was funny. There was a man who lived next to the abandoned house. He was outside barbecuing and saw the altercation. He said he just thought the pair were wrestling and playing. When the young girl emerged from the building crying he realized that the pair was not playing he had witnessed the beginning of a rape.

Some men think rape is funny, getting a woman drunk and forcing her to have sex is a sport. One comedian in the 1980's said of women who were raped it is not like they haven't done it before. The sport is practiced in high school aboard school busses and then perfected in college. This is why many of your top executives of the Fortune 500 companies in this country can be a rapist. Do you think men stop raping after they graduate from college? Why do you think this country have so many sexual harassment suit associated with the work place. How many police detectives do you think have associated sexual harassment complaints with rapes that occurred on college campuses years ago? What do these men do with the proclivity they developed in college walk away and be happy with the little missus they married? Please! Men know rape is fun and profitable this is why so many men commit acts of rape whenever they

can. Men bring women to this country from Haiti, Russian, China, the Baltic etc. and sell their bodies to the highest bidder. The women who are sold are being raped and the men who purchase their service are rapists and these men are your father, brother, uncle, cousins, grandfathers and sons. The men believe woman do not suffer any injury it is not like she had not done it with a man before. The biggest lie told in America by a man is that he has never had to buy it. The next time you look at your brother ask yourself how many women has he purchased in his life time when he wanted sex then you will see why it translate that all rapists are men and that it is a 100% possibility that any man you meet is a rapist. At least ten of the women mentioned in this book left the bar with the man who later killed them. The women assumed he was just a regular Joe. Some of the women left the bar just before the men who murdered them. See the Waterford cousins. The bar is an excellent site to locate victims. In 1996 Michael Pat Lucero, 33, of Albuquerque, New Mexico was taken out to a field robbed then beaten to death by two men who befriended him in a bar. William Bradford Fischer, 22, and Adam Walter Sadlowski, 18, were charged with murder. Were these two men not monsters? Realize this fact you can meet anything in a bar. Women must always be alert. You are never alone. Just because you went to the club alone and you are leaving the bar alone does not mean you are not under observation. You must remember Mr. Arthur Bomar is watching. Mr. Arthur Bomar was in the night club watching you waiting for you to leave so he could follow you bump your car and causing you to exit your car then abduct you from the road. It is the rapist intention to catch you unaware and alone. Foil his plans by being alert and aware that Arthur Bomar, 31, is always watching. The women in this country are now entering in a period of our history where we must be assertive regarding our safety. Too much emphasis is placed on the phrase domestic violence. What we should be interested in is the phrase violence against women. Women do not only encounter violence in the home women encounter violence everywhere under all conditions even when they are unconscious in a hospital. Women encounter violence on dates, women encounter violence in the work place, women encounter violence if women are homeless, women encounter violence while working the street both from their johns and police officers. The phrase violence against women encompasses the entire range of violence associated with the female gender whereas the phrase domestic violence is limited to intimate relationships.

Do you see now why it makes no sense for emphasis to be placed on domestic violence? We need to fight the entire range of violent acts against women. These murderers are not changing our society for the better. The murderers are creating a new class of people, the motherless child.

Do not take any one to a dope house in exchange for that person giving you some dope. Do not associate with any dope dealers. Do not visit dope houses. If your spouse is using drugs leave him or her and do not give your spouse or ex-boyfriend your new address. Do not associate with any one participating in any illegal activities. Do not advise your daughter to stay in an abusive marriage for the sake of the children.

Do not associate with any one cheating on their spouse. Do not give an alibi for a cheating spouse. Do not commit adultery because you may cause the murder of your spouse.

Do not steal from work. Keep your car in good repair. You drive the new car let your husband drive the old car. Know where all of the police stations are in the area and where the police hang out. And please remember two things above all else - Nothing precludes a man from being a rapist. Any male that you approach has a 100% chance of being a rapist. May 10, 2003 The Watertown Daily Times reported that Mr. Eric Fuller of Keeseville was sentenced to the maximum sentence (32 years in prison) after being convicted of 12 felony counts including first-degree rape and endangering the welfare of a child. Mr. Fuller

was found guilty of giving alcohol to his teenage daughter and her three girlfriends. He raped a 16 year old after she passed out. Judge Andrew Halloran said at sentencing, "What you did to these four girls is just absolutely despicable." Eric Fuller's daughter left the state. Brooks Bellay, 14, of Florida raped and murdered Angel Ann Halstead, 4, August 1979 while she was following her kitten. He was sentenced to life in prison. He is scheduled for parole December 2005. Who would think a 14 year old was walking the neighborhood looking for a victim? A rapist does not wear his profession on his face nor is rape age specific. Secondly, you are always under observation. Do not think because you weigh 200 pounds, or walk with a cane, or have short hair and zero sex appeal no one is watching you. You are always under observation and you are as much a target as any woman who is a perfect size ten. Mary Jane Westine, 51, a mentally retarded woman, was raped and murdered in her Lake Worth, Florida apartment in 1985. Her neighbor, Michael Thomas White Jr. 23, said he beat her to death with a wrench. Ms. Westine just started a job at a special IBM-sponsored training program in Boca Raton. The job was a turning point in her life. This was the first time she was deemed able to work outside a rehabilitation center. Mr. White was married.

When you look into the face of a man you must understand you do not know who he is. You are not privy to his thoughts. You have no idea of his experiences. You are not with him every hour of the day. You do not know how much pornography he watches on television or his choice of magazines. You do not know his fantasies. You do not know that he has hundreds of panties hiding in the garage that he revisits every weekend. You cannot associate his education to his proclivity to murder not can you associated his patriotism to his desire to murder

Mr. Kenyon Battles Tolerton was considered a very smart man. He was a computer programmer yet he during his lifetime authorities convicted him of two murders. The first known murder he committed was in 1980 when he murdered Donna Waugh in Englewood.

The second murder he was accused of was the murder of Cissy Pamela Foster age 14. Cissy Foster lived in Colorado. Her body was found in a field September 1993. Cissy Foster was stabbed 13 times. Mr. Tolerton, 38, was not indicted for this murder until 1994. He was then three years out of prison for the murder of Ms. Waugh. It is apparent Mr. Tolerton had no desire to stop abusing women. What he was trying to do was to become proficient at murder so he could continue to kill well into his life like Messieurs Timothy Krajcir, suspect Anthony Sowell, of Ohio, suspect John Floyd Thomas, of California, suspect Lonnie Franklin, of California, Lorenzo Gilyard (53) of Missouri and suspect Walter E. Ellis (49) of Wisconsin. Mr. Krajcir killed in four states, Missouri, Illinois, Kentucky and Pennsylvania for a number of years. He left and reentered these states at will. Mr. Lorenzo Gilyard was a suspect in the murder of 13 women from April 17, 1977 to April 11, 1993. He was convicted of murdering six women based on conclusive DNA evidence. Lorenzo Gilyard was Mr. Respectability because he was employed and married. Walter E. Ellis is accused of murdering 9 women over a period of 21 years, 1986 to 2007. His trial is pending 2011. These men as well as Mr. Thomas Mr. Franklin avoid detection for a number of years. There are others you will read about. Neither education nor patriotism precludes a man from attacking women.

This is a synopsis of Mr. Tolerton history he abducted a woman from the parking lot of an area mall (she survived), he kidnapped and murdered Ms. Waugh in 1980 and was convicted in 1981. He was released from prison in 1990. He served ten year in prison for taking a woman's life. What made the state think he was rehabilitated. He was an abuser of women. We know he killed again in 1993. Are we to believe he did nothing between 1990 and 1993? Could this unknown activity not explain some of the bodies found along our highways? After Mr. Tolerton's first act of violence against a woman he should have be incarcerated indefinitely. Getting caught the first time taught him to try harder not to leave a witness. He was a convicted felon when he was arrested July 28, 1980 for the murder of Donna Waugh in Englewood. After murdering a child Mr. Tolerton is finally sentenced to life without parole plus 48 years after pleading guilty in that murder. DNA linked him to the murder of Crissy Foster.

Anthony Sowell, a Marine veteran, living in Ohio is accused of murdering 11 women, Crystal Dozier, 38, Tishana Culver, 31, Leshanda Long, 25, Michelle Mason, 45, Tonia Carmichael, 52, Nancy Cobbs, 43,



Amelda Hunter, 47, Telacia Fortson, 31, Janice Webb, 49, Kim Yvette Smith, 44 and Diane Turner, 38. All of the women are mothers. Ms. Crystal Dozier was the mother of seven children. She shared a birthday with her mother, Florence Bray. A woman complained to the police that Mr. Sowell attack her in April 2009. This investigation led to the discovery of the bodies and his subsequent arrest. It is always a woman who believes she is entitled to police protection that leads police to multiple murderers (Washington, Florida, Michigan). Anthony Sowell has already pleaded not guilty by reason of insanity. His murder trial is pending. He has no other defense since some of the bodies of his victims were found in his home. His defense attorney knows he cannot stand up in court and tell the jury Mr. Sowell did not know the bodies were in his house. Mr. Sowell spent eight years in the Marines. We wonder how many bodies Anthony Sowell left behind in North Carolina, California or Okinawa. He was proficient at killing. It is hard to believe he waited until May 2007 when he was 48 years old to begin killing. He is accused of murdering one woman in 2007, four women in 2008 and six women in 2009.

We do know bodies are left behind by soldiers leaving the corp. Mr. Urdiales left bodies behind in California. A veteran returning to Louisiana left a body behind in California. She was a mother of four children. A CIS agent pursued the Louisiana veteran until his arrest several years later.

Anthony Sowell was a convicted felon. He served 15 years in prison after pleading guilty to an attempted rape in 1989. We do not know his sentence but he was paroled in 2005. He killed in 2007. He was around 31 years old in 1990 when he entered prison. He spent 8 years in the service. So did he become violent toward women between the ages of 26 to 31? Was the 1989 rape victim his first victim causing him to leave prison determined not to return? He lived with a woman from 2007 to 2009 during the time he was murdering his victims. Could this living arrangement not have been his camouflage? I am living with a woman so no one should or will suspect me. Why does he have to be crazy? The woman he was living with said he appeared normal. Maybe Mr. Sowell was in and out crazy one day Dr. Jekyll and the next day Mr. Hyde. His defense attorney will have to find a psychiatrist who can explain this particular brand of madness and how it escaped the woman who was living with Mr. Sowell. And explain how Mr. Sowell did not deliberately (premeditation) use his girlfriend as camouflage to avoid detection. Mr. Sowell told his last victim that "You just another crack (whore) from the street, no one will know if you missing." Now who is crazy Mr. Sowell or the jury if they believe him crazy when he is tried? Is that statement not cognizant and presence of mind? Mr. Kenyon Tolerton was convicted of an assault and spent time in prison. After he was released from prison he killed Donna Waugh - No Witnesses. He did not bother with a girlfriend.

Above we said that neither education nor patriotism precludes a man from being a rapist now we say neither does age or a uniform preclude a man from being a rapist. Take a look at the chart below for Delinquency Arrests. The chart is a wakeup call that we do have juvenile rapists. Many times these young rapists act in packs attack females aboard school buses or in locker rooms or unoccupied classrooms in school buildings. This is why parents should be mindful when they allow their children to board a school bus. See the January 31, 2007 article News Digest Country Club Hills Suit says boy molested... in the Daily South town Chicago, Illinois. School buses are not safe. School systems should not rely upon the bus driver to be all knowing and a safe driver at the same time. A second adult should be aboard all school buses to maintain order. Money should not be a consideration to the safety of children. Hundreds of rapes have occurred aboard school buses where other students cheered the rapists. The other students thought the act was funny. Imagine rearing a child and he or she thinks rape is funny. Their egos were such that cheering a rapist made them feel powerful one of the strong. Their self-esteem had to be in the toilet. Do not be shocked. When bullying is allowed in school what do you expect. Bullying and the constant need for power is a precursor of rape regardless of age.

In 2019 Lorenzo London, a juvenile rapist, will be released from a Minnesota prison. He will be 29 years old young enough to rape again. He raped a woman when he was 17 years old. The rape began as a robbery. January 31, 2007 Mr. London followed a woman as she departed a bus. He robbed her then he forced her into an alley where he raped her. His image was caught on camera. Hundreds of people phoned the police when his photo was released to the media. The judge accepted the prosecutor's recommendation that Lorenzo London be tried as an adult. Mr. London pled guilty June 2007 to the charge

of rape rather than face defending against the charges of rape, kidnapping and aggravated robbery. How much do you want to bet that we shall be hearing more from Mr. London? Does anyone believe he will be rehabilitated in prison? Mr. London's victim is listed in the stats below.

Delinquency cases are all cases of youth referred to a juvenile court for violation of a law or ordinance or for seriously "antisocial" conduct. Several types of facilities are available for those adjudicated delinquents, ranging from the short term physically unrestricted environment to the long term very restrictive atmosphere.

In one of these facilities Mr. Christopher Righetti learned if he murdered his next victim he could avoid prison. The jurisdiction of the above cases was juvenile court.

### Juvenile Arrests

For statistical purposes, the FBI and most states classify as juvenile offenders persons under the age of 18 years who have committed a crime or crimes. The forcible rape figures

represents the number of violent juveniles who have committed offenses against females.

There is no age to age mapping in the relationship between juvenile offenders and their victims. The victim of a juvenile offender can be a teenager or an adult female. In other words male teenagers rape females from ages 8 to 80. If they cannot perform the act physically they use various implements.

There are associated offenses where the offender's main goal is robbery later after feeling a surge of power he decides to rape and murder no one is watching.

The above data does not include juveniles referred to juvenile court where the court has the option of releasing the offender by the age of 18 or 21 or placing the offender on probation. Jurisdiction for these cases is the district court or higher.

The next chart gives us a few of the age of our juvenile offender. Now you see why we say a rapist can be anywhere from age 10 to 70.

Imagine in this country we have teenagers who are rapist and many of the rapes take place on school buses. Data compiled from Sourcebook of Criminal Justice Statistics Table 4.7 by offense charged and age Information based on the number of reporting agencies at the time the report was assembled.

### **Bold juvenile arrests**

We have **7, 648** individuals under the age of 18 who are accused murderers and we have **23,029** individuals under the age of 18 who are accused rapists in one decade. Just as a point of reference if we consider 2000 to be a typical decade we have approximately 33,743 violent offenders under the age of 18 being produce in our country every decade. If we continue to consider 2000 as a typical decade, we can extrapolate that from 1950 to 2010, six decades, this country has produced approximately **50,472** murderers and **202,458** rapists under the age of 18. You can test our thinking by calculating the totals for arrests made for murder and total arrests made for forcible rape from 1990 to 1999. Please note we are only looking at the figures for individuals under the age of 18. Individuals between the ages of 10 and 17

have approximately 60 years of continued activity unless they are permanently stopped. Now let us go back. Look at the 18 year and older total. That figure is **71,122**. Seventy one thousands one hundred and twenty two people were arrested for the charge of murder. One hundred twenty two thousands seven hundred and forty one males (**122,741**) were arrested for the charge of rape. Now if we extrapolate these figures for the past six decades this country has produced **469,404** possible murderers and **810,090** possible rapists all over the age of 18. Do you see now why having a million rapists at large in this country is not an exaggerated figure? We use the word possible because these figures are based on the number of arrests made for the charge of murder and or forcible rape. The individuals still must be tried for the charges. Now look at the total number of suspected murderers and the suspected rapists over the age of 18 arrested for the 2000 decade. If we use these figure we see that in six decades this country has produced approximately **519,882** murderers and approximately **960,762** rapists. What is startling about these figures or better still what is frightening about these figures is that most of these individuals (**1,480,644**) are still alive and at least **960,762** are a direct threat to women. Do you see now why you should act to better address bullying in schools and the problems in our judicial system (sentencing and parole), our foster care system and our way of life? If you question the figures calculate the number of people arrested for the charge of murder and forcible rape for the 1980 and 1990 decade. Find the average of the two decades then use this average to calculate possible murderers and rapists for six decades then compare with our calculations based on the 2000 decade. We considered 10% of the total for the missing year 2000. Our percentage of error is not great. The next time you look in a man's face you will realize how great the possibility is that you are looking into the face of a rapist because the number of rapists in the country is growing and by definition all rapists are men. Not all men are rapists but we know that all rapists are men unsettlingly to say the least.

August 19, 2009 the state of Florida executed John Richard Marek for the June 17, 1983 rape and murder of Mrs. Adela Marie Simmons, 46. He murdered Mrs. Simmons June 17, 1983 when he was 21 years old. He was sentenced to death July 3, 1984 at the age of 22. He was executed August 2009 at the age of 47. He sat on death row for 25 years waiting to die. Any time you look into the face of a man you must realize you are looking into the face of a rapist. Mrs. Simmons and a friend were vacationing in Florida when their car broke down. Ms. Simmons elected to go with two men who stopped their truck offering help to the women. Supposedly the two men were to take her to a place where she could call for help. The best that can be said of Mrs. Simmons' death is she was brutalized. She eventually strangled to death with a bandana. From her picture she appeared to be a refined looking woman. She was a mother. Mr. Marek's accomplice, Raymond Wigley, was murdered in prison in 2000. Any time you look into the face of a man you must realize you are looking into the face of a rapist. I do not care if the man is White; the young and White kill as often and with as much frequency as the old and Black. Nothing precludes a man from being a rapist. Nothing! Any time you look into the face of a man you must realize you are looking into the face of a rapist. This is a lifesaving assumption. To think counter to this assumption is to put your life in that man's hands. Accepting this fact may save your life. As he lay dying Mr. Marek said, "Jesus, remembers the sinners." The death of Adela Marie Simmons was a horrendous murder that shocked even the most sensible. It was also a murder that was remembered. Andrei Trach, the son of Simmons' friend Jean Trach, attended the execution with his sister, Tanya Trach. They said, "The waiting had gone on long enough. That animal was afforded the time to say goodbye to the ones he loved and make peace with his maker. "Ms. Adela Simmons, the victim, was afforded no such luxury." The problem with Mr. Marek is he did not realize he was different than other men. He thought he was normal. He thought a man should take advantage of the vulnerable and helpless in society. If you see someone that needs help take advantage of them. Taking advantage of people is smart. He thought it would be easy to take a life. What he did not understand is his action caused him to take his own life. He did not know he was descending into hell.

### **Dressed In Blue**

**February 2010** Chickasaw, Alabama Police Officer Bob Ingle was convicted by a jury of rape, sodomy and sex abuse. Bob Ingle was convicted of raping his step-daughter, Rebecca McEvoy. It only took the jury a few hours to come back with the guilty verdict. Before sentencing he committed suicide.

**June 2, 2010** New York Police Officer Wilfredo Rosario, 42, a married father of five, was convicted of sexually abusing two women. In January he was convicted of misconduct for telling a teenager he'd tear up a ticket if she did him a sexual favor. He is scheduled to be tried on a charge of raping a woman who had come to a police station looking for information on children's programs

Officer Jeffrey Thorn, 26, was fired June 29, 2010 for sexually assaulting a female Thursday, **June 24, 2010**. Officer Thorn allegedly picked the woman up, drove her to an isolated area and demanded she perform certain sex acts or she would be taken to jail. The woman refused several times. The conversation between the officer and the woman was recorded on the cruiser's audio recording system. Remember what we said about bullies and the need for power. A police sergeant and supervisor working in the area noticed Officer Thorn's police cruiser was idled for quite a while and went and investigated. When the police sergeant went to investigate why the patrol car was sitting for so long he probably saved that woman's life. Officer Jeffrey Thorn faces aggravated sexual assault charges. After Officer Thorn's arrest Assistant Chief Floyd Simpson, commander of the patrol bureau, said, "Dallas police officers will respect the rights of our citizens. Anything, in my opinion, less than that is unacceptable." We have a question if convicted will Officer Jeffrey Thorn be required to register as a sex offender.

**June 29, 2010** Mesa Arizona Police Officer Justin Bowman, 31, was sentenced to 682 years in prison after being convicted on 32 counts, including child molestation, sexual conduct with a minor, sexual exploitation of a minor, public sexual indecency, and furnishing harmful items to a minor. Some of the sex crimes involved a 10 year old boy and a 9 year old girl. He received the maximum sentence of 15 consecutive life terms in prison. Officer Bowman was married.

**August 2009** Thomas Orth, 40, a Massachusetts Bay Transportation Authority officer, was convicted of rape of a child with force. He was accused of raping a 15 year old July 2006. He was indicted in 2008 and convicted August 3, 2009. Officer Orth taught a patrol-procedures course for four years at the MBTA Transit Police Academy in Quincy. This is the same academy where the FBI was investigating allegations that supervisors coerced sex from female cadets. Remember what we said about power and bullies and the face of a rapist. If guilty these supervisors would not have you believe they were rapists. When you force sex or purchase sex you are a rapist. A woman being sold for sex has no control over her circumstances. She has to do as she is told therefore when a man pays to have sex with a Russian woman he is a rapist. Only the dollar he spends makes him believe he has struck a bargain with his victim.

**May 10, 2009** Greenville, Mississippi Police officer Benjamin Roberson, 26, was found guilty of by a jury of the sexual battery of a 14-year-old girl who became pregnant. Officer Roberson was fired after his arraignment.

**August 13, 2008** Bloomington, Illinois police sergeant Jeff Pelo, 43, was sentenced to 440 years in prison for the rape of four women and stalking a fifth. He was convicted of 35 counts including 25 counts of aggravated criminal sexual assault, three counts of home invasion, two counts of burglary and other counts. The assaults occurred between 2002 and 2005. Jeff Pelo was married.

**December 2, 2009** Alexander Police Officer Jeffrey Garcia was sentenced to a 100 years in prison after a jury found him guilty of the rape and sexual abuse of three children. The Saline County jury deliberated 15 minutes.

**April 3, 2008** an East Windsor, Connecticut police officer, Darren Dempsey (Darren Seligman, 39) pleaded guilty to trying to sexually entice an 11 year old girl through the Internet. He pled guilty to one count of using an interstate facility to transmit information about a minor.

**September 9, 2008** Central Texas Police Officer, Jimmy Lewis Fennell Jr. 35, was convicted of kidnapping, and improper sexual activity with a person in custody (the rape of a woman who was drunk). Judge Burt Carnes refused to allow the officer to plead guilty as a plea bargain and serve two years in prison and 10 years' probation.

**November 5, 2008** Miami Dade Police Officer Paul Brosky, 40, was convicted of sexual battery and kidnapping. Officer Brosky allegedly pulled over a vehicle August 2002 and told the 17-year-old female driver and her boyfriend to follow him to an isolated parking lot. Brosky then assaulted the girl and released the couple. He is scheduled to stand trial for molesting another teenage girl and threatening to arrest her if she didn't do certain favors for him. There is nothing like power.

Louisiana Police Officer Len Davis, 31, is again to be sentenced to death in ordering the murder of witness, Kim Groves October 13, 1994. A federal prosecutor said Officer Davis was acting under the color of law when he had Kim Groves murdered. Ms. Kim Groves, 32, worked as a security guard. She was a mother of four. She thought it was wrong for a police officer to beat a person so she agreed to testify against Officer Davis. Officer Davis decided he had the power to do away with Ms. Groves. Officer Davis did what the prosecutor said he did and two juries believed the charges against him. The shooter was 28 year old Paul Cool Hardy. Mr. Hardy escaped the death penalty the second time around.

**March 24, 2006** Woburn, Massachusetts Police Officer, Paul Meaney, 44, was found guilty of two counts of aggravated rape, indecent assault and battery and breaking and entering to commit a felony. The victim was 23 years old and was repeatedly raped June 26, 2003. There is nothing like power and a uniform.

**June 3, 2005** Lufkin, Texas Police officer Ronnie Mural Gurganus Jr., 38, pleaded guilty to sexually exploiting children and possessing child pornography. He got a child to engage in sexual behavior in order to produce child pornography. He was also convicted of the rape of a child.

**April 23, 2004** Baytown, Texas Police Officer James Mulvihill, 43, was convicted abusing his two daughters (aggravated sexual assault of a child under 14). He was sentenced to 20 years in prison.

**May 9, 2002** Danville New Hampshire Police Officer Alan Cullen, 49, was convicted of five counts of aggravated felonious sexual assault against two girls, ages 9 and 10, in 1996 and 1997. He was sentenced to 37.5 to 75 years in prison. Notice the sentence all rapists should be sentenced this harshly. Women should not be worried that rapists will be released from prison in 5 to 7 years. Rapists should be too old to walk when they are paroled from prison.

**February 13, 2001** Berkley, Michigan Police Officer Brent A. Smith, 27, was charged with three counts of second-degree criminal sexual conduct for assaulting an 18 year old woman in the back of his patrol car December 23, 2000 in the parking lot of a popular local bar and restaurant. He was convicted September 17, 2001. He was sentenced to 4 to 15 years in prison. There is nothing like power.

Los Lunas, New Mexico Police Officer Lance Fleming, 63, was convicted December 12, 2001 by a District Judge Camille Martinez-Olguin on two counts of raping a child, criminal sexual penetration of a child under... He took his chances with a judge rather than face and jury and lost.

**February 27, 1998** Monroe North Carolina Police Officer Josh Griffin, 24, was found guilty of first-degree kidnapping and first-degree murder in the death of Kim Medlin, 26. Ms. Medlin disappeared while driving home from her waitress job in Charlotte in the early morning hours of March 29, 1997. Officer Griffin persisted in his denial until 2001 when he admitted he murdered Kim Medlin. Kim Medlin was beaten choked with a flashlight and stomped in the back. She was strangled and her neck was broken. Kim Medlin is not the only woman murdered by a patrolman after her car was stopped for a fake traffic violation.

**June 23, 1997** Police Officer Gilberto Chavero Jr. was convicted of the March 23, 1996, murder of Iris Yvette Hidalgo, a McAllen High School honor student. Her blood was found in his patrol car. She was raped and stabbed to death.

**August 25, 1992** Harris County Sheriff's Deputy Joseph Kent McGowan was charged with murder after the death of Mrs. Susan Diane Harrison White. She was shot to death in her home. Deputy McGowan was convicted in 1994. A retrial was ordered after an appeal. In 2002 he was convicted for the second time. June 5, 2003 the First Court of Appeals upheld his conviction. Mrs. White was a mother.

Florida Highway Patrol Trooper Timothy Scott Harris, 31 was convicted of first-degree murder and rape of Lorraine Hendricks from Jacksonville, Florida. She was abducted from the Interstate Highway 95 March 4, 1990 where her assailant used a patrol car and took her to an isolated area and strangled her to death. Ms. Hendricks was choked to death. She was forced to strip to the amusement of her assailant. There is nothing like power and the uniform. Lorraine Hendricks, 43, was a mother. Another murderer in uniform was Marin County deputy sheriff, Gerard Schaefer. He also murdered several women while patrolling Florida highways. Deputy Schaefer was convicted and later murdered in prison. He was suspected in the murder of eleven women.

**May 26, 1976** Rookie Police Officer James Paul Vanderbilt Jr. was convicted of kidnapping and shooting Katina Moyer, 16, in Amarillo, Texas April 1, 1975. He was sentenced to death. He was still alive in 1995. Katina Moyer was handcuffed when she was shot in the head.

**In 1988** Shreveport Louisiana Police Officer Melvin Allen, 38, was fired from the police force. He was subsequently convicted of sexual charges involving young girls. He paroled in 1992. By September 1992 he was accused of sexually abusing an 8 year old. He was convicted of this charge in 1993.

**December 2, 2009** Alexander Officer Jeffrey Garica was sentenced to 100 years raping and sexually abusing three children in the same family. If you do not read any other article suggested please read Garcia guilty of child rape, get 100 years, Thursday, December 3, 2009 Benton Inquirer Benton Arkansas. Officer Garcia behavior is the reason why single women should never bring an non related male into their home when there are vulnerable children (ages 0 to 18) present. In this case it believed that the mother knew her children were being raped and she did nothing. Why is she not in prison serving time right along with Officer Garcia? Officer Jeffrey Garica probably thought since he was helping to support the children he they should pay him in kind. Please take note of all the police officers that abuse children. This is not a coincidence. When a man abuses a child he derives the greatest feeling of power. This is why we say every time you look in the face of a man you may be looking into the face of a rapist all he needs is an opportunity. We did not write about all the cases we have regarding police officers abusing their power and we did not include cases where the wives, ex wives, girlfriends and ex-girlfriends were murdered by the police officer. Do not bring a rapist into your home to visit with your children

#### **Benny Mora Jr., 15 and Mister Saunders, 13**

Melissa Albert, 34

Melissa Albert lived in Albuquerque, New Mexico. She decided to move January 8, 2002 after her apartment had been broken into. During the moved she was raped and stabbed to death. Her alleged assailants were teenagers. Murderer Status: Mister Saunders, 13, and Benny Mora Jr., 15, were charged with murder. Mister Saunders was her neighbor. In eight years they may be out of juvenile detention ready to rape again. Do you think it is possible for rehabilitation for minds that conceive rape and murder? Shall they be given a second chance to rape and murder?

#### **Thomas Dee Huskey, 32, Tennessee 1991 - 1992**

Susan E. Stone, 30 (LON)  
Darlene Smith, 22

In the fall of 1992 the police in Knox County had a series of rapes and murders to solve. Four women reported to them of being raped in 1991 and 1992 and the bodies of four women were found from October 20, 1992 to October 27, 1992. A 32 year old woman was raped October 5, 1992. Another woman was raped July 18, 1992. Their assailant was armed. He raped two women at the zoo and two women in the Caban Lane woods. One of the women said he posed as a nice guy offering her a ride later only to take her into the woods and raped her. The bodies found in the area were Susan E. Stone, Darlene Smith, Patricia Rose Anderson, and Patricia Johnson. They were murdered in this order. Three of the women were strangled to death. One woman died of a seizure. Her family said she suffered seizures whenever she was frightened. Her assailant described for the police the seizure just before she died. The body of Patricia Anderson was found October 20, 1992. The body of Darlene Smith was found October 26, 1992 along with the body of Patricia Johnson. The skeletal remains of Susan Stone were found October 30, 1992. The police arrested Thomas Dee Huskey age 32 October 21, 1992. He was an unemployed animal trainer. He was the subject of much discussion of women trying to earn a living. One victim took the police to the area where the rape occurred. While there the police heard a woman scream and caught Mr. Huskey raping another woman. The trial did not go anywhere because victim refused to testify. Nevertheless the rape investigation continued until Mr. Huskey was arrested and indicted November 1992. the indictment contains five counts of aggravated rape, two of rape, two of especially aggravated kidnapping, 11 of aggravated kidnapping, two of aggravated robbery and one of robbery. Mr. Huskey was convicted in 1995 and 1996 of raping several women. He refused to pay for sex. He was sentenced to 66 years in prison. The prosecution surmised that Mr. Huskey began killing September 1992. He was charged with four counts of first-degree murder in 1993. Huskey has pleaded innocent by reason of insanity. He claimed to have multiple personality just like the Bellingham Washington murderer Bianchi. The defense claimed Huskey was possessed of multiple personalities he can't control or remember, including an evil alter ego named `Kyle,' who confessed to the killings. The prosecution says Huskey was faking a ruse to avoid a death sentence. The prosecutor had decided to seek the death penalty. A mistrial was declared January 1999. The jury of nine women and three men could not decide whether he was insane when he committed the murders after four days of deliberation. The jury was dead locked at 6 to 6. The prosecutor said that, even if Huskey suffered from a mental defect, he could be convicted if he could "appreciate the wrongfulness of his conduct" or retained a "substantial capacity to conform his conduct." Mental health experts disagreed on whether Huskey suffers from multiple personalities. Mr. Huskey was a divorced father of two and a former Knoxville Zoo worker.

**Daniel G. Payton, 37 (35) (30) – Ohio 1997, 2002 Truck Driver**  
Nellie Evelyn Howard, 72  
Tabitha Jo Bogart, 21

Nellie Howard lived in Scioto County near Portsmouth, Ohio. She was murdered in 1997. Her body was found in a wooded area near Minford. Tabitha Bogart was hitchhiking in Fayette County from Texas to Ohio when she was murdered in 2002. A truck driver found her body near Interstate 75 on Route 35. The murders of these two women were linked by DNA in 2004 to the same assailant. Mr. Payton was not charged for these murders. Instead he was easily convicted for rape. Just after he pleaded guilty February 23, 2004 to three counts of rape one of which was the rape of a 12-year old girl in Scioto County, Ohio Mr. Daniel Payton's lawyer, Mr. Pat Apel said, "He was very remorseful for his actions. He wanted to save his family any more embarrassment" and avoid a trial. Really! Mr. Payton was once Nellie Howard's neighbor. She knew him. She would not necessarily be frightened of him. Ms. Bogart was hitchhiking. Mr. Payton was once a truck driver. Scioto County Common Pleas Judge Howard Harcha III sentenced Payton to consecutive sentences of 10 years each on two rape counts and 10-years-to-life imprisonment on a rape charge specifying him a sexually violent predator. For these crimes he may be sentenced to 30 years in prison. In exchange for Payton's guilty plea, prosecutors dropped a fourth rape charge and specifications that force was used to commit the crimes. Payton threatened his victim with a stun gun. He wants to spare his family embarrassment. How about the pain and suffering of his victims and their families? October 27, 2005 Daniel Payton pleaded guilty to the aggravated rape and murder of Nellie Evelyn Howard. He was sentenced to 29 years to life for her death. February 23, 2006 Mr. Payton pleaded guilty to the kidnapping, rape and aggravated murder of Tabitha Jo Bogart. He avoided the death penalty. Nellie Howard was murdered in 1997. Tabitha Bogart was murdered in 2002 what did he do in between this time. How long was he a truck driver? Did he travel through the nine states where bodies were found? **Daniel Payton has at least 12,045 days to spend in prison before reaching the age 70.**

**Donald Eugene Couch, 28 California Laborer - Parolee**

In 1986 the police in Chula Vista, California were looking for a Mr. Donald Eugene Couch for the murder of Linda Kay Freeby. Mr. Couch, alias, Donald Stokes, was paroled from prison March 1985. He served three years in prison for burglary and a sexual assault. A no-bail warrant was issued for his arrest February 1986 on a parole violation because evidence taken from the Linda Freeby's murder scene implicated him in her murder. Ms. Freeby's body was found January 24, 1986 in Palm City. She was strangled to death and her body was left on the street. Linda Freeby also lived in Chula Vista, California.

Joan Mary Burghardt, Jessica Fortney and Charlotte Schmoyer lived in Pennsylvania. Joan Mary Burghardt worked as a nurse's aide. She was murdered in her home August 1992. She was hit 37 times in the head. Charlotte Schmoyer, 15, worked as a newspaper delivery person for the Morning Call. June 9, 1993 she was abducted from her route. She was stabbed 16 times in the back, 6 times in the neck and 3 other stab wounds to the body. Jessica Fortney's daughter found her body in her home June 14, 1993. She was beaten and strangled. Fortney was killed on the first floor of a three-story row home, while family members slept upstairs. June 20, 1992 a 5 year old child was assaulted in her home while her

parents slept. When the assailant left the child called her mother. Later the child identified Harvey Robinson as her attacker. He choked the child. He lived with his mother. Harvey Robinson was arrested July 31, 1993 after he broke into a woman's home for the third time. Harvey M. Robinson, 19, was charged with three rapes and an attempted murder Robinson was convicted April 1994 and sentenced to 40 to 80 years in prison. Harvey Robinson will be eligible for parole at the age of 59. The police were staking out the woman's house. He raped, choked and beat the woman on her front lawn June 18, 1993. The woman was awarded a civilian commendation for helping the police by allowing them to stake out her home. Mr. Robinson committed his first criminal offense age 9. How do you explain evil? How do you explain a man entering a house raping a child and living with his behavior? How do you explain a man entering a woman's house and raping her on her lawn and returning to that house for a third time to inflict fear and pain? The answer is fear. He wanted to inflict fear. He wanted to think about the fear generated in his victim. He wanted to imagine how they felt and believing he had the power to control their lives by returning time and time again inflicting the same pain over and over again. He was pushing himself testing himself seeing how far he could go. He was telling himself I am strong, I am brave, I am invincible. No one can do anything about me. This young man was clearly just getting started he had a series of plans to put into effect. This man was dedicated to evil and he did not want to change this is why counseling had no effect on him. Mr. Robinson killed Mrs. Burghardt in 1992 then he was arrested September 1992 and placed in a juvenile facility for another offense. He was released from the juvenile facility May 1993 the next month he began killing again. When Robinson was charged for the murders and rapes of Joan Mary Burghardt, Jessica Fortney, Charlotte Schmoyer, and the rape of the 5 year old his attorney asked for three separate trials. His strategy, avoid the death penalty. At 3:34 p.m., November 10, 1994, the court clerk stood and read: "We, the jury, unanimously sentence the defendant to death." The judge and the jury were visibly upset.

Cheryl Burnett was raped and murdered June 5, 1965. The only items taken were a camera and a crucifix. The official cause of death was manual strangulation. Evidence recovered from the crime scene revealed that the victim had been sexually assaulted and that evidence provided a DNA profile of the offender. June 14, 1965, Scripps Institution of Oceanography graduate student William Dowd was found beaten to death in his apartment in San Diego. June 23, 1965 Lola Mercer was assaulted and raped. Her husband, Louis Mercer, 63 was bludgeoned to death trying to defend his wife. In 1965 Clyde Carl Wilkerson was convicted of a sexual assault in California. Wilkerson was convicted in November 1965 of brutally assaulting a La Mesa woman after he broke into her apartment in July 1965. January 25, 1976 a 32 year old woman using a telephone at a gas station in Judsonia, Arkansas was raped. In 2002 Detectives in Tulsa, Okla., linked Clyde Wilkerson through DNA to the rape and murder of Geraldine Martin, 28, in February 1975. Geraldine Martin lived in Tulsa, Oklahoma. Geraldine Martin, 28, was abducted February 5, 1975, from the parking lot of the downtown campus of the Tulsa Junior College. Her body was found three weeks later in a vacant apartment. She'd been strangled and raped. Evidence collected from the rape of Mrs. Mercer, the murder of her husband and the murder of Cheryl Burnett was linked to Clyde Wilkerson through his DNA. He pleaded guilty March 2003 based on a warrant for two murders in El Cajon, California. Clyde Carl Wilkerson was sentenced to an indeterminate life sentence with the possibility of parole in 7 years. California's death-penalty law was not in place when Mr. Mercer and Ms. Burnett were murdered. He will be eligible for parole in Oklahoma in 20 years. Clyde Wilkerson was not eligible for capital punishment or life without parole in Oklahoma because those punishments were not options at the time of his crime. The death penalty was reinstated here in 1977. Wilkerson told detectives he had routinely used methamphetamine since his teens and would often manufacture it. He

used victims' credit cards and forged their checks. Clyde Carl Wilkerson was a long-distance truck driver and had been in every state in the continental United States. **Clyde Wilkerson has at least 2,190 days to spend in prison until his death at age 70.**

Susan Clarke was a teenager living in Chicago, Illinois who earned extra money by babysitting. She was abducted while walking home from a babysitting job. She raped then shot, stabbed and eviscerated August 25, 1977. Murderer Status: Ralph Raymond Andrews 54, (32) was charged in 1999 with first-degree murder, rape and aggravated kidnapping while in prison serving a life sentence without parole for the sexual assault and August 12, 1991 murder of Virginia Griffin. He was 46 years old. Mrs. Griffin was stabbed 36 times and eviscerated. He used a stun gun. This man was a brutal murderer. Virginia Griffin was introduced to Mr. Andrews the night she was murdered. He worked as a bus driver and caretaker. When Mr. Andrews reportedly told a fellow inmate in 1998 about other murders he committed, the inmate notified authorities, who recorded Mr. Andrew's conversation regarding the murder of Susan Clarke. He was always a suspect. He had history of similar attacks on teen-age girls, girlfriends, acquaintances and he lived in the area. He was accused of other sexual offenses in Indiana, Wisconsin and Michigan. He was a prime suspect in the September 1972 strangulation of Amy Alden, 15 who lived in Evanston, Illinois; the November 18, 1972 strangulation murder of Robin Feuerriegel, 17 who lived Evanston, Illinois. She was hitchhiking. And the May 1977 murder of Laura Williams, 16. She was stabbed to death. And the April 1978 killing of Arvella Thomas, 14, who lived in Chicago, Illinois. July 1994 the prosecutor was seeking the death penalty in the death Virginia Griffin. His previous victims testified at his trial. He was acquitted of attempted murder and rape several times. He had a history of severe alcohol abuse. He shot Floyd Foster during a hunting trip. The shooting was deemed an accident. At his sentencing in 1993 Ralph Andrews had approximately 8,760 days to spend in prison before reaching the age 70. Look at the lives he destroyed. **Ralph Andrews was convicted for the murder of Susan Clark in 1993 and Virginia Griffin in 1994.**

**Edward J. Mayrand Jr., 48 Providence, Rhode Island, 1995**

Patricia Paquette lived in Providence, Rhode Island. She was a mother of three children. Her body was found December, 21, 1994 in a vacant house in Providence, Rhode Island. She was dismembered. She died of asphyxiation. She was reported missing December 8, 1994, the day she was seen with the suspect in her murder. She was with Mr. Edward Mayrand at the time of her disappearance. She recently began a friendship with him. A warrant was issued for his arrest. Edward Mayrand was arrested in a shelter in New Haven Connecticut February 6, 1995. Mr. Mayrand was previously convicted of rape in Massachusetts and assault with intent to commit rape in New Hampshire. He was released from a New Hampshire prison January 22, 1994 and moved to Providence, Rhode Island. He is also a suspect in the killing of Kathleen M. Daneault of Gardner in 1983. Her body was found on a path in Gardner November 18, 1983. She was seen drinking with Mr. Mayrand November 17, 1983. In 1987 Mr. Mayrand was an associate of Judith Whitney of Winchester, New Hampshire. Her body was found and her case remains

unsolved. Mr. Mayrand was a suspect. He and Judith Whitney were acquaintances. He uses drugs and alcohol. Mr. Mayrand was an Army deserter in 1967. After a plea bargain he was sentenced to 35 years in prison for the murder of Patricia Paquette. He cried in court. **Edward Mayrand has at least 8,030 days to spend in prison before he reaches the age of 70.**

Lisa Dyke lived in Florida. She was approximately 8 months pregnant. She was babysitting for a friend January 26, 1993 when she was assaulted. She was raped, bitten and stabbed eighteen times. Her assailant, Ronnie Williams, was out of prison eight months when he murdered Lisa Dyke. Why he was released from prison because he had been imprisoned for murdering another teenager? He was released because the prisons were overcrowded. Lisa Dyke gave birth to a son before she died. Ronnie Williams is now on death row. A new trial was ordered in 2001. He was again sentenced to death April 15, 2004. In 2007 the Florida Supreme Court upheld the death sentence. Lisa Dyke was babysitting in his ex-girlfriend's apartment. He was angry for being rejected and attacked Lisa Dyke. There were bite marks on the body. In 1984 Ronnie Williams killed Gaynel Jeffrey, the sister of his ex-girlfriend. His ex-girlfriend learned he had been charged with rape and dumped him. Learning of this rejection he drove to her home and attacked her sister. He was convicted of child molestation and murder. He was only sentenced to 17 years in prison. He served 7 years. He killed Lisashantil Dyke because he current girlfriend had dumped him and Lisashantil Dyke was her friend. Mr. Williams was born June 19, 1962. The death of Lisashantil Dyke is the reason why murderers should not be paroled.

Police in Florida had several unsolved murders. The body of Tommie Lou Whiddon was found March 27, 1985 on the beach. She had been sunbathing on Okaloosa Island. Her throat was slashed. The body of Cindy Condra was found September 16, 1986. She was stabbed 21 times. The body of Audrey Gygi was found May 20, 1987 in the Ocean City area. She was stabbed to death. She worked as an electronic assembler. These cases remained unsolved until 1994. In 1987 Frank Walls was working as a dishwasher when he was tried for the July 22, 1987 murders of Edward Algers and Ann Peterson who were shot to death in their home. He was convicted and sentenced to death for the murder of Mr. Algers and a life sentence for the death of Ann Peterson. While on death row in 1993 he was indicted for the first-degree murder of Audrey Gygi. During a plea agreement he admitted he murdered Ms. Whiddon and Ms. Condra. October 5, 1994 Mr. Walls agreed to plead no contest to Audrey Gygi's murder. The prosecutors agreed not to charge him with any murders he admitted to in the interview with investigators (immunity from prosecution), and further agreed not seek the death penalty in Audrey Gygi's death. He received a life sentence for her death but he was not sentence in the deaths of Tommie Whiddon and Cindy Conra. Frank Walls remains a suspect in the July 23, 1986 beating of Lindsey O. Sams, 35, of Columbus, Mississippi. She died June 1987 of her injuries in Miramar Beach. One interviewer said Frank Walls said he committed his first murder when he was 14 causing him to be a suspect in the October 12, 1982 stabbing death of Renee Johnson, 26, of Florosa. She was found October 12, 1982. He did have a girlfriend. October 7, 2008 his attorney argued before the Florida Supreme Court that Mr. Walls was mentally retarded therefore not subject to the death penalty.

**Samuel L. Smithers, 45 Florida   1996   STD**

Christy Elizabeth Cowan, 31 (LON)

Denise Elaine Roach, 24, (LON)

The bodies of Denise Roach and Christy Cowan were found May 26, 1996, in a pond off Turkey Creek Road at a residence where Samuel Smithers worked as a caretaker. Ms. Roach was beaten and stabbed; Ms. Cowan was strangled and hacked with an ax. Murderer Status: Samuel L. Smithers, 45, a church deacon was charged with two counts of first-degree murder. December 1998 he was convicted. January 1999 a jury deliberated 2.5 hours and he was sentenced to death by the jury. He was divorced with one son. Roach's skull was crushed after she was slammed against the wall so hard that blood splattered across it. Mr. Smithers then stabbed her in the head repeatedly before dumping her body in a pond. Two weeks later, Samuel Smithers smashed Cowan's head with an ax, strangled her and left her for dead in the same pond. Mr. Smithers used a hoe to silence her when he thought she called out from the pond. The Florida Supreme Court rejected his appeal May 2002.

**Jerry Marcus, 36, Alabama, Georgia, Mississippi and Tennessee 1971 to 1987**

Dorothy Davis lived in Starkville, Mississippi she worked as a waitress. Waiting on tables lends itself to catering to your customers. A waitress may not be leery of a person she sees periodically visiting her restaurant. April 10, 1987 Dorothy Davis' body was found in Webster County. She was strangled to death. She went on a date with Jerry Marcus at a disco. When he was arrested in Columbus, Mississippi April 15, 1987 he told where the body was located. Jerry Marcus was suspected of murders in Mobile, Alabama, Knoxville, Tennessee and Tuskegee, Alabama. The victims were strangled to death. Wadine Ellerbe was reported missing September 16, 1986 in Tuskegee, Alabama. The police found her body in 1987 buried after a statement Mr. Marcus made. Francine Davis body was found murdered in her apartment October 31, 1984 in Knoxville, Tennessee. The police began looking for a relationship between Jerry Marcus and Wyvette Chambers whose body was found in 1986 in Alabama. Murderer Status: Jerry Marcus, 36, a construction worker who was unemployed was accused of killing seven women in three states. When people were interviewed they said he played football in high school. He was a starting quarterback in high school. He was a regular Joe. Construction workers like truck drivers move from state to state based on the work an opportunity. He was sentenced to life in Alabama in 1988. **Jerry Marcus had 12, 045 days to spend in prison before reaching the age 70.**

**Keith Zon Doolin, 23 California 1994 to 1995 STD**

Between 1994 and 1995 a man in California shot six women. Four of the women survived their injuries two did not. The women were shot with a .45 caliber handgun. There was no provocation for the shootings. Inez Cantu Espinoza, 30, was shot to death July 29, 1995. Approximately two months later Peggy Ann Tucker, 27, was raped and shot to death September 19, 1995. Forensic evidence and victim's identification allowed for the arrested of Keith Zon Doolin. Keith Zon Doolin, 23, a truck driver was convicted of murder May 7, 1996. May 21, 1996 the jury recommended that Mr. Doolin be sentenced to death. June 17, 1996 Judge James Quaschnick obliges the jury by sentencing Mr. Keith Zon Doolin to death at the age of 23 years. He was sentenced to death June 17, 1996. His mother was in the courtroom. He killed two women because he did not want to pay for sex. He was also convicted of



attempting to murder Alice Alva, Debbie Cruz, Marlene Mendibles and Stephanie Kachman in separate shootings in 1994 and 1995. The murderer was found because Peggy's boyfriend wrote the license number down of the car he saw her being driven away.

### **Robert L. Reynolds, 37 – Illinois 2002**

Paulleen Godoy, 31, (LON)

Paulleen Godoy lived in Springfield, Illinois. She was choked to death in 2002. Her body was found August 18, 2002. Robert L Reynolds, 37, was charged with murder. January 27, 2005 he pleaded guilty to second-degree murder but mentally ill. He was sentenced to 20 years in prison. In Illinois the maximum sentence for second-degree is 20 years in prison. Like Mr. Robert Sylvester Alston of North Carolina he disposed of his victim's body near his home. Mr. Reynolds is a violent man July 26, 2002 he raped a woman while holding scissors to her throat. He committed rape in 1994. Five women filed protection orders against Mr. Reynolds since 1988. Mr. Reynolds was just getting started. He had assaulted and bullied and threatened several women finally in 2002 he killed. This murder took place just before or after he raped a woman July 26, 2002. Maybe he had grown tired of fooling around with women and felt the best way to deal with women was to kill them. **Robert Reynolds has at least 7,300 days to spend in prison until his discharge at age 58.** At the age of 58 he can rape and murder again.

### **Kevin Charles Johnson, 25 Florida**

**Assault victim (survived)**

January 3, 1997 Venecia Kinsey, 37 was found under an overpass in West Palm Beach Florida. She was taken to a hospital where she remained in a coma for ten days. She lost an eye from the beating. Two weeks later the body of Debbie Montgomery was found in West Beach, Florida. She was beaten raped then strangled to death. May 1997 the body of Latoyia Williams was found. She was two months pregnant. She was strangled to death. The police received a tip that the man they were seeking was Kevin Johnson. He was questioned and his DNA was taken and matched the biological evidence taken from his victims. Kevin Johnson, 25, was charged on Monday with two counts of first-degree murder in the deaths of Debbie Montgomery and Latoia Williams He also was charged with attempted first-degree murder in the savage beating in January of Venecia Kinsey. He was tried and found guilty of two counts of murder and attempted murder. He was sentenced to 30 years in prison per murder and 25 years for attempted murder. **Kevin Charles Johnson has at least 7,300 days to spend in prison until his death at age 70.** Mr. Johnson was smoke crack with each of his victims. Kevin Johnson told police he feared the "monster" within him which, when fed by crack cocaine, emerged when he murdered two women

### **Rickie Lynn Rhodes, 24 Florida 1997**

Mrs. Ching Lin Payne, 43, of St. Cloud.

Ching Lin Payne's body was found Wednesday, April 29, 1997, on a golf course near Sea World Orlando, Florida. Murderer Status: Rickie Lynn Rhodes, 24, was charged with the first-degree murder. He was a drifter. He had a girlfriend. He was also a father. Rickie Rhodes, 25, was another man in Florida who pleaded guilty to first-degree murder December 19, 1998 to avoid the death penalty. Rhodes is accused of fatally beating and mutilating **Ching Lin Payne, 44**, a mother of three. Mrs. Payne was from St. Cloud, Minnesota. The two had met at a Kissimmee restaurant April 30, 1997 and left together, according to witnesses. Her naked body was found later at the International Golf Club on International Drive. Rickie Rhodes was charged with first-degree murder and two counts of sexual battery. He was arrested shortly after Ching Payne body was found. He was arrested at his girlfriend's home. Like many killers before him he said he did not mean to kill Ching Payne when he hit her on the head. He said he was drinking and using

marijuana. After the murder when killers have to face the public that is when they come up with these fantastic stories. **Ricky Rhodes has at least 7,300 days to spend in prison until his death at age 70.**

**Unknown Assailant Ohio 1992**

Roberta Poirier lived in Dayton, Ohio. She was 5 feet 3 inches tall. She was last seen June 19, 1992. Her body was found in a field Monday June 22, 1992. Her wrists and ankles were bound with duct tape and a plastic bag covered her head. Murderer Status: unsolved.

**James Allen Kinney, 52 (49) Washington 1998**

Keri Sherlock lived in Braintree, Massachusetts. She flew to Bellingham, Washington to visit family members and to scout the universities in the area. Her body was found October 3, 1998 by hikers. She died of head injuries. During the murder investigation it was learned Ms. Sherlock met James Kinney, 49. He may have tricked her into thinking he could help her land a job. A warrant was issued October 8, 1998. After a two year search he was apprehended in North Carolina and charged with aggravated murder March 2001. December 12, 2001 he pleaded guilty after a deal was made where the prosecutor would not seek the death penalty. He was sentenced to life in prison without parole. He had a history of mental illness. James Kinney was a Vietnam veteran. He was hospitalized at least 26 times during the past 20 years for a host of mental illnesses, including paranoid schizophrenia, schizophrenia, bipolar disorder and schizoaffective disorder. Combat exacerbated his mental illness. He was working construction. He had a girlfriend when he was arrested. It was reported that Mr. Kinney was a person of interest in the murder of Billie Jo Watson, 22, of Grand Rapids, Michigan. She was raped and strangled in 1997. DNA evidence ruled out Mr. Kinney for this murder. **James Kinney has at least 6,570 days to spend in prison until he reaches the of age 70.**

**Frederick Pete Cox, 47 – Florida convicted**

After a long and hard search the police in Florida learned the name of the man who murdered Peggy Logan, Stephanie Singleton and Mary Ann Voepel and assaulted two other women. The first to die was Patricia Logan, 40. Her body was found on a wooded trail in March 1997. She had been shot execution-style. April 29, 1997 two more women died the same way within about 24 hours of each other. The women were shot to death and found off of Interstate 4. The women were Mary Ann Voepel, 22, and Stephanie Singleton, 28. Ms. Voepel and Ms. Singleton were friends. All three women were left naked in woods and posed in degrading positions. A \$10,000 reward was offered for information. During this time Tracy Adams was propositioned by a man. She rejected him for this slight he shot her. After she recovered Ms. Adams was with her daughter in a grocery store when she saw the man who assaulted her. She wrote down the tag number on his car and called the police. For the first time the police would get a look at the man they would soon come to know as the murderer of Peggy Logan, Stephanie Singleton and Mary Ann Voepel. Yolanda Neals was also assaulted and testified against her attacker. Murderer Status:

Frederick Pete Cox was arrested and charged with the first-degree murder. As the investigation progressed additional charges were made including two counts of attempted murder. He had to have separate trials. Ms. Voepel's blood and the gun used in the killings were found in Cox's car. The prosecution asked for the death penalty. The defense said Mr. Cox is mentally ill or did not plan the murders. The February 2001 trial involving the death of Stephanie Singleton and Mary Voepel ended in a mistrial. He was convicted April 17, 2001. Circuit Judge Frank Kaney on Friday sentenced Frederick Pete Cox to three life sentences. He was convicted for the Orange County murders of three women and the attempted murder of two others. Ms. Adams was left with a speech impediment. **Frederick Cox has at least 8,395 days to spend in prison before he reaches the age 70.**

**Louis Reed Jr., 40, (20) (31) Missouri 1969, 1980**

Oregon victim 2/07/1991 Life

Velma Snowden

Velma Snowden lived in St. Louis, Missouri. She was murdered in her home in 1969. She was stabbed then shot to death. Her murder went unsolved for quite some time in absence of a person with a motive. Her assailant used two weapons. Phyllis Seals, 42, lived in University City, Missouri. She was found strangled to death in 1980 in a vacant lot in St. Louis. The murder of Velma Snowden and Phyllis Seals was linked to one man, Louis Reed Jr. Missouri asked that Mr. Reed be extradited from Multnomah County Oregon to stand trial in Missouri. Mr. Reed was serving a prison sentence in Oregon for rape and murder. He was convicted January 04, 1982 and sentenced to life in prison without parole. Mr. Reed was tried for the capital murder of Phyllis Seals first. He was found guilty December 8, 1989. He was sentenced to life without parole for 50 years. Mr. Reed had pleaded not guilty by reason of mental disease or defect. Assistant Circuit Attorney Michael Quinley said Mr. Reed has an "anti-social" criminal personality and describes him as "a successful serial killer" who is mentally disturbed but responsible for his actions. The prosecutor said that the 15 seconds that it took for Ms. Seals to die was "That's a deliberate time," Quinley said, putting down the watch. "You can't call it anything else. That's first-degree murder - capital murder." What was Mr. Reed during between 1969 and 1980? Did he kill during this period? Please note he moved from Missouri to Oregon. He moved from Missouri to Oregon just like Coral Eugene Watts moved from Michigan to Texas seeking a new killing ground. **Louis Reed has at least 10,950 days to spend in prison before he reaches the age 70.**

**John Paul Phillips, 35 – Illinois 1981 – 1975 - 1976**

Joan Wetheral, 23

See Theresa Clark, 23 and Kathleen McSharry, 24

Joan Wetheral lived in Illinois. She worked as a cocktail waitress. She was a Southern Illinois University student. Her body was found in an abandoned strip-mine pit in Jackson County Illinois November 22, 1981. She was strangled and beaten in the head with a hammer. Her death remained unsolved for nearly five years. In 1986 an Illinois prison inmate notified authorities that his roommate, John Paul Phillips, 32, told him he had murdered three women one of those women was Joan Wetheral. Mr. Phillips was indicted for murder while in prison. He was in prison serving a 45 year sentence for the attempted kidnapping of a woman. Mr. Phillips was subsequently tried and convicted of first degree murder. He was sentenced to death. March 29, 1989 the Illinois Supreme Court upheld his conviction and death sentence. **He died in prison in 1993.** The murder investigation into the death of Joan Wetheral led investigators to the deaths of Theresa Clark in 1975 and Kathleen McSharry of Carbondale in July 12, 1976. Theresa Clark's body was found in her apartment she was raped then stabbed to death. Kathleen McSharry's body was found in her apartment. She was stabbed in the back, had her throat slit and was sexually assaulted. DNA evidence was taken from under the nails of Ms. McSharry was matched in 2008. Mr. Phillips' body was exhumed in 2001. Kathleen McSharry was a Southern Illinois University Carbondale student. A DNA match also was made with Theresa Clark who was also a student of Southern Illinois University.

## **Jose Elias Castillon Texas 2001**

Dana Feazell, 31 (LON)

Cammy Kalmen, 32 (LON)

In 2001 the bodies of two women were found in a marsh area outside of town in south east Texas. The women were Dana Feazell and Cammy Kalmen. The women were bound and murdered after drinking with a man they just met. Ms. Kalman was manic depressive used drugs to self-medicate. The murders tied to Jose Castillon a man who recently moved into the area from Colorado. He was arrested two days after the bodies were found by municipal workers. He was tied to the bodies through forensic evidence. He was charged with two counts of murder. He pleaded guilty to capital murder and kidnapping to avoid the death penalty. He was sentenced to life in prison without parole. **He has at least 7,300 days to spend in prison until his death at age 70.**

## **Douglas Thames Jr., 23 (16)**

Susan Marie Dolls, 39

It took investigators six years to solve the murder of Susan Dolls. Her assailant was a juvenile. From what is known his only victim was Susan Marie Dolls. Susan Dolls was murdered during a burglary. Ms. Dolls lived in Fort Collins, Colorado. She was a successful woman living in a very nice area of town. She was engaged to be married and had recently quit her bank job to work in the field of cosmetics. Ms. Dolls was happy with her life and was looking forward life with her fiancé. The police were called to her home 10 days prior to her death because someone had broken into her home. The person stole her underwear. Her home was one of several residential burglaries. August 29, 1989 a real estate agent discovered her body in her home. She was raped, beaten and strangled to death. She recently put her home up for sale. A tremendous amount of forensic evidence was collected. In 1995 a suspect was identified after a DNA comparison was made from the semen on 13 pairs of panties led to the arrest of Douglas Thames Jr. age 22. What made the furnace repairman to collect the panties and take them to the police is unknown. Mr. Thames was charged with rape and first-degree murder. Douglas Thames Jr. 23, (16) was convicted in 1996. **Douglas Thames has at least 16,790 days to spend in prison before he reaches the age of 70.**

## **Mr. Arthur Sanchez, 22, California**

He was ready to rape and kill at a moment's notice as soon as a victim presented herself to him.

Three rape victims

Mary Martha Odermatt, 65

"Her whole life was about serving the Lord, forgiving always. "She never carried any anger or harbored any animosity toward anyone." Agnes Green, daughter

Again California is alerted to the activity of a career rapist who was recently paroled from prison. Mr. Arthur Sanchez, 22, was a career rapist who was ready to rape and kill at a moment's notice. He was agile and adaptive. He succeeded in raping three women and raping and murdering two women. He raped one woman in 1982 and in 1986 he raped and murder two women and raped two women. A 29 year old woman was raped in Modesto, California. Her car was disabled and she was carrying her child in her arms. Her assailant went to prison on another charge. He was released in 1984. In 1986 he began his activity again. August 11, 1986 he raped and slashed the throat of Mary Martha Odermatt while on his way to work. Mrs. Odermatt was stabbed to death in the courtyard of Turlock's Sacred Heart Catholic Church. She worked as a cook at the church. She always arrived early in the morning to prepare the altar for Mass. August. 31, 1986 Mr. Sanchez stabbed Angela Turnbough, 16, to death in the bedroom of her home in Keyes. He left the knife in her throat. He was convicted of Ms. Turnbough's murder in 1988 and sentenced to life in prison without parole. In 2002 DNA test were made on the evidence collected of Ms. Odermatts. Mr. Arthur Sanchez was charged again with her murder and the rape of the other two women. In 2008

Arthur Sanchez, 44, in a plea of guilty to the murder of Mary Odermatt and was sentenced to life in prison without parole. Arthur Sanchez had a wife and two children when he committed these rapes and murders. Notice the impish behavior of these men, leaving the knife in the throat killing on the way to work. Do not tell me raping and murdering women is not an occupation.

### **Arthur Bomar, 38 Pennsylvania,**

Maria Cabuenos, 25      see Aimee Willard

Maria Cabuenos lived in Philadelphia, Pennsylvania. She worked in a laboratory in the area. Authorities believe she was carjacked and abducted March 15, 1997 while driving to work. It was her routine to leave home at 5 am. to get to work. She was reported missing March 15, 1997. She reportedly left home early that day to be on time for her job. Authorities believe she was carjacked after encountering Arthur Bomar on the road. Maria Cabuenos' remains were found New Year's Day 1998 in Tinicum Township Bucks County. When Arthur Bomar, 38, a parolee from Nevada, was apprehended he was driving her car and driving with a gun in the car. Mr. Bomar was using an alias to disguise himself. His girlfriend did not lie for him. She told authorities he began driving the car in March and she saw dried blood in the trunk. Ms. Cabuenos' watch was found in her assailant's home. Mr. Bomar had actively violated the Uniform Criminal Extradition act several times but he was still at large. He did not visit his parole officer a clear sign Mr. Bomar had no intentions of changing his behavior. Arthur Bomar was never tried for the murder of Maria Cabuenos. He was tried for the murder of Aimee Willard. Arthur Bomar was driving Maria Caubenos' car when he was apprehended for the June 1996 murder of Aimee Willard, a George Mason University star athlete. He got rid of his car because his car was used to murder Ms. Willard. His girlfriend said there was blood in the car when he first began to drive it. Arthur Bomar thought his girlfriend would give him an alibi. She refused to give him an alibi for the murder of Aimee Willard. Mr. Robert Knight's girlfriend also refused to give him an alibi for the murder of Dawn Bruce. A woman in Washington also refused to give an alibi for her boyfriend involving the murder of his neighbor. Mr. Bomar was paroled from Nevada in 1990 after committing murder in 1978. He served 11 years. Arthur Bomar committed several parole violations but he was not returned to Nevada. He was allowed to continue to live in Pennsylvania. Mr. Bomar was not charged with the murder of Maria Cabuenos although he could not account for being in possession of her car. What was Mr. Bomar doing between 1990 and the time he was apprehended for the murder of Aimee Willard?

### **Mr. James Jamal Williams    South Carolina    Parolee**

Meshia Samuel, 17

The man who stabbed Meshia Samuel to death in her aunt's apartment in South Carolina is not only a murderer and a rapist he is also a liar. He wrote his girlfriend and told her he did not mean to kill Meshia Samuel. Surely he is stupid how can you not mean to kill someone when you stab them 26 times? He sat like a vulture and watched the apartment and waited for his moment to strike. His behavior is the reason why people need to know when parolees move into their area. Another point Mr. James Jamal Williams was not rehabilitated in prison. He just became more determined to become effective in his criminal enterprises. You notice he used a girlfriend as a cover, a backdrop to his main goal. Girlfriends make men appear normal. There was nothing normal about Mr. Williams except he was just getting started. Meshia Samuel from Darlington was visiting her aunt in South Carolina. He was able to watch her because her aunt lived across the hall from Mr. Williams. Mr. Williams was supposed to be in prison for violating his parole but he was allowed to bond out of jail for \$15,000. The magistrate handling his bond hearing did not know Mr. Williams was supposed to be in prison and allowed the bond. This is why we need to upgrade all of our police computers where we can effectively communicate. One day after Meshia Samuel's body was found Mr. Williams was arrested. He was charged with murder, first-degree criminal sexual conduct and first-degree burglary. The jury failed to sentence him to death.

### **Mr. Robert Douglas Knight    Virginia**

Dawn Rachelle Bruce, 22

The man who raped and murdered Dawn Bruce March 1990 in her bed was a stupid person. The way he was caught proved he was stupid twice over; the murder weapon was found in his apartment and he asked his girlfriend to give him an alibi for the time of the murder. What decent woman would give a man an alibi knowing he could possibly be the man who attacked and raped a woman while she was sleeping? Mr. Knight was angry because Ms. Bruce rebuffed him. He was a common man without aspirations with nothing to offer a woman except babies that he would not support. Instead of flirting outside of her apartment he should have been working. To avoid the death penalty he pleaded guilty to all charges. He was not tough enough to walk into court protesting his innocence with the death penalty hanging over his head. He has a chance at parole. Let us hope that the women of Virginia send in a petition at the time of his parole hearing. Many apartment murders happen just this way. The murders happened in Washington, Florida and California. The man sits and watches and waits for the opportune time. This is how Meshia Samuel was targeted for murder. If you read a rape victim's name it is because she released her name to the local media. We would not knowingly violate a woman's privacy.

### **Eugene McWatters, Florida**

Jackie Bradley, 29  
Carrie Ann Caughey, 18

Christal Wiggins

Three women went missing in Florida in 2004 after being seen with Mr. Eugene McWatters. Mr. McWatters was a man who wandered the neighborhood. People drank a beer with him or smoked a joint whatever. He was seen to be one of the crowd, a harmless individual. He was not attached to any one person or any one thing. He was a smiling face that floated with the mood of the neighborhood. Some of the people in the area were seen drinking and talking at a camp site in Stuart Florida. By the end of the summer of 2004 people in Florida learned Mr. McWatters was not harmless. He was a very dangerous man. The first woman to die was Jackie Bradley, a homeless woman. She was seen with Mr. Mc Watters March 28, 2004. Her body was found on the morning of March 31, 2004. The injuries to her neck were consistent with manual strangulation. Eugene McWatter had separated Mrs. Bradley from the group during the evening by offering to allow her to bathe at his cousin's home. Carrie Ann Caughey was seen with Mr. McWatters during the early morning hours of May 31, 2004. Her body was found in a secluded wooded area near a lake on June 3, 2004. Eight days later on June 7, 2004 the body of Christal Wiggins was found near a lake, the same area where Ms. Caughey was discovered. Wiggins' body was partly skeletonized due to decomposition. Ms. Wiggins was last seen with McWatters in Port Salerno, Florida at a party. He offered to provide her with crack cocaine if she had sex with him. What you bet he had no money and no cocaine so she refused and he killed her. Another killer used this technique; separate the woman from the group then kill her. You will read about these men. After the police realized the murders of Jackie Bradley, Christal Wiggins and Carrie Ann Caughey were related Mr. McWatters was questioned then charged with three counts of first degree murder. The prosecutor did not hesitate he notified the court he would seek the death penalty if Mr. McWatters was convicted. December 4, 2008 Martin Circuit Judge Larry Schack sentenced Mr. McWatters to death based on a jury's recommendation. In addition to the three death sentences, Schack ordered three consecutive life prison terms for the rapes of the three victims. He raped and strangled to death three women in 10 weeks.

### **James Brown, 24 Michigan**

Demesha Hunt, 25 mother  
Natasha Curtis, 29

Renisha Landers, 24  
Vernithea McCrary, 28 (mother of 3)

James Brown of Sterling Hgts, Michigan is another man who rapes and murders. He is accused of killing two women at a time in his home. December 2011 four women, Demesha Hunt, Renisha Landers, Natasha Curtis, and Vernithea McCrary, were all murdered in a short length of time. Mr. Brown killed four women during the month of December 2011. He was arrested May 1, 2012. He was charged with moving their bodies and with arson. He was later charged with four counts of murder. The problem the Detroit investigators believe the women were murdered elsewhere and their bodies were placed in cars in Detroit

for discovery. A number of police agencies worked on this case. December 24, 2011 the bodies of Demesha Hunt, 24, and her cousin, Ranisha Landers, 23, were found in the trunk of her car. Miss Landers a Sterling Hgts Chrysler employee had recently purchased her Chrysler 300. Family members reported them missing after the women failed to return from visiting an area night club. Family and friends said the cousins were inseparable. The bodies of Natasha Curtis and Vernithea McCrary were found on Christmas day inside a burned car. James Brown was charged with dead bodies-disinterment of cousins Demesha Hunt, 25, and Renisha Landers, 24, and with arson and disinterment of Natasha Curtis, 29, and Vernithia McCrary, 28. The problem with these cases is there is no one to testify except the accused. Why should he tell the truth? What purpose would the truth serve him? Macomb County is where police believe the murders occurred. It is a common occurrence for some murderers to use Detroit as a dumping ground. Supposedly all of the murders in Michigan take place in Detroit. Please note you will read about men killing two women during a single occasion. Mr. Brown stands 6'6 and weighs 300 pounds. February 2014 James Brown of Michigan was convicted of four counts of first-degree murder. April 15, 2014 he learned that he would not leave prison alive. He was sentenced to life in prison without parole. Michigan is not a death penalty state.

### **Michael M. Braae, 48 Idaho Oregon Washington**

Lori Jones, 44 (mother) Susan Ault, 39 - Wahkiakum County 2001  
Valina Marie Larson - Clackamas County, Oregon Marchelle Morgan, 50 left brain dead  
Debra Van Luven, missing from Lacey

By 2009 people in Washington and Oregon came to the conclusion that the women in Mr. Braae's life were ill fated. They did not meet with a good end. Two women were missing and two women were murdered. The families of these women were now holding the Department of Correction to blame for failing to monitor a man who the courts said was dangers and violent. It was not like no one knew Michael Braae's history. Mr. Braae was non complaint with his conditional release from prison. In 1998, Clackamas County Sheriff's Lt. Wendi Babst notified the Washington DOC of her investigation of a suspicious death of one of Braae's girlfriends, Velina Larson, in Oregon. She asked to be notified about Braae's release from DOC custody. Lt. Wendi Babst was not notified of his release. The families say Mr. Braae was able to wander freely and continue his pattern of abusing women. There were numerous probation violations. Court documents say Lori Jones' body was found in her Lacey, Washington apartment July 8, 2001 by a friend and her apartment manager. She was killed by manual strangulating but not before she was raped vaginally, orally and anally and beaten in the head. A bartender said he last saw her in the company of Mr. Braae around 2 am July 7, 2001. Mr. Braae was not immediately tried for Lori Jones' murder. It took seven year. First he went on the run. When he was apprehended July 20, 2001 in Moscow, Idaho he had to be tried in Washington (ended in mistrial - a judge ruled victim was unfit to testify as a witness because of brain injuries) and Idaho (convicted of assault). Michael Braee was on parole when he murdered Lori Jones. He was placed on the lowest level of supervision. Michael John Braae, 48, was convicted of first-degree murder and first degree rape May 22, 2008. Mr. Brae was a felon under the supervision of the DOC but he was classified as a low risk offender when he was released in 2000. Mr. Braae's hunting ground was Washington and Oregon. The records say a judge parole Mr. Brasses but Michael Braae was to be monitored closely but the judge's orders were not followed. Between May 2001 and July 2001 four women were murdered or brutalized. Susan Auld was reported missing. She disappeared May 21, 2001 after arguing with Mr. Braae near a friends trailer purse, with identification, later was found at a rest stop. Her body has never been found. In July 2008, the Wahkiakum County coroner issued a death certificate for her father, stating that Susan Ault was a victim of "homicidal violence of unknown type. Michael Braae is a person of interest in her case. Marchelle Morgan, 50, was shot in the July 14, 2001 head and left on a road to die. She survived. Ms. Morgan survived the shooting but she was left with severe brain damage that forced her to live in a nursing home after partially recovering from the shooting. In 2006 Ms. Morgan's condition had deteriorated to the point that she was unable to testify against Michael Braae. A mistrial was declared. Karen Peterson was assaulted July 2001 by Mr. Braae. He followed her home from a bar. He strangled her until she lost consciousness. She survived. Mr. Braae was called a womanizer and was suspected in the disappearance of two women, Susan Ault the murder of two women, Valina Marie Larson and Lori Jones and the rape of a fifth woman. He was suspected in murdering Valina Marie Larson, who

was last seen with him on September 30, 1997 in Clackamas County, Oregon. Her remains were found January 1998. Susan Ault was last seen in Cathlamet, Washington June 25, arguing with Mr. Braae. No body has been found. She was his girlfriend. He was also accused of raping a woman July 13 in Yakima, Washington. Lives may have been saved if authorities had learned what happened to Debra Vanluven when her mother reported her missing in 1997. Ms. Vanluven was Michael Braae's girlfriend. They had a history of violence throughout their relationship. Mr. Braas was using her deceased brother's identification.

**Mr. Guy Shannon Jr., 45 Kansas City, Missouri.**

Marcia Lynn Davis, 20.

Marcia Davis was rape and strangled March 1989 in Kansas City, Missouri. Her murder was not solved for approximately 20 years. Mr. Guy Shannon was arrested on a driving incident. He was required to give DNA. His sample was put in CODIS. A match was made with the forensic evidence taken from the crime scene of Marcia Davis.

**Mark Daniel Beebout Sex offender (California – Oregon)**

Mark Beebout was a registered sex offender who lived in Portland, Oregon. He is now charged with murdering two women.

Nikayla Jaedon Powell, 32  
Unidentified woman, teen to early 20's

A body of a woman was found June 26, 2012 in Washington Park in Multnomah County Oregon. Her body was found just west of the Vista Bridge off Southwest Jefferson Street. The coroner said the cause of her death was a homicide. Authorities believe she was homeless and a transient. She is described as 5-foot tall, 100 pounds with long, and straight black hair of mixed race. Her death remained unsolved until August 21, 2012 when Mark D. Beebout, a homeless man, was charged with her murder. Mr. Beebout was linked to her death through DNA August 20, 2012. Nikayla Powell lived in Portland, Oregon. She worked as a volunteer three nights a week for the nonprofit agency of St. Stephens Episcopal Parish. During her volunteering (Operation Night watch) she came in contact with Mark Daniel Beebout who was a homeless sex offender from California. This relationship led to her being murdered in her apartment July 4, 2012. Mr. Daniel Beebout was apprehended after charging a \$1,000 on her credit cards. He also stole her car and dog. Her body was found July 10, 2012. He was arrested July 19, 2012 in Seattle, Washington and arraigned July 31, 2012 on of murder, first-degree theft, tampering with physical evidence, fraudulent use of a credit card, and unauthorized use of a motor vehicle. A grand jury indicted Mr. Beebout on six counts of aggravated murder, and one count each of first-degree sodomy, first-degree sexual abuse and unauthorized use of a vehicle and two counts of fourth-degree assault for a January 1, 2011 assault on another victim. Miss Powell was strangled to death. No one at the organization knew he was sex offender.

**Officer Josh Griffin, 24, North Carolina**

Kim Medlin, 26



Kim Medlin worked as a waitress in Charlotte, North Carolina. March 29, 1997 she was accosted by a police officer while on her way home. Her body was found several days later. Murderer Status: Officer Josh Griffin, 24, was arrested and charged with murder. He was convicted and sentenced to life in prison. Ms. Medlin was strangled to death. We do not know if she had children. She was working late for a reason. Again we have a man who gave way to his fantasies. Officer Griffin later admitted he murdered Kim Medlin. His deed left his family destroyed. His mother and father supported him in the courtroom. How do you live knowing your parented a murderer. Officer Griffin would definitely kill again it would only be a matter of time. Power and success is a combination that fosters confidence.

### **Police Officer Gilberto Chavero Jr. Texas**

Iris Yvette Hidalgo, 18

Iris Yvette Hidalgo was a high school student living with her parents in Texas. March 23, 1996 Iris Hidalgo was placed in a squad car. She was raped and stabbed. Murderer Status: Police Officer Gilberto Chavero Jr. was arrested and charged with her rape and murder. Forensic evidence tied him to the scene. He was later convicted in 1997. Yvette Hidalgo was stabbed to death. Officer Gilberto Chavero was a sex predator in the making. He was waiting for a victim. Yvette Hidalgo would not have been his last victim. There would be more to come. He thought under the cover of the uniform he would be successful in fulfilling his heart's desire, the murder of a female. He was given a life sentence.

### **Harris County Sheriff deputy Joseph Kent McGowan Texas**

Mrs. Susan Diane Harrison White (mother)

"The only people who know exactly what happened in that room are McGowen and Ms. White, and one of them is dead." Prosecutor Don Smyth

Susan White was shot to death in her home in Texas August 25, 1992 after a long running dispute with a Harris County Sheriff deputy Joseph Kent McGowan. The deputy said he shot Mrs. White to death in her home in self-defense. He was not believed. Murderer Status: Officer Joseph Kent McGowan was tried twice, in 1994 and 2002. He was convicted twice. His story did not make any sense. Officer McGowan was to be obeyed. He was not going to allow Mrs. White to forget who had the power. June 5, 2003 the First Court of Appeals upheld his conviction.

### **Highway Patrol Trooper Timothy Scott Harris, 31 Florida**

Lorraine Hendricks, (Mother)

Lorraine Hendricks lived in Jacksonville, Florida. She was just recovering from a divorce and was trying to raise her daughter and develop her career. She was accosted on the highway March 4, 1990 while on the way to a busy meeting. Her assailant was a Florida Highway Patrolman. Murderer Status: Florida Highway Patrol Trooper Timothy Scott Harris, 31 was arrested and tried for murder. He was convicted of first-degree murder She was strangled her to death. Ms. Hendricks was choked to death. She was forced to strip to the amusement of her assailant. Imagine the chagrin of the police officers that investigated this case. If Officer Harris had been successful with this crime there would have been more victims sooner or later. Success breeds confidence.

### **Rookie Police Officer James Paul Vanderbilt Jr. Texas**

Katina Moyer, 16

Katina Moyer was a high school student living with her parents in Amarillo, Texas. She was kidnapped in 1975 while on the way to pick up her mother. A man forced his way into her car. After the murder

investigation was over a police officer was arrested. Murderer Status: Rookie Police Officer James Paul Vanderbilt Jr. was convicted of kidnapping and murder. Katina Moyer was handcuffed when she was shot in the head. Officer Vanderbilt was tried twice for the murder of Katina Moyer and he was twice convicted and sentenced to death. The death of Katina Moyer was an example of a man seeking and trying out power. Ex officer James Paul Vanderbilt died of pneumonia on death row October 19, 2002 at the age of 49. He entered prison at the age of 24.

**Officer Len Davis, 31, Louisiana**

Kim Groves (Mother of 4)

Kim Groves lived in Louisiana. She was a mother of four working to support her family. One day she witnessed a police officer beating a suspect. Believing this activity was wrong she agreed to testify against the police officer. The police officer believed he could beat the charges if he eliminated Ms. Groves. He contracted with Mr. Paul Cool Hardy, 28, to have Mrs. Groves murdered. Kim Groves was shot to death October 13, 1994 leaving her four children motherless. Murderer Status: Officer Len Davis, 31, was charged under a federal statute allowing for the death penalty. Officer Len Davis was twice tried and twice convicted and twice sentenced to death. The jury did not like him. A Black police officer violating a person's civil rights and ordering the murder of a mother does not go over too well with a jury. He really did not have a chance since he could not shake his association with the shooter, Paul Hardy. Mr. Hardy was sentenced to life in prison the second time he was tried. Ms. Groves would not have been shot if it were not for the instigation of Officer Len Davis so the death penalty was appropriate for Officer Davis. Do not think if Officer Davis had gotten away with this murder he would have stopped bullying and beating people. The concept of his power would have grown.

**Carl Mosley, 26 North Carolina**

Dorothy Louise Woods Johnson, 35  
Deborah Jane Henley, 38

Dorothy Johnson lived in North Carolina. April 12, 1991 she went to a local dance at the SRO Club, a Country and Western dance club, in Winston-Salem. There she met Carl Moseley. Throughout the evening she danced and chatted with Mr. Moseley. The last time she was seen alive was at the club. April 13, 1991 her parents notified the sheriff that Miss Johnson had not returned home. Soon her body was found in a field. She had been beaten with a blunt force object, cut with a sharp object, sexually assaulted with a blunt instrument, raped, and was strangled manually and with a ligature. Authorities believed she left the club with her killer. Her assailant was not immediately apprehended. Once Carl Moseley thought he was successful in killing Dorothy Johnson he struck again. He killed another woman in July 1991. He believed the SRO Club was a good hunting ground presenting him with a fresh batch of victims every weekend.

Deborah Henley lived in North Carolina. She was murdered July 25, 1991. After the murder of Miss Henley Carl Moseley was arrested and charged with the murder of Dorothy Johnson and Deborah Henley. He was tried separately for each rape and murder in January 1993. He was convicted of first-degree murder and sentenced to death and consecutive sentences of life imprisonment for first-degree sexual assault and first-degree rape. A September 1994 appeal confirmed the verdict and sentence. Carl Moseley committed his first murder at age 26. We do not know how long he had been planning the events in his mind. Murderer Status: Carl Moseley was tried for murder and convicted January 1991. He was sentenced to death. The U.S. Supreme Court was mute in hearing his appeal. He is now on death row awaiting execution. Ms. Deborah Henley was abducted, tortured and sexually assaulted before she was murdered. Deborah Henley's sister drove her to a local dance in the area. She socialized until around 2 o'clock when Mr. Moseley offered to take her home. The next time Deborah Henley was heard of was when her body was found in a field. Deborah Henley was a low risk victim. She was compliant self-conscious and wanted to make new friends. Carl Moseley used these characteristics against her. It is

oblivious when a woman goes to a dance unaccompanied she is looking to make friends. Miss Johnson had a speech impediment consequently she would be more receptive to people who act as if they accepted her inabilities. This is what predators do they look for weaknesses in their victims that they can exploit. Ask yourself what are your weaknesses. How can a perfect stranger exploit these weaknesses? If you begin looking at yourself through the eyes of a predator, it will help you develop your defenses. Ask yourself how much do you want to be accepted? I realize this is very difficult and painful to do but it is necessary. You are a female therefore you are a target of a predator whether you like it or not so you should consider all the ways a means a man of this predilection could approach you. Maybe he is your savior when you have a flat tire. Maybe he is the man who helps you load the groceries into your car. Maybe he is the next door neighbor who offers to rake your leaves. Think then save your life. Think about it there were at least 10 to 20 single women at that dance what caused Mr. Moseley to home in on Deborah Henley. Mr. Moseley went to the club looking for a specific victim, a low risk victim.

### **Mr. Kenyon Battles Tolerton Colorado 1980, 1993**

Donna Waugh,

Cissy Pamela Foster, 14

Mr. Kenyon Battles Tolerton was considered a very smart man. He was a computer programmer yet during his lifetime authorities convicted him of two murders. The first known murder he committed was March 1980 when he murdered Donna Waugh in Englewood, Colorado. He had been in prison before but Ms. Waugh was his first known murder victim. Donna Waugh was a stranger to him. What is not clear is how he was out of prison by 1993 in order to murder his second victim when he was convicted of murdering Donna Waugh in 1981. Six years before he murdered Donna Waugh he abducted a woman from a parking lot in Chapel Hill Mall. We do not know on what grounds were he released in 1990. He was paroled in 1990. From the time of his release to September 1993 we do not know if there were other victims. What we do know is the second person he was accused of killing was Cissy Pamela Foster age 14. Cissy Foster lived in Denver, Colorado. Her body was found in a field September 1993. Cissy Foster was stabbed 13 times. Mr. Tolerton, 38, was not indicted for this murder until May 12, 1994. He was then three years out of prison for the murder of Ms. Waugh. He was charged with of first-degree murder, first-degree kidnapping and sexual assault on a child. It is apparent Mr. Tolerton had no desire to stop abusing women. What he was trying to do was to become proficient at murder so he could continue to kill well. In 1994 he was convicted of first-degree murder and sentenced to life in prison without parole. He pleaded guilty to avoid the death penalty. Did you notice men have to kill twice before they are no longer allowed in society. DNA linked him to the murder of Cissy Foster. This young lady lost her life because Colorado failed to convict and sentence Mr. Tolerton on a greater charge in the death of Donna Waugh. Before he was convicted of killing Donna Waugh he kidnapped a woman from a mall. Juries continue to view rape as associated with sex as if the offender can be rehabilitated. The death of Cissy Foster dispels this notion.

### **William Clyde Gibson – Convicted Sex Offender**

Karen Hodella, (mother of 2)  
Stephanie Kirk, 35

Christine Whitis, 75

William Clyde Gibson was a sex offender living in New Albany, Indiana. In 2012 his name became a headline because the police had associated him with the murder of three women. The police found the body of his family friend, Christine Whitis, age 75 in his home April 19, 2012. They found the body of Stephanie Kirk buried in his back yard April 27, 2012 after executing a search warrant and the police believed that they had enough evidence to charge him with the October 2002 murder of Karen Hodella. Ms. Stephanie Kirk of New Washington, Indiana had been missing since March 2012. May 23, 2012 Indiana prosecutors said they would seek the death penalty against Mr. Gibson if he was convicted of the murders. The women were sexually abused and two of them were mutilated. Mr. Gibson will probably not be tried until 2014 since this is a death penalty case. If the state is to take his life then there can be no errors in the proceedings. How can Mr. Gibson explain away the body of Christine Whitis and Stephanie Kirk being on his property?

## **Darren Dee O'Neall - Army veteran, married father**

Killing Time: 1987

Robin Pamela Smith, 22  
Lia Elizabeth Szubert, 22  
Salt Lake City, Utah 3 women names unknown

Wendy I. Aughe, 29 (mother of 2)  
Oregon Rape victim, 14

Darren Dee O'Neall worked as a truck driver. January 17, 1987 he raped a 14 year old girl he found walking along a highway in Portland, Oregon. She was going to a convenience store. He forced the 14 year old in his truck and raped her using his gun to frighten her. She was later released. Darren O'Neall would be tried for this rape a year later.

Darren Dee O'Neall was in Nampa, Idaho. He hitched a ride with a trucker. There he stole the man's truck and he stole a .357 magnum revolver off of a trucker. He drove from Idaho to Colorado then to Washington.

Mr. O'Neall drove to Marysville, Washington where he met up with Robin Smith. After their initial meeting he made a date with her. He used the name Herb Johnson.

March 28, 1987 Robins Smith saw Herb Johnson at a party. She was seen leaving with him. She was never seen alive again. Robin Pamela Smith, 22, was murdered March 28, 1987 after leaving the party. Her remains were found a year later. She died of blunt force trauma to the head. Robin Smith's fiancé died unexpectedly after ingesting an overdose of prescription drugs and alcohol. His death was officially ruled an accident. Family members said he never got over Robin's death and "died of a broken heart," after more than a year of being depressed and despondent. A woman in Colorado Springs identified Darren O'Neal as the man who raped her.

April 29, 1987 Wendy Aughe, 29, and her car disappeared after leaving to go on a date with a bartender she met at the La Paloma Restaurant in Bellingham, Washington. Fingerprints on the bartender's application were those of Mr. O'Neal although he used an alias of Mike James Johnson. He changed his hairstyle and appearance frequently. Saturday, May 2, 1987, Ms. Aughe's 1972 Ford Torino was found abandoned in Eugene, Oregon. Mr. Darren O'Neall would later be charged with stealing her 1972 Ford Torino. She lived in Washington. She was a mother of two children and worked and was attending college. The murder of Robin Smith and Wendy Aughe was four weeks apart. The whereabouts of Wendy Aughe remains unknown

May 31, 1987 the trucker's car was found. It was blood stained and police found several teeth inside the car.

May 1987 Darren O'Neall raped a woman in Colorado Springs, Colorado.

June 9, 1987 Lisa Szubert worked as a waitress. She disappeared from a truck stop in Mountain Home, Idaho. She was last seen with Mr. O'Neall. She was going to pick up her boyfriend up from the airport and developed car trouble. On Saturday, June 13, 1987 the nude body of Lia Elizabeth Szubert, 22, was discovered by a passing motorist along Interstate 84 in eastern Oregon, about 12 miles east of the town of La Grande.

June 1987 he abducted a woman in Idaho. He killed three women in Salt Lake City, Utah. All the women were last seen with Mr. O'Neall and all were shot to death.

February 3, 1988 Darren O'Neall was apprehended in Florida. January 4, 1989 during jury selection Darren O'Neall said he wanted to plead guilty to Robin Smith's murder. He received a life sentence which amounts to a maximum of 27 years and 9 months. He refused to make any statement regarding Liz Szubert or Wendy Aughe. At his age he probably thought he could be paroled from a Washington prison if

he could avoid being tried for the other two murders. May 1990 he was tried for the kidnapping and rape of the 14-year-old girl. Once convicted the judge gave him a sentence to make certain he would never be paroled. He was charged with two counts of first-degree kidnapping, three counts of first-degree rape, sexual penetration with a foreign object, three counts of third-degree rape, and single counts of first-degree sodomy, third-degree sodomy, and sexual abuse. He was convicted. August 1990 Darren O'Neill was sentenced to 135 years in prison on a variety of charges stemming from the rape and abduction of the teenager. Judge Kimberly Frankel ordered that the sentence run consecutively to the life sentence he had received for the murder of Robin Smith in Washington. No charges were brought against him in the death of Liz Szubert for lack of evidence. He supported himself by stealing from his victims and others. He stole cars allowing him to drive from state to state. Louisiana fought to keep Darren O'Neal because they wanted him to answer for stealing a car in his state. Washington won the extradition fight.

**Gary Schaeffer      Veteran    Vermont**

Sherry Nastasia, 13  
 Theresa Fenton, 12  
 Catherine Richards, 11

Three beautifully young women, Sherry Nastasia, Theresa Fenton, and Catherine Richards, were beaten to death with a rock in 1979, 1981 and 1983 in Springfield, Vermont. Their deaths had nothing to do with an argument or a misunderstanding. Their deaths were the result of a man's obsession for killing. The murders were planned and executed so the assailant could continue to remain cloaked in amenity. Gary Schaefer targeted safe victims, victims that could afford the least physical resistance and who he knew from a far. Look at the ages of his victims. His first known victim was Sherry Nastasia. She lived in an apartment complex managed by Gary Schaefer's brother. He raped and beat her to death in 1979. He targeted Theresa Fenton in 1981 and successfully killed her. He failed to kill his third victim in 1982, who he attacked in Brattleboro, Vermont. His fourth victim, Catherine Richards was abducted April 9, 1983. He crushed her head with a stone. Gary Schaefer was arrested September 1983. He admitted to the murders of Theresa Fenton and Catherine Richards. The plea bargain that resulted allows Mr. Schaeffer to be paroled. He admitted to kidnapping, sexual assault and second-degree murder of Catherine Richards. The prosecution agreed to drop the murder charge for the death of Theresa Fenton. Theresa Fenton's murder and the third victim's rape became bargaining chips for the defense. Gary Schaefer, 33, was sentenced to 30 years to life. If he is still alive, he will be eligible for parole in 2013 as will a lot of other men we discussed in this book that was sentenced to x number of years to life. As soon as the state needs some extra money you will see these men being paroled. Virginia Morrell, 21

"We can only hope, this man, not man – animal gets the maximum sentence you can give him. Robert White should rot in hell." Marilyn Belmonte, sister

Virginia Morrell lived in Pennsylvania. She was raped and suffocated to death in her apartment November 1, 1978. Her hands were bound behind her back. Her family had to wait 30 years before learning the name of her murderer. Robert W. White Jr., 50, was arrested in Virginia in 2008 for the murder of Virginia Morrell. He committed the murder in his youth. He will spend old age in prison. Virginia Morrell case was reopened and detectives had the forensic evidence tested at the stated lab. A DNA match was made to Mr. White. He thought he had escaped justice. Robert W. White Jr. pleaded guilty to first-degree murder to avoid the death penalty. He knew he could not win after three women testified he attacked them

between 1978 and 1982. His ex-wife also testified. The women described the assaults in great detail. He was sentenced to life in prison on March 18, 2009

Tammie Turner

Tammie Turner lived in Miami, Florida. Her body was found September 1986. Her death was declared a homicide but the cause of death was undetermined.
